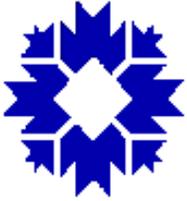

Proposed Amendment: To remove parcels amended out of Area 2 and to update total acreage

1. Exhibits A and B shall be deleted in their entirety and shall be replaced by the updated Exhibits A and B, which are attached hereto.
2. Ordinance 17-12 shall be amended by replacing the acreage total in the fifth whereas clause, which presently reads 2,887.71 acres, with a corrected total of 2,755.15 acres.

Synopsis

This amendment updates Ordinance 17-12 to remove parcels from the map and legal description that were previously amended out of Ordinance 17-12 via Amendments 02 and 03. It also updates the acreage total contained in the fifth whereas clause of the preamble to Ordinance 17-12.

Note: This amendment was revised after release in the September 15, 2021 Legislative Packet but before introduction by the Council to revise the corrected acreage total from 2,758 acres to 2,755.15 acres.

Map of South-East Bloomington Annexation Territory





Legal Description of South-East Bloomington Annexation Territory

City of Bloomington Indiana Annexation Study Area Number 2 Legal Description:

The intent of the following description is to describe the City of Bloomington Annexation Study Area Number 2 as provided by the City of Bloomington Indiana Geographic Information System Department in January, 2017 with a revision in September, 2021. The following described lines are intended to be coincident with existing annexation ordinance and parcel boundary lines. No field work was performed in preparing this description. Bearings and distances shown were taken from the Monroe County Geographic Information System files.




