Breanca Merritt is Chief Health Equity and ADA Officer for Indiana's Family and Social Services Administration. She oversees FSSA's Office of Healthy Opportunities by addressing social determinants of health for low-income and vulnerable Hoosiers and designing and implementing antiracist and socially equitable policy. Prior to joining FSSA, she was the Founding Director of the Center for Research on Inclusion and Social Policy (CRISP) and Clinical Assistant Professor at the O'Neill School of Public and Environmental Affairs at IUPUI. She currently serves as an adjunct professor and community scholar in IUPUI's Africana Studies program. Dr. Merritt has a Ph.D. in Health Promotion Sciences from the Hudson College of Public Health at the University of Oklahoma Health Sciences Center, her M.A. in political science from Texas A&M University, and a B.A. in journalism from the University of Oklahoma.
