- I. Call to Order: (~5:31 PM)
- II. Approval of Minutes 9/22/2021 Ms. Wahl has a correction to the minutes: no TRANSIENT garage revenue from March to August (word was omitted in III, A, ii). Mr. Dalton motioned to approve the minutes and Mr. Emge seconded. The motion received a roll call vote of Ayes: 7, Nays: 0, Abstain: 0; the motion passed.
- III. Reports from Commissioners & City Offices
 - **A.** City Offices: Ms. Wahl reports that sales of neighborhood permits are up, mostly in zones 1 and 4. Garage permit sales (monthly) also up. 100 new parkers coming to the 4th street garage starting Nov 1. Some number of cancellations due to IU students graduating and moving on. Morton street garage is largely full of monthly parkers.
 - **B.** Commissioners:
 - Mr. Volan has been approached by the owner of two homes in the Garden Hill neighborhood zone 6 and would like to purchase neighborhood permits. We need to determine if the omission is an issue of address.

- A. Terra Trace Apartments On-Street Parking (Binder): Commission received several letters from residents of Terra Trace Apartments. Discussion of the effect of allowing apartment building dwellers to purchase neighborhood parking permits, differential pricing of neighborhood zones, etc.
- **B.** Parking Commission Annual Report (Cm. Volan, Binder): There is a draft of the 2017 Parking Report. For next time: commissioners should read and provide feedback, look for errors, etc. Highlights:

- **C.** Parking App Discussion: Tabled.
- **D.** Shared-use Scooter Parking (Cm. Flaherty): Scooter parking is on the books as within Commission's scope. Recommendations from Cm. Flaherty:
 - Illegally parked scooters (blocking sidewalks, etc.) \$30 ticket, \$100 impoundment fee, additional storage fees, etc. Guidelines are in 15.58.060.
 - ii. Question: how do we address the issues with scooters and safety? more aggressive enforcement? Banning scooters?

VI. Resolutions

A. Parking Resolution 21-08--Loading Zone on E. 7th Street (Beth Rosenbarger): Most of on-street parking on 7th street was removed because of the 7 Line high-protection bike lanes. Correction needed for a business (Butch's) in the block between Walnut and Washington, needs a loading space because frontage is ONLY on 7th street. Bike lane is still protected by a curb.

Motion to approve made by Mr. Emge, Seconded by Mr. Volan. The motion received a roll call vote of Ayes: 7, Nays: 0, Abstain: 0; the motion passed.
