# **CONSENT AGENDA**

The minutes of the September meeting were approved. The next meeting of the Tree Commission will be 9:30 a.m. Wednesday, 17 November, online or in person, to be determined.

# South Walnut Street sidewalk improvements (Neil Kopper, City Engineering)

Kopper described the plan to construct new sidewalks on the east side of Walnut between Winslow and Ridgeview. The city decided that the best approach would be to remove the volunteer trees that occupy that space and start from scratch (plan attached). George commented that sweetgum is very slow-growing; Mia added that dogwoods generally don't like being in full sun. The committee suggested a hornbeam as a good small-stature tree as a substitute. They agreed that the hackberry is a great choice. Jeff remarked that the redbud variety in the plan might be too large (and perhaps too bright?) for the space. He also suggested that the tree varieties be selected with the uncertainty of climate change in mind. The group also suggested that the city not plant single species all in a row.

# **URBAN FORESTER REPORT**

Erin has received several tree removal appeals, including one included in a sidewalk repair project and the removal of some Bradford pears from Bryan Park. The appeals will go to the Park Board.

The Bradford pear has been designated as the "invasive plant of the year." Erin noted that if people want to remove trees from their tree lawns, they need to get permission from the city, as the tree lawns and trees thereon are actually city property.

# IU (Mia)

IU is anticipating more tree planting this fall; these activities are going to be staff-only. Normally, they recruit students to help, but because of Covid concerns, IU will hold off engaging students until the spring of 2022. They continue to manage removals of ashes lost to the ash borer. She said there are some obvious dead ash that need to be removed on the golf course.

### **Environmental Commission (Dave Parkhurst)**

The BEC will meet on Thursday, so there is no report other than the agenda. The Biodiversity working group is going to reconvene to work on native species planting; George asked if there was a map available to show what areas of the city are involved. David said he would try to send maps to the TC.
