REQUEST: Speed Limit Updates on Indiana, Henderson, Rogers, and Madison Streets

<u>Location</u>: Indiana Avenue (Atwater to 17th), Henderson Street (1st to Atwater), Rogers Street (Patterson to 11th), and Madison Street (11th to 17th).

<u>Description and purpose:</u> A Traffic Commission member previously requested a review of the existing posted speed limits on both Indiana Avenue and Rogers Street. Currently, both of these streets are posted and codified at 30mph. Staff included Henderson Street (1st to Atwater) in the evaluation of Indiana Avenue and included Madison Street (11th to 17th) in the evaluation of Rogers Street because they are continuous corridors.

The Transportation Plan lists target speeds (the operating speed for which a street is designed to achieve) for all streets to inform the design of new projects. The Plan does not provide specific guidance regarding speed limit changes to existing streets.

Historic speed limit setting practices primarily consider the existing operating speeds (typically the 85th percentile speed) on a corridor. However, there is growing awareness that this method does not consistently produce desirable outcomes in an urban context. In 2020 The National Association of City Transportation Officials (NACTO) produced a guide title "City Limits: Setting Safe Speed Limits on Urban Streets" which recommends that decisions regarding individual speed limits primarily consider conflict density (e.g. a street without sidewalks should generally have a low speed limit because pedestrians share space with moving motor vehicles) and activity level (e.g. a retail area with high pedestrian traffic should generally have a low speed limit).

The information below provides brief notes and documentation of staff's evaluation of these streets based on their existing characteristics, context, and adjacent land use.

Indiana Avenue/Henderson Street:

- Indiana Avenue is the border between IU campus and mixed-use downtown Bloomington, both of which generate heavy pedestrian activity.
- Retail and housing along the corridor is relatively dense with gridded streets.
- Density reduces north of 13th Street. However, this segment is relatively short before the street terminates at 17th Street.
- The majority of the corridor has existing sidewalks. Indiana Avenue between approximately 15th Street and 17th Street has no sidewalk on either side of the street.
- The corridor has no dedicated bicycle facilities.

- Henderson Street north of 1st Street and all of Indiana Avenue have a posted speed limit of 30mph.
- Henderson Street south of 1st Street has a posted speed limit of 25mph.
- All of the nearby north/south corridors in this area are 25mph (including Dunn Street, the other part of the one-way couplet).

Rogers Street / Madison Street:

- Rogers Street is located at the western edge of mixed-use downtown Bloomington and is within or bordered by mixed use downtown zoning (3rd Street to 13th Street).
- Rogers Street borders an elementary school which has a 20mph school zone (approximately 7th Street to 9th Street).
- Rogers Street and Madison Street have relatively dense retail, housing, and gridded streets between Patterson Drive and 17th Street. South of Patterson Drive the density reduces and the Transportation Street typology switches from General Urban to Neighborhood Connector. North of 17th Street the density also reduces, and the street name changes to Kinser Pike.
- The majority of the corridor has existing sidewalk.
- There is a multiuse path along the west side of Rogers Street south of Patterson Drive.
 North of Patterson Drive has a few short segments of striped bicycle lanes, but generally does not have dedicated bicycle facilities.
- The corridor has a posted speed limit of 30mph.

Title 15 Changes: •


Title 15 would need to be amended to update the Speed Limit in these areas.

Recommendation:

TC-22-06: Staff recommends amending Title 15 to change the speed limit on Indiana Avenue/Henderson Street between 1st Street and 17th Street from 30mph to 25mph.

TC-22-07: Staff recommends amending Title 15 to change the speed limit on Rogers Street /Madison Street between Patterson Drive and 17th Street from 30mph to 25mph.

Staff recommends that the Commission forward a Title 15 amendment for both of these changes to Council with a positive recommendation.
