## New Business

> April Farmers' Market Review (April 2 ${ }^{\text {nd }}, 9^{\text {th }}$, and $16^{\text {th }}$ ) - For the first three Saturday's we had 64 vendors. Our attendance for the first three Saturdays in April were 2559 customer. Regarding seasonal staff, we recently hired Sarah Jan Murray. So far in April, we had 6 entertainers w/ 3 more scheduled. Our first Information Alley was held on April 7. We also hosted 30 IU off-campus students at this year's "A Day @ the FM" on 4/16
> Looking forward to May - May marks the start of the Peak-Season. We are expecting 32 more vendors to start arriving. We have scheduled recurring visitations by our Natural Resources "Roving Naturalist" beginning on May 7. Also, May marks the return of the "A Fair of the Arts" monthly crafts fair. Finally, we will be favored by performances from the Brass Quintet of the Bloomington Symphony Orchestra and performances by the IU Ballet Department on May 28.
> A discussion continued on 1) ordering t-shirts and tote bags. These swag items have provided good revenue for the Market. 2) 2024 marks the $50^{\text {th }}$ Anniversary of the Market. Comments from the council included creating a committee to recognize this milestone on a selected Saturday or possible a theme could be embraced for the entire year. A special T-shirt was proposed along with retaining some select entertainment. 3) The feasibility of produce tastings was discussed and tabled for further discussion. With September being National Honey Month,
an effort should be made to recognize our honey vendors. With the addition of Emily Carrico, we plan to explore health and wellness events and related partnerships.

This would become official after Park Board Approval).
