## AGENDA

- I. <u>Approval of Minutes:</u> Motion from Bunger for approval of the minutes from March 15, 2022. Seconded by Washel. Motion passed unanimously.
- II. <u>Personnel Update:</u> (Hensley) Dispatch currently has 13 vacant spots. Three have been retained from the four hired in January. Four new dispatchers will start May 31 and should be released on their own sometime in September. There will be one more hiring process this year, ending the year with 9 vacancies.

- IV. <u>Statistics:</u> (Hensley) Total calls are down from 2021. Calls increased in April from March. 911 calls have increased but are being answered quicker

There are 330-375 landline calls a month. Just under 4% are businesses. 5% are residential. January – April 2022 there were approximately 6500 total with 5% being residential.

Time to dispatch on fire calls. Stats for March 1 -April 30 are in the packet. The benefits of the Protocols is that it shortens training time and customizes the responses for responders and they get standardized information. It was never meant to shorten response time.

Dillard – compliance is not time based? AH – that is correct.

Dillard – what is the standard: AH will get that information to fire.
