Built for Zero Initial Goals



Ensure our region has quality data.

- Public data dashboard by early 2023.



Initial focus on veteran homelessness.

 Created veteran advisory council to assist us in housing veterans.



Logistical Support for South Central Housing Network

South Central Housing Network works to "provide and coordinate the best possible housing resources and supportive services to those who are most in need."

Network covers the counties of Monroe, Morgan, Lawrence, Owen, Greene and Martin.

Members are required to join the network as a condition of receiving federal (HUD) funding.



Cross-Agency Training





Collaborating with the South Central Housing Network to create a cross-agency training program.





Goal: To provide professional development trainings that will educate, empower, and support staff who are doing housing security work.

SCHN Advocacy Committee

Collaborating with the South Central Housing Network to advocate for community resources that improve housing security in the region.

SCHN Street Outreach Policy Committee

Collaborating with the South Central Housing Network to develop a street outreach policy for this region.

Starting with street outreach template provided by Built for Zero.

Committee is still being formed, but will likely include representatives from HealthNet, Centerstone, Beacon, IU Positive Link and others.



Housing Navigation Resource Guide

Resource to provide accurate, up-to-date guide for people searching for low-income housing and related resources.

Contracted with Deborah Myerson for this work.

Estimated launch: First quarter 2023.

Regional Outreach

Housing security is a regional issue.

Partnering with United Way of South Central Indiana.

Met with community leaders in Lawrence and Orange counties in August for a wide-ranging discussion on housing needs & solutions.



Regional Outreach

Partnered with Owen County Community Foundation.

Convened community leaders in August to strategize how to improve housing security in Owen County.

Similar event planned later in September with the Greene County Alliance, in partnership with the Greene County Foundation.



Weekly Shelter Check-Ins

Convene Monday morning meetings with shelter providers, City of Bloomington, Monroe County Public Health, IU Health and others.

Updates on shelter capacity, public health issues, other relevant information.

Designed to spot problems or trends in a timely way, coordinate responses.



Housing & Eviction Prevention Program (HEPP)

Partnering with Community Justice & Mediation Center (CJAM) to partially fund this year's HEPP staff.

Working with CJAM and other stakeholders to address sustainability of this important work.

Developing Eviction Court Watch program of volunteers, based on a Prosperity Indiana model.



Rental Renovation Pilot Project

Goal: Increase regional housing units that are accessible to low-income and homeless individuals, specifically residents with health issues, or mental health and substance abuse challenges.

Applied for \$1.5M IU Health Community Impact Investment grant.

Program would fund renovations of landlord-owned housing units in exchange for long-term master lease agreements with local agencies that work with clients who are housing insecure.



Landlord Risk Mitigation Program

Partnership with Bloomington Housing Authority's Landlord Risk Mitigation Program.

Expand program outside Bloomington city limits, starting in early 2023.

Encourage increased landlord participation in accepting Housing Choice Vouchers (Section 8) and expand housing opportunities for low-income residents with housing barriers in the Monroe County.



Community Loan Center

Employer-based alterative to predatory lending.

Working with Prosperity Indiana on a program rolled out in other communities.

Looking for a partner financial institution.

Conversations with CDFI Friendly Bloomington.



Ordinance #: 22-24 Amendment #: Am 01

Submitted By: (in search of sponsor) **Date**: September 21, 2022

Proposed Amendment:

1. <u>Ordinance 22-24</u> shall be amended by inserting a new Section 3 and renumbering subsequent sections accordingly. The new Section 3 shall read as follows:

SECTION 3. To the extent such annexation is completed, the South-East Bloomington Annexation Area that was the subject of <u>Ordinance 17-12</u> is hereby reassigned to Council District No. 5. Following the effective date of the annexation, the City will review and redistrict its Council Districts as appropriate and required to ensure compliance with I.C. 36-4-6-3, I.C. 3-5-10, or other applicable laws.

Synopsis

This amendment adds a new section to reassign the South-East Bloomington Annexation Area that was the subject of <u>Ordinance 17-12</u>, if that annexation is completed, to the new Council District 5 as a result of the redistricting process. <u>Ordinance 17-12</u> had previously assigned the Annexation Area to District 4, which would no longer be contiguous to the Annexation Area upon adoption of <u>Ordinance 22-24</u>.
