- 1. Introductions- David Parkhurst (from EC), and Matt Smethurst (Engineering)
- 2. Minutes from November- approved
- 3. January meeting push to 1/23 due to MLK holiday
- 4. No public comment
- 5. Engineering West 1st street reconstruction (College to Maple)- narrower road, larger sidewalks and larger tree plots, all due to redevelopment of hospital/Hopewell area
 - We had seen plan last summer with Erin, who had identified some trees that are important to be saved
 - Focus for this presentation is on street trees
 - Reconstruction of wall (method = cast-in-place) and road grading done with goal to save trees
 - o Removing 21 trees, but will be replaced with 84 new trees
 - Trees are being removed because of utility conflict
 - Larger trees to be removed were generally in poor health or were Callery Pear
 - Construction begins February (digging when trees dormant) and going into spring/summer 2023
 - o New tree plots- what are the sizes? this detail may not be included in current plan
 - Plots on south side of street may be too confining
 - o INDOT has already approved plan as it is, but we have leeway with tree species
 - Species currently include about ¼ maples, should remove legacy sugar maples (size) and concern with overplanting of Acer genus
 - Legacy maples will be replaced depending on plot size and location
 - Haskell will give us his recommendations on species, we will vote in January

6. Urban forester report

- o Removals- approx. 250 this year
- Currently working on problem areas- clearing of poor condition/invasive species, removing Callery Pears from Jackson Creek school area and Butler West area
 - Planting of fruit trees in Butler area new gardens
- o Pruning- around 840 this year
- o Planting- around 370-400 for year
- Labor position interviews concluded this past Thursday, person has been selected and awaiting HR approval
- All bicentennial planting complete, inspections (first round) completed, adding deer guards and stakes, 177 additional plantings this spring
- o Bicentennial round 2- downtown area plantings (90)- these are in TreeKeeper
- Park Board service agreements with Bluestone and Canopy were both approved
- o B-line removals and replacements of Callery Pear are complete
- o Pruning on E Winston will begin soon
- Working on updating UDO buffer update
- Upcoming neighborhood planting with Canopy in spring
- City union contract- bucket truck, chipper saw safety course
 - Additional educational opportunities (pruning, etc.) also upcoming
- Additional partnerships with Middleway and post bicentennial planting survey (IU), and Youth Tree Tenders (w/Canopy)

- River Farm Nursey on Kentucky- Haskell is in negation with them, similar soil to what we have and more heat-adapted southern trees, nursery also has additional interesting cultivars (American Sycamores an example, heat-adapted River Birch)
- o Tom's plaque- Haskell will get order in after January 9, dedication in April

7. IU update (Mia)

- Tree planting is complete for year, two additional trees to be planted after current snow issues over
- Success story with INDOT- 45 and Pete Ellis/Discovery drive intersection- INDOT will compensate IU for 27 trees removed in the area with \$45,000 (up from \$5,000), this was approved by IU trustees

8. Environmental Commission report (Dave)

- Land planning group (ECPC)- Linda Thomson, liaison from city, used to be able to report
 to EC on any plans that might need comment or review, but this is no longer the casethe Commission is working on how they can begin getting these reports again
- Has 2-3 pages of updates to send to the UDO
- o Discussing what might happen with the Habitat Connectivity Plan
- Will begin planning 2023 in January
- o ERAC-
 - discussion of deer management (46 deer taken over the two hunting weekends)
 - prescribed burns- none done this year (no burn advisory due to drought) in order to reduce maple and beech and promote oak and hickory
 - 7th street greenway- 25% survival (vandalism and car accidents)
- Leonard Springs- potential expansion
 - Smaller area (5 acre) likely to be purchased, larger area (50 acre) over budget

9. Old business

- Approval of finalized tree lists (interior lists)
 - Will go through Linda and then to UDO
 - And this is editable for next year- revisit and build next fall
 - Haskell will send this along

10. New business

- o Laurel and Dedaimia will not continue in their roles
- David P. is currently taking on Dedaimia's role (add David to email list)
- Tree Commission officer appointment for 2023
 - Need to replace Laurel as chair- we will make decision next month
 - George is willing to be Vice President

11. Next big task- revision of Tree Care Manual

- Language in text- remove qualification of "healthy" for trees required to be replaced due to removal for construction, etc. projects
