- O'Neill IU Capstone Project Update

  - Group discussed the possibility of opening the survey back up for a specific period of time during some upcoming local events in order to get more responses from Black community members

  - Marissa will double check with Beverly Calender-Anderson on presenting the final report to City Council in December, and will follow-up with the group
