### I. APPROVAL OF MINUTES

Valerie moved to approve the **April 17, 2023,** as written. Sita thanked Lisa for her excellent minutes. Sue seconded.

Motion passes, 5-0-0.

#### **II. NEW BUSINESS**

# i. Appeal of Neuter Requirement – Baker

Officer Ennis reviewed the history of Chop and Pluto, dogs that have a history of being at large, owned by Gregory Baker. Officer Ennis confirmed that Pluto was previously neutered due to second offense, but Chop was not required to be neutered. She confirmed that Mr. Baker did comply with the fence requirement.

Gregory Baker explained that he was at work and his son did not latch the gate. He now has a female and wants to breed Chop one more time, then will get him neutered.

The Commission discussed.

Valerie moved that upon official notification that the gate of the enclosure has been secured, Chop can be released with the understanding that he can have one litter and then get neutered afterwards. If he gets out prior to the litter being created, he would be neutered. All litter permit requirements must be followed, all fines stand and written proof of neutered must be provided to Animal Control. Chris seconded.

Roll Call Vote: Sue – "Yes," Sita – "Yes," Chris – "Yes," Valerie – "Yes," Nancy – "Yes," Laura – "Yes."

Motion passes, 6-0-0.

# ii. Request to Declare Habitual Offenders – Williams and Flynn

Officer Ennis explained a long history of at large dogs owned by Jawan Williams and Julie Flynn, who were not present at the meeting, including Roxie, Regina and puppies. They have indicated to Officer that nothing will change and they have no plans to fix the broken fence. Virgil explained that the tools that Animal Control regularly use are not working.

The Commission discussed.

Valerie moved to declare Jawan Williams and Julie Flynn Habitual Offenders and require the removal of all animals under their ownership and guardianship. The animals are to be seized, brought to the animal shelter and relinquished. They are not allowed to have any additional dogs for the next three years. Sue seconded. Roll Call Vote: Sue – "Yes," Sita – "Yes," Chris – "Yes," Valerie – "Yes," Nancy – "Yes," Laura –

"Yes." Motion passes, 6-0-0.

### iii. Title 7 Ordinance potential update approval

Virgil outlined the proposed ordinance updated in the following areas:

Sita recommended updated the wording in the Reconsideration section 7.26.100 to reflect the change from Potentially Dangerous I, II, III and Vicious to Potentially Dangerous, Dangerous and Vicious.

Nancy moved to approve the ordinance updates with the above change to go to the Mayor and Council for approval.

#### iv. July Meeting date change

#### **III. REPORTS**

# i. Animal Care and Control Report

Virgil explained that they had a successful Memorial Day adoption special with reduced fees and with 55 animals adopted! June is Adopt a Cat month and fees are waived for adult cats. There are still six Carolina Dogs in foster and nine in the shelter. It has been challenging working with these dogs. The dogs in foster homes are doing extremely well. Unfortunately, as they are flight risks, two are currently missing in Bloomington. Statistics from January through May 2023, show basically the same amount of animals as 2022, although more dogs have come in than last year. The veterinarian shortage is a big challenge for the shelter currently. Pets Alive is now short a veterinarian and spay/neuter is getting backed up. The shelter is working on a foster to adopt program to get animals out before spay/neuter is scheduled.

# ii. MCHA Update

Sue reported that they do have an Executive Director! Andrew Krebbs who is currently the Communication Director for the City, will be starting July 5! The Development Director will be chosen soon and a new bookkeeper position has been created. The MCHA is also looking for a potential 3<sup>rd</sup> veterinarian.

### iii. AMC Update

Virgil reported that the last meeting went fine. As usual the County is still seeing lots of declarations and Habitual Offenders.

# **IV. ANIMAL CONTROL COMMISSION DISCUSSION**

Sita reported that she looked into egregious offender clauses. She found a lot of disparate information, but learned that it usually becomes a legal matter that is turned into the State.
