Ellen Rodkey made a motion to approve Consent Calendar. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

B. PUBLIC HEARINGS/APPEARANCES

B-1. Bravo Award

Emily Buuck, Community Relations Coordinator presented Paul and Linda Kern with the May Bravo award for the many hours given as Adapt-a-Greenspace volunteers at Griffy Lake/Dunn Street. Their support, helped reverse the impact of forest-degrading pressure, helped in the collection of trash, and in the effort to stop the spread of invasive species. The department and staff were grateful for their volunteer hours and support.

The Board: thanked Paul and Linda Kern for their service.

B-2. Parks Partner Award – none

B-3. Staff Introductions

Jason Sims, Cascades Golf Course Facilities Manager, had recently accepted the position of Manager at Cascades Golf Course. Over the last eighteen years, Jason had held many positions at Cascades Golf Course, and had moved up the ladder from his first position as Attendant to Facility Manager.

Erin Freese-Posthura, had recently accepted the position of Program Specialist at Banneker Community Center. Erin's primary experience had been working with children to provide educational activities and help meet specific needs of both children and their families. Erin had previously provided classroom support within the Monroe County Community School Corporation, and had a strong day camp background.

C. OTHER BUSINESS

C-1. Review/Approval to Uphold Tree Work Permit Denial for 2626 S. Bryan Street

Haskell Smith, Urban Forester, Audrey Jo Williams had submitted a Tree Work Permit to have a White Pine tree removed at 2626 S Bryan Street. After an inspection of the tree had been completed, staff rated the tree at "low risk", and denied the permit. A private certified arborist, hired by the appellant, inspected the tree and rated the tree as "moderate risk". Staff recommended to uphold the denial of the Tree Work Permit.

The Board: took statements from Audrey Jo Williams.

Jim Whitlatch made a motion to uphold the appeal and reverse the decision to not remove the tree. *Israel Herrera* seconded the motion. Basis for decision: the information provided revealed the tree was standing alone, the tree was not located in an ideal location, and the tree was of a semi non-native species. One arborist had rated the tree as a "moderate risk". If the tree fell, personal injury or property damage could possibly occur. Vote taken: unanimously carried 4-0 in favor of upholding the appeal.

C-2. Review/Approval of Facility Suspension Appeal

Mark Sterner, General Manager Twin Lakes Recreation Center, due to major violations of City Policy 11080 Rules of Conduct outlined in the Behavior Guidelines, on March 9, 2023 Stewart Eaton was suspended from Twin Lakes Recreation Center for a three-month period. A lifetime suspension was issued when Stewart Eaton violated the original suspension on March 30, 2023. On April 12, 2023, the lifetime suspension was amended to a one-year suspension. The amendment was in accordance with City Policy. Staff recommended upholding the one year suspension from Twin Lakes Recreation Center.

The Board: took statements from Stewart Eaton.

Jim Whitlatch made a motion to uphold staff recommendation, and enforce a one year suspension of Stewart Eaton from Twin Lakes Recreation Center. *Ellen Rodkey* seconded the motion. Basis for decision: Mr. Eaton stated he never received the suspension notification in his email, despite documentation provided in the board packet that Mr. Eaton had corresponded with staff via email. The email exchange began on March 9th, 2023 sent by staff to Mr. Eaton requesting a meeting to discuss his facility usage. Mr. Eaton responded to the email on March 10th, 2023 at 2:46am writing he was too busy to meet, however staff concerns could be addressed through an email reply. On March 10th, 2023 10:53am the "Notice of Suspension" was sent to Mr. Eaton's email address. In the March 4th incident report, the language was concerning and contained a statement that Mr. Eaton said to staff "I won't live much longer" that kind of language along with the other incidents created concerns. *Ellen Rodkey* seconded the motion. Vote taken: unanimously carried 4-0 in favor of upholding the one year suspension.

C-3. Review/Approval of contract with Bo-Mar Industries Inc. for Design, Fabrication and Installation of Public art Element for the Miller-Showers Bicentennial Gateway

Tim Street, Operations and Development Division Director through the design process of the bicentennial gateways project, a monolith design had been selected to become Bloomington's north gateway. The final monolith element would be approximately 40-feet tall, constructed out of powder coated aluminum, would be internally-lit with controlled LED light zones, and have an organic appearance. Staff recommended approval of a contract with Bo-Mar Industries for the structural design fabrication, and installation of the monolith element at Millers-Showers Park. Amount was not to exceed \$395,105, and funding source would be Bicentennial Bond Series C-980-18-18018C-54510.

Board Comments: *Jim Whitlatch inquired:* on the durability of the material. *Adam Lee, Bo-Mar Industries responded:* the powdered coat was very durable material. *Jim Whitlatch inquired:* could it be recoated. *Adam Lee responded:* only if taken back to facility. Touch up paint would be available for small spots. *Jim Whitlatch inquired:* of the possibility of the color fading. *Adam Lee responded:* the powder coat stood up well against fading. *Jim Whitlatch inquired:* if the lights would be programmable. *Adam Lee responded:* yes, they would be programmable. *Kathleen Mills inquired:* if there would be any issues with electric services. *Tim Street responded:* there were no foreseen issues, it would require coordination with the general contractor. *Ellen Rodkey inquired:* could the possible changes made to the College-Walnut corridor affect the project. *Tim Street responded:* the plans were in areas of the park that should be unaffected by the College-Walnut corridor.

Ellen Rodkey made a motion to approve the contract with Bo-Mar Industries Inc. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-4. Review/Approval of Revision to Policy 13090 – Animal Restrictions in Park Locations

Leslie Brinson, Community Events Manager due to safety of participants, and the maintenance and upkeep of park property, staff wished to update Policy 13090 (Animal Restrictions in Parks). The language would update the policy to restrict domestic livestock, including horses, in all Parks and Recreation Parks without a permit. Staff recommended approval of the policy updates.

Board Comments: *Kathleen Mills inquired:* if the update was just a general update. *Leslie Brinson responded:* no, a horse had been ridden into Food Truck Friday at the Switchyard Park. *Kathleen Mills inquired:* on the reindeer that were at different events. *Leslie Brinson stated:* those were permitted through Animal Control. *Jim Whitlatch inquired:* on how domestic livestock was defined. *Leslie Brinson responded:* staff researched other Park Departments, and domestic livestock was the most common line used in that type of policy. *Jim Whitlatch recommended:* change language to “any domestic livestock, including but not limited to horses, are not allowed in the park without a permit”. *Ellen Rodkey inquired:* there were some specific park locations listed in some sections of the policy, and inquired if dogs were not allowed at Farmers’ Market unless a service animal. *Leslie Brinson responded:* the locations at the top portion of the policy referred to dogs/animals in areas where food would be served. It was a health code violation, not specific to parks. *Israel Herrera inquired:* on permits for animals. *Leslie Brinson responded:* if an event included animals, a special use permit would need to be submitted and approved. Some type of approval process with guidelines must be met. *Board Members recommended slight changes be made to the language.*

Ellen Rodkey made a motion to approve the policy updates that could include some of the Boards suggestions. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-5. Review/Approval of Contract with Chef for Hire, Inc for Banneker Summer Food Program

Kevin Terrell, Banneker Community Center Program and Facility Coordinator staffed wished to once again vend meals for the Banneker Summer Food Service Program. The vendor would produce, package, and deliver breakfast and lunch meals twice per week for the approximate 70 to 80 daily participants of the Banneker Camp summer program. The packaged meals would meet the standard of the USDA Summer Food Service Program. The USDA Summer Food Service Program, would reimburse Banneker for each meal served. Staff recommended approval of the contract with Chef for Hire, Inc.

Board Comments: *Ellen Rodkey commented:* The work that had been done at the Banneker was wonderful, the facility looked great, and there were great programs offered for the Banneker community.

Ellen Rodkey made a motion to approve contract with Chef for Hire, Inc. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-6. Review/Approval of Contract with Mother Nature Landscaping for Watering Services for the 2023 Downtown Tree Planting Project

Haskell Smith, Urban Forester to alleviate burden on the in-house watering truck, staff wished to contract an outside watering service. Through the 2023 Downtown Tree Planting Project, approximately 90 trees were slated to be planted in the downtown area. The contract would provide an extra level of survivorship to those trees. Staff recommended approval of the contract with Mother Nature Landscaping, in an amount not to exceed \$25,200. Funding source would be bicentennial bond 980-18-18018c-54510.

Board Comments: *Kathleen Mills confirmed:* the department did have their own watering truck. *Haskell Smith responded:* that was correct. Staff would water close to 6,000 trees in 2023. *Kathleen Mills inquired:* if there were just

too many to take care of with the new additional downtown trees. *Haskell Smith responded:* it was too many, especially with the trees being located in the downtown area.

Ellen Rodkey made a motion to approve contract with Mother Nature Landscaping. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-7. Review/Approval of Peoples Park Special Use Agreement with IU Arts and Humanities

Crystal Ritter, Community Events Coordinator the IU Arts and Humanities Council wished to temporarily install the haptiK/B sculpture by W. Dorian Bybee in Peoples Park from June 1 through June 30, 2023. The agreement included a month by month renewal option up until September 1, 2023. The request included a plan for performances on a small portable stage that would be part of the art installation. IU Arts and Humanities Council would submit a maintenance and vandalism plan. Staff recommended approval of the Special Use Agreement.

Board Comments: *Jim Whitlatch inquired:* What would IU's monitoring plans be for protecting the art work. *Crystal Ritter responded:* IU Arts and Humanities would submit a maintenance and vandalism plan prior to installation. They stated "IU Arts and Humanities Council staff offices were located within a two minute walk from the proposed site of the installation, and during the weekday, they would assign one staff member to walk by the piece every day to monitor it for any damage. IU Arts and Humanities and the artist agreed to be responsible for any maintenance, removal of graffiti, or vandalism while installed". *Jim Whitlatch comment:* was concerned on how the piece would be attached, and concerned with the possibility of vandalism occurring to the art work at night. *Crystal Ritter responded:* the Community Family Resources Department's night time ambassador monitored the downtown area, and could keep an eye on the piece. Due to those types of concerns, the agreement would be on a month by month renewal basis. If issues developed, staff could request the installation be removed. *Jim Whitlatch inquired:* if the installation would provide areas for people to sleep. *Holly Warren, Assistant Director of Arts responded:* that had been a concern expressed to the artist. People could not enter or manipulate the installation, it was not anticipated that people would be able to sleep there. *Israel Herrera inquired:* on what the haptiK/B installation meant. *Holly Warren responded:* it referred to a sensory experience. The idea, the installation would be a replication of the Peoples Market that use to be at that site. *Israel Herrera inquired:* what would the extension be based on. *Holly Warren responded:* if no issues occurred, the art work would remain until September. To give people more time to think about the history of the site and interact with the piece. *Ellen Rodkey inquired:* if the portable stage that would be part of the installation could be used after the festival. *Crystal Ritter responded:* yes, individuals would need to complete a Peoples Park Use Permit for approval to use the stage. *Israel Herrera inquired:* if vandalism or damage occurred, who would determine if it would be repaired or removed. *Crystal Ritter responded:* IU Arts and Humanities would make that determination. Park and Recreation staff could request it be removed if deemed necessary.

Ellen Rodkey made a motion to approve special use permit with IU Arts and Humanities. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-8. Review/Approval of Indemnification Agreement with First Capital for Use of Parking Area for Overflowing Parking Expected at the Switchyard Park Thursday Concert Series

Hsiung Marler, Switchyard Park General Manager due to anticipated need of additional parking for the Thursday night Regional Concert Series. Visit Bloomington! had secured the vacant First Capital property on the west side of S. Rogers Street. The property owners had requested Visit Bloomington! and City of Bloomington Parks for an Indemnity Agreement. Staff recommended approval of the Indemnification Agreement.

Ellen Rodkey made a motion to approve indemnification agreement for the additional parking with the LLCs listed. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0

C-9. Review/Approval of Contract with Neidigh Construction for Structure Removal at Griffy Lake Nature Preserve

Steve Cotter, Natural Resources Manager staff wished to have three abandoned, and dilapidated structures removed from Griffy Lake Nature Preserve. The structures were located on the 20 acer parcel that had been donated to the Department by Julia Heiman. The contractor would be responsible for removal the buildings, and dispose of the debris. Staff recommended approval of the contract with Neidigh Construction, in an amount not to exceed \$13,200. Funding would be from Natural Resources General Fund budget.

Ellen Rodkey made a motion to approve contract with Neidigh Construction. *Israel Herrera* seconded the motion. Vote take: unanimously carried 4-0.

Julie Ramey, Community Relations Manager on April 16, 2023 at the annual Hoosier Trails Council Gala, Park Board Commissioner Jim Whitlatch had been presented with a North Star Award for his service to the Council as its pro bono attorney. 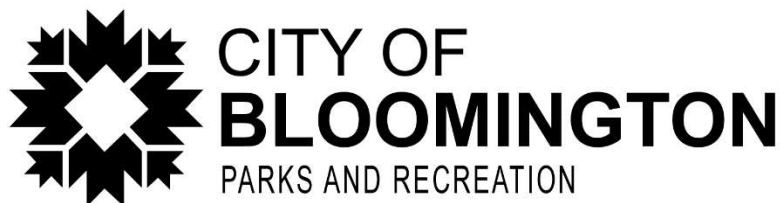
Background

COOPERATIVE PROGRAM PARTNERSHIP AGREEMENT

Cicada Cinema

This agreement is made and entered into this _____ day of _____, 2023, by and between the City of Bloomington Parks and Recreation Department (“BPRD”) and Cicada Cinema (“Cicada”).

WHEREAS, BPRD and Cicada Cinema desire to cooperate in the provision of free outdoor movies for the benefit of the general public; and

WHEREAS, Cicada Cinema is qualified to perform such services with BPRD; and

WHEREAS, BPRD is authorized to plan and develop partnerships and contractual arrangements with non-city organizations to ensure delivery of services;

NOW, THEREFORE, in consideration of the terms and conditions set forth herein, the Partners to this Agreement agree as follows:

1.0 Purpose of Agreement:

The purpose of this Agreement is to outline a program partnership which provides for increased entertainment opportunities for the Bloomington community by combining available resources from each partner to the Agreement.

2.0 Duration of Agreement:

This agreement shall be in full force and effect from July 1, 2023 to October 1, 2023, unless early termination occurs as described in Article 7 of this Agreement.

3.0 Bloomington Parks and Recreation

The goal of BPRD is to build a positive relationship with Cicada Cinema in order to provide more affordable entertainment opportunities for the Bloomington community. BPRD agrees to:

3.1 Provide Lower Cascades Park for a July 8th movie and Waldron, Hill and Buskirk Park for a September 2nd movie.

3.2 Compensate Cicada Cinema one hundred dollars for half of the cost of each movie rights. Total payment for movie rights by the BPRD shall not exceed \$200.

3.3 Promote the September 2nd movie in the Fall/Winter Program Guide and through public service announcements and social media, listing Cicada Cinema as a co-sponsor in all publicity.

3.4 Provide staff support prior to movies and as needed on the day of the movies.

4.0 Cicada Cinema

The goal of Cicada is to provide high-quality screenings of underrepresented cinema- the old, the new, and the locally created while partnering with local organizations.

4.1 Promote the films through their social media outlets, listing BPRD as a co-sponsor in all publicity.

4.2 Provide a screen, sound equipment, projector, and staffing for the movies.

4.3 Secure the movies and the rights to show the movies.

4.4 Provide invoices for payment by BPRD for one hundred dollars per movie.

4.5 Provide adequate staff and volunteers to manage both movies.

5.0 Terms Mutually Agreed To By All Partners To This Agreement:

The intent of this Agreement is to document a mutually beneficial partnership between BPRC and Cicada Cinema.

5.1 The staff and personnel involved will at all times represent all partners to this Agreement in a professional manner and reflect the commitment of both partners to quality services and customer satisfaction.

5.2 To commitment of personnel, promotions, equipment and funding sources will be honored according to the timetable agreed upon by all partners.

5.3 Bloomington Municipal Code sections 6.12.030 and 14.36.090, respectively, prohibit smoking in public places and the consumption of alcoholic beverages on City of Bloomington property.

5.4 The possession of drugs and other illegal controlled substances, fireworks, air rifles, paintball guns, bow and arrows, crossbows, swords, and pellet guns is strictly prohibited in any park or park facility. In addition, pursuant to Bloomington Municipal Code 14.20.020, the discharge of a firearm is strictly prohibited within the City's jurisdiction.

5.5 This Agreement and the services provided will be evaluated in March 2024.

7.1 Termination by mutual agreement: The partners may terminate this Agreement prior to December 31, 2023, by mutual written agreement only.

7.2 Unilateral termination: In the event that one of the partners to this Agreement

breaches any of its terms and conditions, the non-breaching party shall serve written notice of the breach to the other party by certified mail. The breaching party shall then have ten (10) days from the date of mailing in which to cure the breach. If the breaching party fails to cure the breach within ten (10) days, the non-breaching party may, at its option and in writing, unilaterally terminate the Agreement.

8.0 Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the other party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

9.0 Release and Hold Harmless Agreement:



This Agreement, entered into on this _____ day of _____ 2023, by and between the City of Bloomington Department of Parks and Recreation (the “Department”), and Butler, Fairman, & Seufert, Inc. (“Contractor”).

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, “Scope of Work”, attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before 7/31/23 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor’s work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Tim Street, as the Department’s Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances (“Standard of Care”). The Department shall be the sole judge of the adequacy of Contractor’s work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor’s performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department’s Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed two thousand dollars (\$2,000). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Department cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be

named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights

Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

This Agreement, entered into on this _____ day of _____, 2023, by and between the City of Bloomington Department of Parks and Recreation (the “Department”), and I Shine Cleaning, LLC (“Contractor”).

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, “Scope of Work”, attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before July 31, 2024 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor’s work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Kevin Terrell, as the Department’s Project Manager. Contractor agrees that any information or documents, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances (“Standard of Care”). The Department shall be the sole judge of the adequacy of Contractor’s work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor’s performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department’s Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed Forty five hundred dollars (\$4500). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Contractor cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such

policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights

Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

Recommendation

WHEREAS, there is a need for a summer dog event in Bloomington: and,

WHEREAS, the BPRD and Mad 4 My Dog desire to cooperate in the provision of a community event called Drool in the Pool for dogs and owners; and,

WHEREAS, Mad 4 My Dog is qualified to perform such services; and,

WHEREAS, the BPRD is authorized to plan and develop partnerships and contractual arrangements with other community organizations to ensure delivery of services; and

WHEREAS, services provided by each partner will reflect on the other in the Partnership Agreement requiring clear communication and outline of expectations.

NOW THEREFORE, the partners do mutually agree as follows:

1. Purpose of Agreement:

2. Duration of Agreement:

This Agreement commences on July 12, 2023 and expires on August 31, 2023 unless terminated earlier as provided under Article 7.

3. Bloomington Parks & Recreation

The goals of BPRD are to partner with other community agency(s) and provide an opportunity for the Bloomington community, specifically dogs and their owners, to participate in an affordable and fun summer event called Drool in the Pool. The event, to be held at Mills Pool, on Wednesday and Thursday, August 2 and 3, from 5:00-8:00 pm is designed to create social, safe, and fun opportunities for dogs and their owners.

BPRD agrees to:

- 3.1. Create and coordinate the distribution of promotional materials including printed material as well as social media.
- 3.2. Communicate to the public and participants regarding concerns or questions about cooperative programs and activities.
- 3.3. Email out sponsorship/vendor information to past participants.
- 3.4. Promote Drool in the Pool at other major family-friendly BPRD events prior to the event.
- 3.5. Share all marketing/promotional material with Mad 4 My Dog.
- 3.6. Provide the Community Events Coordinator and additional full-time/part-time staff necessary for the event.
- 3.7. Coordinate recruitment and scheduling of volunteers.
- 3.8. Contact and schedule Animal Control officers to be onsite during event to check dog vaccination records.
- 3.9. Provide maintenance staff who shall be assigned to maintain and prepare the facility on the day of the event. Additional maintenance support staff needed to perform other repairs, tasks and services shall also be provided.
- 3.10. Facilitate the pool area during the event.
- 3.11. Be responsible for on-site registration and check-in.
- 3.12. Take any citizen concerns, reports or problems regarding the facility, improvements to the facility, services provided by staff or other issues by referral to BPRD on the designated form within 24 hours of observation.
- 3.13. Provide Mills Pool as the facility to house the event.
- 3.14. Work with the Aquatics Manager to open and close the facility and assist with facility-related matters.
- 3.15. Provide tables and chairs necessary for all activities for the event.
- 3.16. Provide temporary fencing for the event.
- 3.17. Provide regular checking, stocking and maintenance of locker rooms.
- 3.18. Develop all sponsorship materials for distribution.

- 3.19. Design and order the event t-shirts.
- 3.20. Provide a sound system.
- 3.21. Provide an emcee and contest judges for the event.

4. Mad 4 My Dog

The goals of Mad 4 My Dog are to partner with another community agency and provide an opportunity for the Bloomington community, specifically dogs and their owners, to participate in an affordable and fun summer event called Drool in the Pool. The event, to be held at Mills Pool, on Wednesday and Thursday, August 2 and 3, from 5:00-8:00 pm is designed to create social, safe, and fun opportunities for dogs and their owners.

Mad 4 My Dog agrees to:

- 4.1. Maintain close contact with Bill Ream, Community Events Coordinator, and address any related issues to his attention.
- 4.2. Assist with marketing the event including social media posts.
- 4.3. Secure all prizes for contests.
- 4.4. Refer any citizen concerns, reports or problems to BPRD within 24 hours of observation.
- 4.5. As possible, provide staff for each night of the event.

5. Terms Mutually Agreed to By All Partners:

The intent of this Agreement is to document a mutually beneficial partnership between Mad 4 My Dog and BPRD for Drool in the Pool.

BPRD and Mad 4 My Dog agree to:

- 5.1. Coordinate safety management and regulate visitor flow of Drool in the Pool.

Recommendation

Staff recommends approval of the 2023 Cooperative Partnership Agreement with the Monroe County History Center to provide programming and volunteer support for the “Dearly Departed Cemetery Tours” in Rose Hill Cemetery on Saturday, October 14 of 2023. The partnership agreement also includes a 50/50 revenue split of the gross revenue from the registration fees collected. The revenue split is to be paid out of 201-18-186500-53990.

Background

Our partnership with the Monroe County History Center (MCHC) will provide an evening of cemetery tours of Rose Hill Cemetery that highlights the stories of some of the permanent residents of this historic cemetery. This partnership began in 2018 and continues to be a successful program that has seen growth in attendance each year. We would like to work them again in 2023 to provide cemetery tours of Rose Hill Cemetery through the “Dearly Departed Cemetery Tours” program on Saturday, October 14. The partnership outlines the program to be provided by the MCHC and the logistics and registration management to be provided by the Bloomington Parks and Recreation Department.

**COOPERATION SERVICE AGREEMENT
PROGRAM PARTNERSHIP**

This Agreement is made and entered into this ____ day of _____, 2023, by and between the Bloomington Parks and Recreation Department (“BPRD”) and the Monroe County History Center (MCHC).

WHEREAS, BPRD and the MCHC desire to cooperate in order to provide cemetery tours of Rose Hill Cemetery for the benefit of the general public; and

WHEREAS, the MCHC is qualified to perform such services with BPRD; and

WHEREAS, BPRD is authorized to plan and develop partnerships and contractual arrangements with non-city organizations to ensure delivery of services;

NOW THEREFORE, the partners do mutually agree as follows:

1.0 Purpose of Agreement:

The purpose of this Agreement is to outline a program partnership which will provide for greater services in unique programming to the community by combining available resources from each partner to this Agreement.

2.0 Duration of Agreement:

This Agreement shall be in full force and effect from July 12, 2023 to May 30, 2024, unless early termination occurs as described in Article 8.0 of this Agreement.

3.0 Bloomington Parks and Recreation:

The goal of BPRD is to build a positive relationship with the MCHC in order to provide educational and engaging cemetery tours of Rose Hill Cemetery through the “Dearly Departed Cemetery Tours” program and the Headstones Restoration Workshops for the Bloomington community.

Dearly Departed Cemetery Tours

BPRD agrees to:

- a. Provide use of Rose Hill Cemetery for the tours and use of the Rose Hill Cemetery Office for restrooms and actor dressing rooms on the nights of the scheduled tours. Tours are to be held on Saturday, October 14th with a rain date scheduled for Sunday, October 15th.
- b. Publicize the cemetery tours through social media outlets, the program guide, posters, and in weekly press releases.
- c. Provide infrastructure for the tours including tents, tables, chairs, lighting, and decorations.
- d. Provide at least two full-time staff members to assist with tours.
- e. Run registration for programs and process payments for program registration.
- f. Name MCHC in all forms of publicity as a co-sponsor of tours held in Rose Hill Cemetery.
- g. BPRD will split equally (50/50) all gross revenue from cemetery tour registration with MCHC. BPRD will email the MCHC a final registration roster after the last cemetery tour to secure an invoice for the amount due, and will pay the invoice within thirty (30) days after receipt.

Headstone Restoration Workshops

BPRD agrees to:

- a. Provide use of Rose Hill Cemetery for the workshops and use of the Rose Hill Cemetery Office for restrooms and water spigot. Workshops are to be held on Saturdays, June 24, September 23 and October 21st from 10am – 2pm.
- b. Provide use of the Rose Hill Cemetery garage to store stone, sand and other supplies as needed. These supplies will be dropped off a couple of days in advance of each workshop.
- c. Publicize the workshops by displaying posters in the Rose Hill Cemetery kiosk and the Building Trades Park kiosk.

4.0 Monroe County History Center:

The goals of MCHC are to increase awareness of the Monroe County History Center and to educate the Bloomington community on the history of Rose Hill Cemetery through a mutually beneficial partnership with BPRD.

Dearly Departed Cemetery Tours

MCHC agrees to:

- a. Name BPRD in all forms of publicity as a co-sponsor of the tours.
- b. Be responsible for the production of the tours in their entirety including: rehearsals, props, costumes, make-up, and other production needs.
- c. Research content for and create the program for tours. Ensure that the tours are appropriate for the general public.
- d. Recruit and train the required number of volunteers needed to lead tours and execute the tour program as planned and agreed upon by partners.
- e. Provide invoice to BPRD following the receipt of a final registration report provided by BPRD.
- f. Provide at least two paid staff members to assist with tours.

Headstone Restoration Workshops

MCHC agrees to:

- a. Secure the Rose Hill Cemetery Office and garage at the conclusion of each workshop.
- b. Provide a list of all headstones that received care/cleaning/repairs and their location, (section/lot), to the BPRD staff.
- c. Provide at least two persons who take responsibility for the organizing, work, and clean-up during the workshops.
- d. Provide volunteers needed to accomplish the headstone repairs.
- e. Ensure that all safety measures are in place for all paid workers and volunteers while workshops are taking place.

5.0 Release and Hold Harmless Agreement:

MCHC, including its membership, agents, and assigns, do hereby agree to release, hold harmless, and indemnify the City of Bloomington, its Parks and Recreation Department, and any and all employees, agents, and assigns from any and all claims, causes of action, suits, proceedings, or demands, including but not limited to claims involving personal injury or death, which may arise from this Agreement, even if caused by the negligence of releasees.

6.0 Terms Mutually Agreed to by all Partners to This Agreement:

- a. The intent of this Agreement is to document a mutually beneficial partnership between BPRD and MCHC.
- b. The staff and personnel involved in this Agreement will at all times represent both partners to this Agreement in a professional manner, and reflect the commitment of both partners to quality services and customer satisfaction.
- c. The commitment of personnel, promotions, equipment, and funding sources will be honored according to the timetable agreed upon by both partners.
- d. MCHC is recognized as having the expertise and experience to run the production safely and effectively. BPRD shall have the right to review risk management, agreement terms, and service quality issues.
- e. The Agreement and the services provided will be evaluated in March, 2024.
- f. The possession of alcoholic beverages, drugs and other illegal controlled substances, fireworks, air rifles, paintball guns, bow and arrows, crossbows, swords, and pellet guns is strictly prohibited in any park or park facility. In addition, pursuant to Bloomington Municipal Code 14.20.020, the discharge of a firearm is strictly prohibited within the City's jurisdiction. Amplified music, or the promotion or sale of any article is expressly prohibited without a Special Use Permit.
- g. Municipal Code sections 6.12.020 prohibit smoking inside City of Bloomington facilities on City of Bloomington property.
- h. BPRD and MCHC have agreed to make a decision to cancel or postpone the scheduled programs due to inclement weather by 2:00 pm on October 13th for the tours. Inclement weather is defined as a sustained temperature below 38 degrees Fahrenheit, a wind chill below 32 degrees Fahrenheit, heavy rain, and/or forecasted severe weather during the scheduled tours.
- i. In the event of cancellation due to inclement weather, both parties will provide staff, volunteers, and equipment to run the tours on the scheduled rain date. The rain date is scheduled for Sunday, October 15, 2023.

8.0 Termination

This Agreement may only be terminated in writing and by the mutual agreement of all partners.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify the Monroe County History Center of any such termination and the reasons therefore in writing.

9.0 E-Verify

Pursuant to Ind. Code 22-5-1.7-11(a), which was adopted on July 1, 2011, MCHC as a business entity has to enroll in and verify the work eligibility status of all newly hired employees through the E-Verify program. MCHC is not required to continue this verification if the E-Verify program no longer exists.

Recommendation

Staff recommends approval of the 2023 partnership agreement between Bloomington Parks and Recreation and Purdue Extension Office of Monroe County for Food as Medicine program. No money will be paid out in this partnership.

Background

Bloomington Parks and Recreation has had a longstanding relationship with Purdue Extension Office of Monroe County. This will be the first year for Food as Medicine. Food as Medicine will be grant funded through the Jack Hopkins Social Services funding program. Food as Medicine aims to serve underrepresented families, located in and around the Crestmont neighborhood of Bloomington. Food as Medicine is an 8-week program that will provide educational lessons, as well as a cooking demonstration weekly. Each family will be supplied with weekly meal kits to recreate the recipe at home, as well as wellness incentives at the end of the program.

Highlights include:

- Food as Medicine will be held at Banneker Community Center Thursday evenings, 5:30-6:30 p.m., from August 3 – September 21, 2023.
- Food as Medicine will provide underrepresented, Monroe County families with nutrition and physical activity education, as well as weekly meal kits.
- Wellness incentives will be provided to families at the end of the program to encourage continued utilization of Parks and Recreation facilities to promote health and wellness.

7.0 Termination:

- 7.1.** Termination by mutual agreement: The partners may terminate this Agreement prior to December 31, 2023 by mutual written agreement only.
- 7.2.** Unilateral termination: In the event that one of the partners to this Agreement breaches any of its terms and conditions, the non-breaching party shall serve written notice of the breach to the other party by certified mail. PEMC shall require any subcontractors performing work under this contract to certify to the PEMC that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. PEMC shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

**STANDARD CONTRACT
BETWEEN
CITY OF BLOOMINGTON PARKS AND RECREATION DEPARTMENT
AND
TERMINIX
FOR
GREEN PEST CONTROL**

This Agreement, entered into on this _____ day of _____ 2023, by and between the City of Bloomington Department of Parks and Recreation (the “Department”), and Terminix (“Contractor”).

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, “Scope of Work”, attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before July 31, 2024 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor’s work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Kevin Terrell, as the Department’s Project Manager. Contractor agrees that any information or documents, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances (“Standard of Care”). The Department shall be the sole judge of the adequacy of Contractor’s work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor’s performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department’s Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed One thousand dollars (\$1000). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Contractor cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be

named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights

Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

Recommendation

Staff recommends approval of an encroachment agreement with 400 W 7th, LLC, for a redevelopment at the same address, otherwise known as the "Johnson Creamery."

Background

The Johnson Creamery building, located at 400 W 7th St., is being redeveloped into a mixed-use building. The developers would like to attach the new building to the B-Line trail just west of the Showers Plaza with a concrete sidewalk, and additionally, the construction will require some encroachment onto city-owned property. This encroachment agreement is the City's typical template agreement used for encroachments onto the B-Line and other trails. The development will remain responsible for the upkeep and maintenance of any encroachments they build onto public property, while the City reserves to the right to have these improvements removed if deemed necessary.

**AGREEMENT REGARDING ENCROACHMENT
ONTO THE B-LINE TRAIL**

This Agreement, dated this ____ day of _____, 2023, WITNESSETH:

WHEREAS, 400 W. 7th, LLC, on its own behalf and on behalf of its successors and assigns (“Developer”) is redeveloping a property with an address of 400 W. 7th St in Bloomington, Indiana (“Property”), which is immediately adjacent to property owned by the City of Bloomington (“City”) known as the B-Line Trail (“City Property”), and Developer desires to encroach onto the City Property with a pathway as more specifically depicted in Attachment A, attached hereto and incorporated herein by reference (the “Encroachments”); and

NOW THEREFORE, in consideration of the Developer’s ability to encroach onto the City Property as described herein, Developer, its officers, directors, agents, employees, members, successors and assigns, do hereby acknowledge, covenant, and agree to the following terms and conditions:

1. This Agreement shall apply only to the Developer and cannot be transferred to a different property owner.
2. If the City or another governmental agency with jurisdiction over the City Property determines that the City Property containing one or more of the Encroachment(s) should be improved to better serve the public, or that other public improvements need to be made on the City Property and the Encroachment(s) interfere with the planned public improvements, the City may require Developer to remove the Encroachment(s) at the Developer's cost. If the City proposes changes to the City Property that require removal or alteration of the Encroachments, the City agrees to make reasonable efforts to coordinate alternatives to the Encroachments with Developer.
3. Developer accepts responsibility for the maintenance, repair, proper working conditions, and all expenses associated with the Encroachment(s). Specifically, Developer or Developer’s designee shall maintain the Encroachment(s) in good repair and take such other measures as are reasonably necessary to maintain the Encroachment(s) in good, clean condition.
4. The City’s approval of the Encroachment(s) does not relieve Developer from any provisions of any applicable zoning or other ordinance or statute that may apply to the City Property.
5. The City may alter the terms and conditions of the Encroachment(s) to address unanticipated problems or may even revoke permission to encroach if the City determines the Encroachment(s) are undesirable in terms of the general welfare of the City or City Property.
6. Developer understands and agrees that if the City or a public utility need to work in the area of the Encroachment(s) for any reason, and the Encroachment(s) need to be removed to facilitate the City or the utility, the removal of the Encroachment(s) will be at the expense of Developer and the City will not be responsible for any damage which may occur to the Encroachment(s).
7. Developer shall use its best efforts to inform its tenants that the City requires special use permits to be obtained through the Parks and Recreation Department for any activity on the B-Line Trail or other park property that uses the property to the exclusion of other users. Any use of the City Property by Developer or Developer’s tenants without a special use permit that operates to exclude other users from the City Property is a violation of this Agreement.

8. Developer agrees for itself and its successors in interest to release and forever discharge, indemnify and hold harmless the City of Bloomington, its departments, officers, agents, employees, successors and assigns for any and all actions, including attorney's fees, losses or injuries that occur as a result of its use of the City Property. In case any claim or action in court is brought against the City of Bloomington, or an office or agent of it, for the failure, omission or neglect of the Developer to perform any of the covenants, acts, matters or things by this agreement undertaken or for injury or damage caused by alleged negligence of the Developer or its agents, employees or subcontractor, the Developer shall indemnify and hold harmless the City of Bloomington and its officers and agents, from all losses, damages, costs, expenses, judgments or decrees arising out of such action, including attorney's fees.

9. Developer expressly agrees that its obligations under the foregoing Agreement are intended to be as broad as permitted by law and if any portion thereof is not found to be enforceable, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

The undersigned person executing this Agreement on behalf of Developer represent and certify that they are duly authorized to execute this Agreement on Developer's behalf.

This Agreement shall be recorded in the Office of the Monroe County Recorder and is expressly intended to run with the land and bind Developer and Developer's successors and assigns and inure to the benefit of the City of Bloomington. Developer expressly consents to the provisions of this Agreement on its own behalf and on behalf of its successors and assigns.

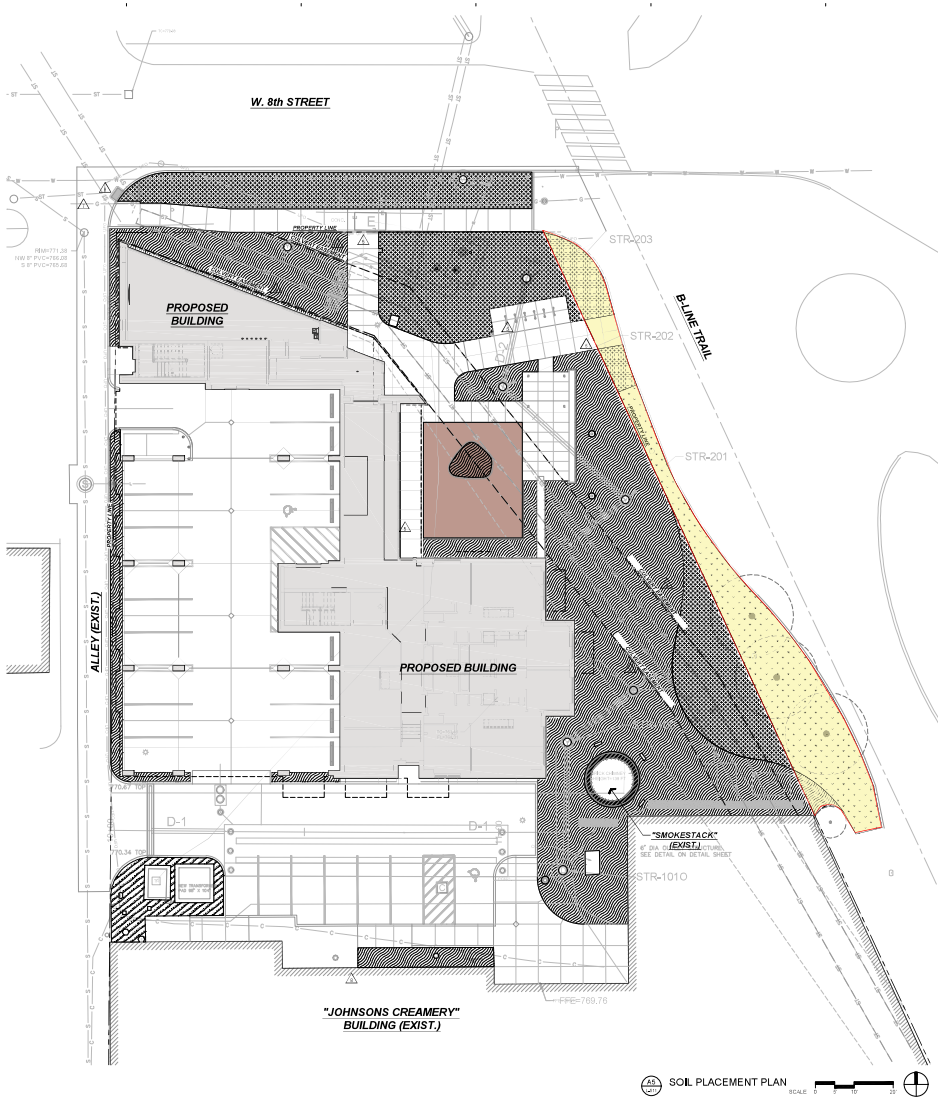

Recommendation

Staff recommends approval of the MOU regarding shelter rental fee waiver for volunteer groups for the upcoming Adult Field Day event on July 28, 2023.

Background

The upcoming Adult Field Day event is one of the department's most intensive community events. THIS MEMORANDUM OF UNDERSTANDING is entered into by and between the City of Bloomington Parks and Recreation Department (Hereinafter referred to as “Parks”) and the (CLUB NAME HERE) (Hereinafter referred to as “Club”).

WHEREAS, Parks is hosting the second-annual Adult Field Day event at Switchyard Park in Bloomington on Friday, July 28, 2023 and is in need of 16 volunteers across two shifts. The two shifts are from 4:30 p.m. – 7 p.m. and 7 p.m. – 10 p.m. Volunteer duties include event set-up, game facilitation, craft help, prize table staffing, and teardown. The aforementioned duties list is not all-inclusive and may include other duties assigned by Parks supervisory staff and that are reasonably related to facilitating the event activities.

WHEREAS, Club and Parks wish for Club’s members to volunteer at Adult Field Day, in exchange for the shelter rental outlined herein.

NOW, THEREFORE, in consideration of the mutual covenants herein contained the parties hereto agree as follows:

1. Club agrees to provide a minimum of five (5) volunteers per shift. Club agrees that all volunteers shall be under the instruction and supervision of on-site Parks staff, shall stay for the duration of the shift they signed up for, and shall carry out the duties assigned by on-site Parks staff. Volunteers may sign up for one or both shifts, but Club must have a minimum of five (5) volunteers at each shift.
2. Parks agrees to waive shelter rental fee at a shelter of Club’s choice at a date to be determined between Parks and Club. The date must be after the conclusion of Adult Field Day on July 28, 2023. The date is subject to availability of shelters and current rentals.
3. Waived fees apply to the rental of the shelter ONLY. Any additional add-ons such as food, drink, decoration, etc., are the sole responsibility of the Club.
4. Although the shelter fees are waived, Club must still sign a facilities rental agreement, and submit the form to Parks prior to the Club’s shelter rental date. Parks shall provide Club with the appropriate form once parties have chosen a shelter location and date. Club is bound to all terms, agreements, and rules as listed in the rental form.
5. If Club fails to meet the expectations outlined in paragraph 1, as reasonably determined by Parks, Club forfeits the right to free shelter rental through Parks.

This Agreement, entered into on this _____ day of _____, 2023, by and between the City of Bloomington Department of Parks and Recreation (the “Department”), and Southside Rental (“Contractor”).

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, “Scope of Work”, attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before December 31, 2023 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor’s work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Bill Ream as the Department’s Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances (“Standard of Care”). The Department shall be the sole judge of the adequacy of Contractor’s work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor’s performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department’s Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed six thousand dollars (\$6,000). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Department cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be

named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights

Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification



Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

Background

In July 2020, a contract was created with Aztec Engineering for the design of the "Power Line Trail," running west from Switchyard Park under the Duke Energy power line poles for approximately .90 miles. This design contract also included the design of a missing section of Rogers St. sidewalk at Switchyard Park which was intended to be bid together as one project. Various delays with Duke infrastructure projects and county jurisdiction have added complexity to the project. The Rogers St. sidewalk received separate construction funding from the 2022 bond issue and is now ready to be bid on its own.

This contract addendum adds \$80,100 to the original contract agreed on with Aztec Engineering for the design of the Bicentennial "Power Line Trail" along the Duke easement west of Rogers St and the missing sidewalk section of Rogers St. \$50,900 will be charged to the Bicentennial Bond Series A, and \$29,200 to complete the design and bidding of the Rogers St. Sidewalk will be charged to the 2022 Parks Bond, where this project was approved.

The Rogers St. amount covers moving the Rogers St. project documents into their own bid so that project can move forward into construction, and also additional scope for Aztec to cover redesign issues on the Rogers St. sidewalk necessitated by new Duke utility poles within the project limits, including flood plain permit coordination with Indiana Department of Natural Resources. The Power Line Trail addendum amount includes scope for covering a Phase I archaeological survey, wetland delineation/investigations, and additional time on issues related to parcel boundaries and trail design for the Power Line Trail.

Recommendation

Staff recommends approval of a contract with E&B Paving for the 2023 Parks Infrastructure Improvements project.

Background

The Parks Infrastructure Improvements project includes a number of general infrastructure and asphalt improvements that have been bundled together for cost savings and bid efficiency. An invitation to bid was issued and E&B Paving was the low bidder (of two bidders) with a bid of \$412,400. Parks staff worked with E&B to value engineer \$5,000 out of the project to meet the available budget. The improvements include:

- Repairs and upgrades to the B-Line Grimes Bridge decking, as identified in a bridge engineering inspection. This will include a new vane drain at the south end of the bridge to manage stormwater flowing off of the bridge.
- Asphalt repairs to the B-Line Trail between 2nd St and the Convention Center, where root heave has caused the trail to become very uneven.
- A new 120-foot asphalt trail at Switchyard Park located behind the stage, which will formalize a path that has been worn in by foot traffic.
- Center line striping (dotted line) on every part of the B-Line trail that is not finished with pavers.
- Completing repaving efforts at Rose Hill Cemetery that began in 2022.
- Completing asphalt resurfacing and installing speed humps at the RCA Park parking lot.

AGREEMENT

BETWEEN

CITY OF BLOOMINGTON

PARKS AND RECREATION DEPARTMENT

AND

E&B PAVING, INC

FOR

2023 PARK INFRASTRUCTURE IMPROVEMENTS

THIS AGREEMENT, executed by and between the City of Bloomington, Indiana, Parks and Recreation Department through the Board of Park Commissioners (hereinafter Board), and E&B Paving, Inc. (hereinafter CONTRACTOR);

WITNESSETH THAT:

WHEREAS, CITY desires to retain CONTRACTOR'S services for **SCOPE OF WORK** (more particularly described in Attachment A, "Scope of Work"; and

WHEREAS, CONTRACTOR is capable of performing work as per his/her Bid on the Bid Summary sheet; and

WHEREAS, in accordance with Indiana Code 5-16-13 *et seq.*, incorporated herein by reference, Contractor is a Tier 1 or General Contractor for this project; and

WHEREAS, CONTRACTOR was determined to be the lowest responsible and responsive Bidder for said project.

NOW, THEREFORE, in consideration of the mutual promises hereinafter enumerated, the parties agree as follows:

ARTICLE 1. TERM

1.01 This Agreement shall be in effect upon execution of this Agreement by all parties. In accordance with Indiana Code 5-16-13 *et seq.*, incorporated herein by reference, Contractor is a Tier 1 contractor or general contractor for this project.

ARTICLE 2. SERVICES

2.01 CONTRACTOR shall complete all work required under this Agreement by December 1, 2023, unless the parties mutually agree to a later completion date. Substantial Completion shall mean completion of all work.

2.02 It is hereby understood by both parties that time is of the essence in this Agreement. Failure of CONTRACTOR to complete all work as herein provided will result in monetary damages to CITY. It is hereby agreed that CITY will be damaged for every day the work has not been performed in the manner herein provided and that the measure of those damages shall be determined by reference Section 13.00 of the General Conditions for Each Day of Overrun in Contract Time. CONTRACTOR agrees to pay CITY said damages or, in the alternative, CITY, at its sole discretion, may withhold monies otherwise due CONTRACTOR. It is expressly understood by the parties hereto that these damages relate to the time of performance and do not limit CITY's other remedies under this Agreement, or as provided by applicable law, for other damages.

2.03 CONTRACTOR agrees that no charges or claims for damages shall be made by him for any delays or hindrances, from any cause whatsoever during the progress of any portion of the services specified in the Agreement. Such delays or hindrances, if any, may be compensated for by an extension of time for a reasonable period as may be mutually agreed upon between the parties, it being understood, however, that permitting CONTRACTOR to proceed to complete any service, or any part of the services / project, after the date to which the time of completion may have been extended, shall in no way operate as a waiver on the part of CITY of any of its rights herein.

ARTICLE 3. COMPENSATION

3.01 CONTRACTOR shall provide services as specified in Attachment A, "Scope of Work", attached hereto and incorporated into this Agreement.

3.02 Upon the submittal of approved claims, CITY shall compensate CONTRACTOR in a lump sum not to exceed four hundred seven thousand four hundred dollars (\$407,400). CITY may withhold payment, in whole or in part, to the extent necessary to protect itself from a loss on account of any of the following:

Defective work.

Evidence indicating the probable filing of claims by other parties against CONTRACTOR which may adversely affect CITY.

Failure of CONTRACTOR to make payments due to subcontractors, material suppliers or employees.

Damage to CITY or a third party.

3.03 The submission of any request for payment shall be deemed a waiver and release by CONTRACTOR of all liens and claims with respect to the work and period to which such payment request pertains except as specifically reserved and noted on such request.

3.04 CONTRACTOR shall maintain proper account records for the scope of all services of this Agreement and provide an accounting for all charges and expenditures as may be necessary for audit purposes. All such records shall be subject to inspection and examination by CITY's representatives at reasonable business hours.

3.05 For projects utilizing federal funding the CONTRACTOR shall submit time sheets (WH-347) for his own and all subcontracted employees, to City Engineer or his representative for approval and review, including review for compliance with Davis Bacon requirements, if federal funds are used.

3.06 Engineer The Parks and Recreation Department Operations Director shall act as the CITY's representative and assume all duties and responsibilities and have all the rights and authority assigned to the Engineer in the Contract Documents in connection with completion of the Work in accordance with the Contract Documents.

ARTICLE 4. RETAINAGE

For contracts in excess of \$100,000 and for which Contractor requested Progressive Payments on its Bid Form, the Owner requires that retainage be held set out below.

4.01 Escrow Agent The retainage amount withheld shall be placed in an escrow account. First Financial Bank, Bloomington, Indiana, shall serve as the escrow agent.

4.02 Retainage Amount The escrow agent, Owner and Contractor shall enter into a written escrow agreement. Under that agreement, the Owner shall withhold five percent (5%) of the dollar value of all work satisfactorily completed until the Contract work is complete. The escrow agent shall invest all escrowed principal in obligations selected by the escrow agent. The escrow agent shall be compensated for the agent's services by a reasonable fee, agreed upon by the parties, that is comparable with fees charged for the handling of escrow accounts of similar size and duration. The fee shall be paid from the escrow income. The escrow agent's fee may be determined by specifying an amount of interest the escrow agent will pay on the escrowed amount, with any additional earned interest serving as the escrow agent's fee. The escrow agreement may include other terms and conditions as deemed necessary by the parties. However, if Contractor intends to receive a Single Lump Sum payment upon acceptance of this project, retainage will not be required and an Escrow Agreement will not be required.

4.03 Payment of Escrow Amount The escrow agent shall hold the escrowed principal and income until receipt of the notice from the Owner and Contractor that the Contract work has been substantially completed to the reasonable satisfaction of the Owner, at which time the Owner shall pay to the Contractor the balance to be paid under this Contract and execute such documents as are necessary to authorize the escrow agent to pay to the Contractor the funds in the escrow account, including both specifying the part of the escrowed principal to be released from the escrow and the person to whom that portion is to be released. After receipt of the notice, the escrow agent shall remit the designated part of the escrowed principal and the escrowed income, minus the escrow agent's fees, to the person specified in the notice. However, nothing in this section shall prohibit Owner from requiring the escrow agent to withhold amounts necessary to complete minor items of the Contract, following substantial completion of the Contract in accordance with the provisions of paragraph 4.04.

4.04 Withholding Funds for Completion of Contract If, upon substantial completion of the Contract, there still remains minor Contract work that needs to be completed, or minor Contract work that needs to be performed to the satisfaction of the Owner, Owner may direct the escrow agent to retain in the escrow account, and withhold from payment to the

Contractor, an amount equal to two hundred percent (200%) of the value of said work. The value of said work shall be determined by the architect/engineer. The escrow agent shall release the funds withheld under this section after receipt of notice from the Owner that all work on the Contract has been satisfactorily completed. In the event that said work is not completed by the Contractor, but by Owner or another party under contract with the Owner, said funds shall be released to the Owner.

ARTICLE 5. GENERAL PROVISIONS

5.01 CONTRACTOR agrees to indemnify and hold harmless CITY and its officers, agents, officials and employees for any and all claims, actions, causes of action, judgments and liens arising out of any negligent act or omission by CONTRACTOR or any of its officers, agents, officials, employees, or subcontractors or any defect in materials or workmanship of any supply, materials, mechanism or other product or service which it or any of its officers, agents, officials, employees, or subcontractors has supplied to CITY or has used in connection with this Agreement and regardless of whether or not it is caused in part by a party indemnified herein under. Such indemnity shall include attorney's fees and all costs and other expenses arising therefrom or incurred in connection therewith and shall not be limited by reason of the enumeration of any insurance coverage required herein.

CONTRACTOR shall indemnify and hold harmless CITY and its officers, agents, officials and employees for any and all damages, actions, costs, (including, but not limited to, attorney's fees, court costs and costs of investigation) judgments and claims by anyone for damage to property, injury or death to persons resulting from the collapse or failure of any trenches, ditches or other excavations constructed under or associated with this contract.

5.02 Abandonment, Default and Termination

5.02.01 CITY shall have the right to abandon the work contracted for in this Agreement without penalty. If CITY abandons the work described herein, CONTRACTOR shall deliver to CITY all surveys, notes, drawings, specifications and estimates completed or partially completed and these shall become the property of CITY. The earned value of the work performed shall be based upon an estimate of the proportion between the work performed by CONTRACTOR under this Agreement and the work which CONTRACTOR was obligated to perform under this Agreement. This proportion shall be mutually agreed upon by CITY and CONTRACTOR. The payment made to CONTRACTOR shall be paid as a final payment in full settlement of his services hereunder.

5.02.02 If CONTRACTOR defaults or fails to fulfill in a timely and proper manner the obligations pursuant to this Agreement, CITY may, after seven (7) days' written notice has been delivered to CONTRACTOR, and without prejudice to any other remedy it may have, make good such deficiencies and may deduct the cost thereof from the payment then or thereafter due to CONTRACTOR. In the alternative, CITY, at its option, may terminate this Agreement and take possession of the site and of all materials, equipment, tools and construction equipment and machinery thereon owned by CONTRACTOR, and may finish the project by whatever method it may deem expedient, and if the such action exceeds the unpaid balance of the sum amount, CONTRACTOR or his surety, shall pay the difference to CITY.

5.02.03 Default: If CONTRACTOR breaches this Agreement or fails to perform the work in an acceptable manner, he shall be considered in default. Any one or more of the following will be considered a default:

Failure to begin the work under this Agreement within the time specified.

Failure to perform the work with sufficient supervision, workmen, equipment and materials to insure prompt completion of said work within the time limits allowed.

Unsuitable performance of the work as determined by CITY ENGINEER or his representative.

Neglecting or refusing to remove defective materials or failure to perform anew such work as shall have been rejected.

Discontinuing the prosecution of the work or any part of it.

Inability to finance the work adequately.

If, for any other reason, CONTRACTOR breaches this Agreement or fails to carry on the work in an acceptable manner.

5.02.04 CITY shall send CONTRACTOR a written notice of default. If CONTRACTOR, or his Surety, within a period of ten (10) days after such notice, fails to remedy the default, then CITY shall have full power and authority, without violation of the Contract, to take the prosecution of the work out of the hands of said CONTRACTOR, to appropriate or use any or all materials and equipment on the ground as may be suitable and acceptable, and may, at its option, turn the work over to the Surety, or enter into an agreement with another Contractor for the completion of the Agreement according to the terms and provisions

thereof, or CITY may use such other methods as, in its opinion, shall be required for the completion of said Contract in an acceptable manner.

5.02.05 All cost of completing the work under the Contract shall be deducted from the monies due or which may become due to said CONTRACTOR. In case the expenses so incurred by CITY shall be less than the sum which would have been payable under the Contract if it had been completed by said CONTRACTOR, CONTRACTOR shall be entitled to receive the difference. However, in case such expense shall exceed the sum which would have been payable under the Contract, CONTRACTOR and his Surety will be liable and shall pay to CITY the amount of said excess. By taking over the prosecution of the work, CITY does not forfeit the right to recover damages from CONTRACTOR or his Surety for his failure to complete the work in the time specified.

5.02.06 Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of the Agreement by CITY are at any time not forthcoming or are insufficient, through failure of any entity to appropriate the funds or otherwise, then CITY shall have the right to terminate this Agreement without penalty by giving prior written notice documenting the lack of funding in which instance, unless otherwise agreed to by the parties, this Agreement shall terminate and become null and void.

5.02.07 CITY agrees that it will make its best effort to obtain sufficient funds, including but not limited to, including in its budget for each fiscal period during the term hereof a request for sufficient funds to meet its obligations hereunder in full.

5.03 Successors and Assigns

5.03.01 Both parties agree that for the purpose of this Agreement, CONTRACTOR shall be an Independent Contractor and not an employee of CITY.

5.03.02 No portion of this Agreement shall be sublet, assigned, transferred or otherwise disposed of by CONTRACTOR except with the written consent of CITY being first obtained. Consent to sublet, assign, transfer, or otherwise dispose of any portion of this Agreement shall not be construed to relieve CONTRACTOR of any responsibility of the fulfillment of this Agreement.

5.04 Extent of Agreement: Integration

5.04.01 This Agreement consists of the following parts, each of which is as fully a part of this Agreement as if set out herein:

1. This Agreement and its Attachments.
2. All Written Amendments and other documents amending, modifying, or supplementing the Contract Documents which may be delivered or issued after the Effective Date of the Agreement and are not attached hereto.
3. All Addenda to the Bid Documents.
4. The Invitation to Bidders.
5. The Instructions to Bidders.
6. The Special Conditions.
7. All plans and technical specifications as provided for the work that is to be completed.
8. The Supplementary Conditions.
9. The General Conditions.
10. The General and Technical Specifications.
11. CONTRACTOR'S submittals.
12. The Performance Bond and the Payment Bond.
13. The Escrow Agreement.
14. Request for Taxpayer Identification number and certification: Substitute W-9.

5.04.02 In resolving conflicts, errors, discrepancies and disputes concerning the Scope of Work to be performed by CONTRACTOR, and other rights and obligations of CITY and CONTRACTOR, the document expressing the greater quantity, quality or other scope of work in question, or imposing the greater obligation upon CONTRACTOR and affording the greater right or remedy to CITY shall govern; otherwise the documents shall be given precedence in the order as enumerated above.

5.05 Insurance

5.05.01

CONTRACTOR shall, as a prerequisite to this Agreement, purchase and thereafter maintain such insurance as will protect him from the claims set forth below which may arise out of or result from CONTRACTOR'S operations under this Agreement, whether such operations be by CONTRACTOR or by any SUBCONTRACTORS or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable:

5.05.02 CONTRACTOR'S comprehensive general liability insurance shall also provide coverage for the following:

Premises and operations;

Contractual liability insurance as applicable to any hold-harmless agreements;

Completed operations and products; which also must be maintained for a minimum period of two (2) years after final payment and CONTRACTOR shall continue to provide evidence of such coverage to CITY on an annual basis during the aforementioned period;

Broad form property damage - including completed operations;

Fellow employee claims under Personal Injury; and

Independent Contractors.

5.05.03 With the prior written approval of CITY, CONTRACTOR may substitute different types or amounts of coverage for those specified as long as the total amount of required protection is not reduced.

5.05.04 Certificates of Insurance showing such coverage then in force (but not less than the amount shown above) shall be on file with CITY prior to commencement of work. These Certificates shall contain a provision that coverage afforded under the policies will not be canceled or non-renewed until at least sixty (60) days' prior written notice has been received by CITY. The CITY shall be named as an additional insured on the Commercial General Liability, Automobile Liability, and Umbrella Excess Liability policies. The CONTRACTOR shall agree to a waiver of subrogation on its Worker's Compensation policy.

5.06 **Necessary Documentation** CONTRACTOR certifies that it will furnish CITY any and all documentation, certification, authorization, license, permit or registration required by the laws or rules and regulations of the City of Bloomington, the State of Indiana and the United States. CONTRACTOR further certifies that it is now and will maintain in good standing with such governmental agencies and that it will keep its license, permit registration, authorization or certification in force during the term of this Agreement.

5.07 Applicable Laws CONTRACTOR agrees to comply with all federal, state, and local laws, rules and regulations applicable to CONTRACTOR in performing work pursuant to this Agreement, including, but not limited to, discrimination in employment, prevailing wage laws, conflicts of interest, public notice, accounting records and requirements. This Agreement shall be governed by the laws of the United States, and the State of Indiana, and by all Municipal Ordinances and Codes of the City of Bloomington. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

5.08 Non-Discrimination

5.08.01 CONTRACTOR and subcontractors shall not discriminate against any employee or applicant for employment, to be employed in the performance of this Agreement, with respect to hire, tenure, terms, training, conditions or privileges of employment, because of race, sex, color, religion, national origin, ancestry, disability, sexual orientation, gender identity, veteran status or housing status. Breach of this covenant may be regarded as a material breach of the Agreement.

5.08.02 CONTRACTOR certifies for itself and all its subcontractors compliance with existing laws of the City of Bloomington, the State of Indiana and the United States regarding:

Prohibition of discrimination in employment practices on the basis of race, sex, color, religion, national origin, ancestry, disability, sexual orientation, gender identity, veteran status, housing status, or any other legally protected classification;

The utilization of Minority and Women Business Enterprises. CONTRACTOR further certifies that it:

- a. Has formulated its own Affirmation Action plan for the recruitment, training and employment of minorities and women, including goals and timetable; which has been approved by the City's Contract Compliance Officer.
- b. Encourages the use of small business, minority-owned business and women-owned business in its operations.

5.08.03 FURTHER, PURSUANT TO INDIANA CODE 5-16-6-1, CONTRACTOR AGREES:

- A) That in the hiring of employees for the performance of work under this Agreement or any sub agreement hereunder, no contractor, or subcontractor, nor any person acting on behalf of such CONTRACTOR or subcontractor, shall by reason of race, sex, color, religion, national origin, ancestry, or any other legally protected classification, discriminate against any citizen of the State of Indiana who is qualified and available to perform the work to which the employment relates.
- B) That no contractor, subcontractor, or any person on their behalf, shall, in any manner, discriminate against or intimidate any employee hired for performance of work under this Agreement on account of race, religion, color, sex, national origin, ancestry, or any other legally protected classification.
- C) That there may be deducted from the amount payable to CONTRACTOR, by CITY, under this Agreement, penalty of Five Dollars (\$5.00) for each person for each calendar day during which such person was discriminated against or intimidated in violation of the provisions of this Agreement. Any such person discriminated against retains the right to file a discrimination complaint with the appropriate civil rights agency or court.
- D) That this Agreement may be canceled or terminated by CITY and all money due or to become hereunder may be forfeited, for a second or any subsequent violations of the terms or conditions under this section of the Agreement.

5.09 Workmanship and Quality of Materials

5.09.01 CONTRACTOR shall guarantee the work for a period of one (1) year from the date of substantial completion. Failure of any portion of the work within one (1) year due to improper construction, materials of construction, or design may result in a refund to CITY of the purchase price of that portion which failed or may result in the forfeiture of CONTRACTOR's Performance Bond.

5.09.02 SUBSTITUTION: Whenever material or equipment is submitted for approval as being equal to that specified, the submittal shall include sufficient information and data to demonstrate that the material or equipment conforms to the Contract requirements. The decision as to whether or not such material or equipment is equal to that specified shall be made by the ENGINEER. The approval by the ENGINEER of alternate material or equipment as being equivalent to that specified, shall not in any way relieve CONTRACTOR of responsibility for failure of the material or equipment due to faulty design, material, or workmanship, to perform the function required by the Contract Documents. Specifications as determined by other entities within the City of Bloomington such as City Utilities shall only be substituted or changed by their approval which shall be submitted in writing to the ENGINEER.

5.09.03 CITY shall be the sole judge of the sufficiency of workmanship and quality of materials. Disputes shall be resolved by the City Engineer and are not subject to arbitration.

5.10 Safety. CONTRACTOR shall be responsible for the safety of employees at all times and shall provide all equipment necessary to insure their safety. CONTRACTOR shall ensure the enforcement of all applicable safety rules, regulations, ordinances and laws, whether federal, state or local. Contractor’s Superintendent of Safety shall make daily inspections upon the arrival and leaving of the site at the close of each workday.

5.10.01 CONTRACTOR is required to comply with IOSHA regulations 29 C.F.R 1926, Subpart P, Excavations for all trenches of at least five (5) feet in depth. All cost for trench safety systems shall be the responsibility of the CONTRACTOR and included in the cost of the principal work with which the safety systems are associated. CONTRACTOR shall sign an affidavit, attached as Attachment B, affirming that CONTRACTOR shall maintain compliance with IOSHA requirements for excavations of at least five (5) in depth.

5.11 Amendments/Changes

5.11.01 Except as provided in Paragraph 5.11.02, this Agreement may be amended only by written instrument signed by both CITY and CONTRACTOR.

5.11.02 Without invalidating the Agreement and without notice to any surety, CITY may, at any time or from time to time, order, in writing, additions, deletions, or revisions in the work. Upon receipt of any such document, CONTRACTOR shall promptly proceed with the work involved, which will be performed under the applicable conditions of the Agreement Documents.

5.11.03 If CONTRACTOR believes that any direction of CITY under paragraph 5.11.02, or any other event or condition, will result in an increase in the Contract time or price, he shall file written notice with CITY no later than twenty (20) calendar days after the occurrence of the event giving rise to the claim and stating the general nature of the claim with supporting data. No claim for any adjustment of the Contract time or price will be valid if not submitted in accordance with this Paragraph.

5.11.04 CONTRACTOR shall carry on the work and adhere to the progress schedule during all disputes or disagreements with CITY. No work shall be delayed or postponed pending resolution of any dispute or disagreement except as CONTRACTOR and CITY may otherwise agree in writing.

5.12 Performance Bond and Payment Bond

5.12.01 For contracts in excess of \$100,000, CONTRACTOR shall provide CITY with a Performance Bond and a Payment Bond in the amount of one hundred percent (100%) of the contract amount.

5.12.02 Failure by CONTRACTOR to perform the work in a timely or satisfactory fashion may result in forfeiture of CONTRACTOR’S Performance Bond.

5.12.03 If the surety on any bond furnished by CONTRACTOR becomes a party to supervision, liquidation, or rehabilitation action pursuant Indiana Code 27-9 et seq. or its right to do business in the State of Indiana is terminated, CONTRACTOR shall, within thirty (30) calendar days thereafter, substitute another bond and surety, both of which must be acceptable to CITY.

5.13 Payment of Subcontractors CONTRACTOR shall pay all subcontractors, laborers, material suppliers and those performing services to CONTRACTOR on the project under this Agreement. CITY may, as a condition precedent to any payment hereunder, require CONTRACTOR to submit satisfactory evidence of payments of any and all claims of subcontractors, laborers, material suppliers, and those furnishing services to CONTRACTOR. Upon receipt of a lawful claim, CITY shall withhold money due to CONTRACTOR in a sufficient amount to pay the subcontractors, laborers, material suppliers, and those furnishing services to CONTRACTOR.

5.13.01 The surety of the Payment Bond may not be released until one (1) year after the Board’s final settlement with the CONTRACTOR.

5.14 Written Notice Written notice shall be considered as served when delivered in person or sent by mail to the individual, firm, or corporation, or to the last business address of such known to CONTRACTOR who serves the Notice. Notice shall be sent as follows:

5.15 Severability and Waiver In the event that any clause or provision of this Agreement is held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not affect any other provision of this Agreement. Failure of either party to insist on strict compliance with any provision of this Agreement shall not constitute waiver of that party's right to demand later compliance with the same or other provisions of this Agreement.

5.16 Notice to Proceed CONTRACTOR shall not begin the work pursuant to the "Scope of Work" of this Agreement until it receives an official written Notice to Proceed from the City. Contractor shall start active and continuous work on the Agreement within fifteen (15) calendar days after the date of the Notice to Proceed. In no case shall work begin prior to the date of the Notice to Proceed. If a delayed starting date is indicated in the proposal, the fifteen (15) calendar day limitation will be waived. Work day charges will then begin on a date mutually agreed upon, but not later than the delayed starting date specified. In the event that any Agreement is canceled after an award has been made but prior to the issuing of the Notice to Proceed, no reimbursement will be made for any expenses accrued relative to this contract during that period.

5.17 Steel or Foundry Products

5.17.01 To comply with Indiana Code 5-16-8, affecting all contracts for the construction, reconstruction, alteration, repair, improvement or maintenance of public works, the following provision shall be added: If steel or foundry products are to be utilized or supplied in the performance of any contract or subcontract, only domestic steel or foundry products shall be used. Should CITY feel that the cost of domestic steel or foundry products is unreasonable; CITY will notify CONTRACTOR in writing of this fact.

5.17.02 Domestic Steel products are defined as follows:

"Products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two (2) or more of such operations, from steel made in the United States by open hearth, basic oxygen, electric furnace, Bessemer or other steel making process."

5.17.03 Domestic Foundry products are defined as follows:

"Products cast from ferrous and nonferrous metals by foundries in the United States."

5.17.04 The United States is defined to include all territory subject to the jurisdiction of the United States.

5.17.05 CITY may not authorize or make any payment to CONTRACTOR unless CITY is satisfied that CONTRACTOR has fully complied with this provision.

5.18 Verification of Employees' Immigration Status

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Attachment B, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code Chapter 12 or by the U.S. Attorney General.

Contractor and any of its subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or any of its subcontractors learns is an unauthorized alien. If the City obtains information that the Contractor or any of its subcontractors employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or its subcontractors of the Agreement violation and require that the violation be remedied within thirty (30) calendar days of the date of notice. If the Contractor or any of its subcontractors verify the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or its subcontractor did not knowingly employ an unauthorized alien. If the Contractor or its subcontractor fails to remedy the violation within the thirty (30) calendar day period, the City shall terminate the Agreement, unless the City determines that terminating the Agreement would be detrimental to the public interest or public property, in which case the City may allow the Agreement to remain in effect until the City procures a new contractor. If the City terminates the Agreement, the Contractor or its subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this Agreement to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the

subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of this Agreement with the City.

5.19 Drug Testing Plan

In accordance with Indiana Code 4-13-18 as amended, the CONTRACTOR was required to submit with his/her bid a written drug testing policy for a public works project that is estimated to cost \$150,000 or more. Among other things, the law sets forth specific requirements that must be in the plan for a program to test the employees of the CONTRACTOR and Subcontractors for drugs. The successful CONTRACTOR must comply with all provisions of the statute. This contract is subject to cancellation if CONTRACTOR fails to implement its testing program during the term of this contract, fails to provide information regarding this testing at the request of CITY; or provides false information to CITY regarding CONTRACTOR's employee drug testing program. CONTRACTOR shall sign an affidavit, attached as Attachment C, affirming that CONTRACTOR has and shall implement CONTRACTOR'S employee drug testing program throughout the term of this project.

5.20 Non-Collusion

CONTRACTOR is required to certify that it has not, nor has any other member, representative, or agent of CONTRACTOR, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. CONTRACTOR shall sign an affidavit, attached hereto as Exhibit D, affirming that CONTRACTOR has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

5.21 Living Wage Ordinance

Contractor is considered a "covered employer" under City Ordinance 2.28, otherwise known as the "Living Wage Ordinance," or "LWO," and is required to pay their covered employees at least a living wage. Currently, the living wage is \$15.29 per hour for covered employees, and up to 15% of that amount, or \$2.29, may be in the form the covered employer's contribution to health insurance available to the covered employee.

Contractor shall execute the Living Wage Ordinance Affidavit, attached as Exhibit E; shall abide by the LWO by paying their employees a living wage; and shall post the Living Wage Poster, provided by the City Legal Department, in areas frequented by their covered employees.

Background

Earlier this year, Parks staff were looking at replacing the lower picnic shelter at Building Trades Park. However, replacing and potentially relocating the shelter raise a host of other questions about location and accessibility within the park. Along with these questions, aging park infrastructure, increased anticipated use from the development of the Hopewell neighborhood, a need for updated accessibility north-south across the park, and the development of the Second St. protected bike lanes are all issues facing the park. An updated master plan will help plan for the park's future serving these neighborhoods.

This Agreement, entered into on this ____ day of _____, 2023, by and between the City of Bloomington Department of Parks and Recreation (the “Department”), and Mader Design, LLC (“Contractor”),

WITNESSETH:

WHEREAS, the Department wishes to create a new master plan for Building Trades Park; and

WHEREAS, the Department requires the services of a professional landscape designer to create concepts, organize public feedback, and create the master plan (the “Services” as further defined below); and

WHEREAS, it is in the public interest that such Services be undertaken and performed; and

WHEREAS, Contractor is willing and able to provide such Services to the Department.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, “Scope of Work”, attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before June 30, 2024 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor’s work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Tim Street as the Department’s Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances (“Standard of Care”). Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work,

and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed thirty six thousand dollars and no cents (\$36,500). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Mader Design of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Contractor cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall indemnify, and hold harmless the City of Bloomington, the Department, and the officers and employees of the City and the Department from damages, costs, expenses or other liability to the extent resulting from the reckless or negligent performance of Contractor's professional services, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims").

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees of each shall be included as additional insureds under the General Liability and Automobile policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

Article 28. Living Wage Ordinance.


Contractor is considered to be a "covered employer" under City Ordinance 2.28, otherwise known as the "Living Wage Ordinance," or "LWO," and is required to pay their covered employees at least a living wage. Currently, the living wage is \$15.29 per hour for covered employees, and up to 15% of that amount, or \$2.29, may be in the form the covered employer's contribution to health insurance available to the covered employee.

Contractor shall execute the Living Wage Ordinance Affidavit, attached as Exhibit E; shall abide by the LWO by paying their employees a living wage; and shall post the Living Wage Poster, provided by the City Legal Department, in areas frequented by their covered employees.

Dear Tim,

Thank you for selecting Mader Design to submit this Letter of Agreement for the landscape architecture services for the Building Trades Park Master Plan for updates to the park between Howe and 2nd Streets in Bloomington (Project) between the Bloomington Parks & Recreation Department (Owner) and Mader Design LLC (Landscape Architect).

Project Scope

Per our web meeting and email correspondence, the Project will focus on a long term master plan for the redevelopment of the Building Trades Park. The area is undergoing rapid redevelopment of the former hospital site south of the Park focused on commercial and multifamily housing, with stable residential neighborhoods surrounding the rest of the park. We anticipate working closely with park and city staff for input and direction through the planning process. We also plan to facilitate a public meeting early in the process to elicit input regarding potential amenities/facilities/uses to incorporate into the park. A second public meeting will be held to present the final draft of the plan. We will facilitate three stakeholder meetings as part of the process to review and provide input into progress plans developed throughout the master plan process.

The plan is anticipated to include both short term improvements as well as long term phasing opportunities. Primary considerations are the removal and replacement/relocation of the picnic shelter, improving accessibility north/south through the park, and re-use opportunities for the existing hard-court area. Longer term considerations could include relocating parking and playground areas, updates to existing facilities within the park, and additions of other park amenities that will be determined through public, stakeholder, and staff input through the planning process. Considerations will be made throughout the process for meeting the needs of the existing surrounding neighborhood while also planning for improvements that will service the new commercial and residential developments occurring at the former hospital site.

Scope/Process

Our proposed process includes:

1. Review previous and current planning efforts for adjacent redevelopment, current department wide master plan, and assess current conditions within the park and surrounding neighborhoods.
2. Receive City GIS information for the park site in AutoCAD format for development of base drawings for site assessment, planning, and design of Master Plan.
3. Conduct Kickoff meeting and periodic progress meetings with Park Staff and/or Master Plan Stakeholders Committee, including 3-5 representatives of the department, administration, elected or appointed officials, and/or members of the public.
4. Visit Park site to review existing conditions with Park representatives.
5. Develop site assessment of existing conditions, opportunities/constraints, etc.
6. Begin a preliminary list/program potential of park uses and amenities considering site assessment, with recommendations for potential, maybe, and not feasible designations.
7. Facilitate public meeting with Park Staff to present Site Assessment, and preliminary program of park uses to gather input and feedback from the public regarding their wishes for development within the park.
8. With Public and Park Staff input, develop 2-3 preliminary concept plans for the park along with some concepts for theme and aesthetics.
9. Meet with Park Staff and stakeholders (as appropriate) to review concepts for feedback and input.
10. Refine to 1 or 2 concepts based on feedback, and hone in on more refined theme and aesthetic. Refine areas/uses/amenities level of detail.

11. Meet with Park Staff and stakeholders to review concepts for feedback and input, receive direction for final direction of master plan.
12. Refine final concept based on feedback, refine master plan level park amenities and uses, refine aesthetic and precedent references and imagery.
13. Meet with Stakeholders to review draft master plan for technical input and additional community insight.
14. Facilitate Public meeting to present final draft of the master plan.
15. Develop final graphic master plan for the park with notes and precedent images/concept sketches representing design ideas and improvements proposed for the park.
16. Develop Master Plan booklet, anticipating a master plan narrative, master plan level budget, proposed phasing, and graphics.
17. Provide to Owner for final review, and provide edits/updates as appropriate.
18. Lead approximately 6 progress meetings with Park staff.
19. Facilitate 2-3 Stakeholder meetings to engage appropriate city/county departments, elected/appointed officials, and other interested city officials and community leaders.
20. Provide to Owner for final presentation to the Park Board and City for approval and adoption.
21. Provide PDF file of final document and graphics, and 2 final hard copies. Additional printing shall be completed by Owner, or shall be considered an additional Reimbursable Expense if printed by Landscape Architect.

Assumptions

1. All information related to the Project provided by Owner or others is assumed to be true and accurate.
2. Owner shall provide GIS mapping with aerial photography in CAD or digital image format for use as base plan. It is not anticipated for Landscape Architect to perform field verification or develop base plans for this work. If not available in CAD, we will use PDF's or other Imagery available from sources available on the internet.
3. Detailed Design work and development of construction documents will be required as future projects are initiated, but are not anticipated within this scope of work.
4. Landscape Architect shall not be responsible for determining if any areas on site are environmentally sensitive (i.e. underground tanks, asbestos materials, etc...) or may require special environmental permitting.
5. The following services are not included in the Scope of Work and Fee for Basic Services, but can be provided as Additional Services:
 - o Zoning approvals, variances, or rezoning efforts beyond Administrative Review.
 - o Obtaining Improvement Location and/or Building Permits, regulatory reviews for local, county, or state agencies.
 - o Detailed design, construction documents or design efforts beyond Master Planning.
 - o Detailed cost estimating.
 - o Civil Engineering, Architectural, MEP Engineering, or Environmental reviews.

Project Schedule

A mutually agreeable work plan and overall project schedule shall be developed as the Project commences.

Professional Fees

The design fees for Landscape Architecture Services are proposed to be a lump sum of **\$36,500** billed monthly based on work completed to date.

Reimbursables

Expenses for mileage and basic printing for Owner and Public meetings, and 2 final booklets are included in the Fees listed above. Mileage for additional trips or printing of graphics, boards, or booklets shall be considered Reimbursable Expenses, which are expenditures for the Project made by the Landscape Architect in the interest of the Project.

Additional Services

If Additional Services are requested during the course of the project, a revised fee will be submitted for approval. For services not included in this Agreement, Additional Compensation shall be a negotiated lump sum or computed using the hourly rates indicated in the attached Terms & Conditions.

Contract Form

This Letter of Agreement and attached Terms and Conditions shall be utilized as the Contract for this scope of work.

Please keep one copy of this Letter of Agreement for your records, and return one signed copy to our office. We will begin work on the project upon receipt of this executed Agreement or written Notice to Proceed indicating method of Contract.

Recommendation

Staff recommends approval of a lease extension agreement with The Project School for a period running through June 30, 2029.

Background

The Project School signed the original lease with the City of Bloomington for 349 S. Walnut St. in April 2009. The lease ran for ten years, then was extended another five years to run through June 30, 2024. Per the terms of the original lease agreement, The Project School recently notified the City that they would like to exercise the option to renew for a second five-year term beginning on July 1, 2024 and ending on June 30, 2029. The annual rent during the last year of the 2019-2024 lease extension was \$95,297.51. The rent under this second lease extension will be increased annually, by the lesser amount of two percent (2%) or the consumer price index for the preceding twelve months. All other terms of the original lease remain in effect.

This Second Extension of Lease Agreement ("Second Extension"), entered into this ____ day of _____, 2023, by and between the City of Bloomington Parks and Recreation Department and The Project School.

Witnesseth:

Whereas, the City of Bloomington Department of Parks and Recreation, by its Board of Parks Commissioners ("Landlord") and The Project School ("Tenant") first entered into a lease ("Original Lease") for the property located at 349 S. Walnut, Bloomington, Indiana beginning on April 21, 2009; and

Whereas, the initial term of the Original Lease began on April 21, 2009 and ended on June 30, 2019; and

Whereas, the Original Lease provided the opportunity to extend the initial term by two additional five-year terms; and this was later modified to allow for additional terms in the Second Amendment to the Lease Agreement; and

Whereas, the parties agreed to Amendment Number 3 to the Original Lease on October 11, 2010, providing that the rental amounts for the first and second extended terms would be \$88,125.00 annually, plus the lesser amount of the consumer price index or two percent, adjusted annually;

Whereas, the parties agreed to extend the Original Lease, as amended, by one additional five-year term, beginning on July 1, 2019, and ending on June 30, 2024; and

Whereas, in compliance with Amendment Number 3, the annual rental amount was adjusted annually during the first five-year extension; and

Whereas, the parties wish to extend the Original Lease, as amended, by a second five-year term, beginning on July 1, 2024, and ending on June 30, 2029; and

Whereas, the rental amount shall continue to be adjusted annually in compliance with Amendment Number 3.

Now, therefore, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Original Lease, as amended, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to extend the Original Lease, as amended, as follows:

TERM: The extended term shall begin on July 1, 2024, and will end on June 30, 2029.

FUTURE RENT ADJUSTMENTS: The annual rent during the last year of the 2019-2024 lease extension was \$95,297.51. The rent under this second lease extension will be increased annually, by the lesser amount of two percent (2%) or the consumer price index for the preceding twelve months. Parties agree that a negative CPI shall not be applied to annual rent and in no event shall rent decrease from year to year.

All other terms of the Original Lease, as amended by Amendments Number 1, dated June, 2009; Number 2, dated August, 2009 and Number 3, dated October 11, 2010, remain in effect.

LEASE AGREEMENT

BY THIS LEASE AGREEMENT (this "Lease"), the City of Bloomington Department of Parks and Recreation by its Board of Park Commissioners, ("Landlord"), and the Bloomington Project School ("Tenant"), in consideration of their mutual undertakings, agree as follows:

ARTICLE I **LEASE OF THE PREMISES**

Section 1.1 The Premises. Landlord, for the term and subject to the provisions and conditions hereof leases to Tenant, and Tenant rents from Landlord, the space (hereinafter referred to as "Premises") delineated on the floor plans attached hereto as Exhibit "A" within the building commonly known as the Bloomington Adult Community Center, located at 349 S. Walnut Street, Bloomington, Monroe County, Indiana, the legal description of which is attached as Exhibit "B" (the "Building").

ARTICLE II **TERM AND POSSESSION**

Section 2.1 Initial Term. The "Initial Term" of this Lease shall commence on April 21, 2009 and shall end on June 30, 2019, unless sooner terminated as herein provided. Notwithstanding the foregoing, Tenant's obligation to begin paying rent, as contemplated by Article IV of this Lease, shall commence on July 1, 2009.

Section 2.2 Options to Extend. Upon the expiration of the Initial Term, if Tenant is not then in default, Landlord hereby grants to Tenant the right to extend the term of this Lease for two (2) additional terms of five (5) years each (each an "Extended Term") and together with the Initial Term, the "Term"). The Tenant shall exercise its options to extend this Lease by giving written notice to Landlord as provided in this Lease on or before the date that is fourteen (14) months prior to the last day of the Initial Term or the then current Extended Term, as the case may be. The parties agree that they may negotiate a potential purchase of the Building by Tenant at the end of the Initial Term and any Extended Terms, or the inclusion of an option to purchase in this Lease during the then following Extended Term, such negotiations to begin at least fourteen (14) months prior to the last day of the Initial Term or the then current Extended Term, as the case may be. No such option to purchase exists during the Initial Term. The rent payable by Tenant to Landlord during any Extended Term shall be determined as set forth in Section 4.4 of this Lease. If Tenant fails to give written notice of extension to Landlord within the time specified, or if this Lease is terminated, any subsequent options to extend shall expire and be of no force or effect. The exercise of any option to extend shall be ineffective if Tenant is in default on the last day of the prior term.

Section 2.3 Lease Year and Partial Year Defined. The term "Lease Year" means a period of twelve (12) consecutive calendar months, beginning on July 1 and

ending on June 30. The first full Lease Year commences on July 1, 2009 and ends on June 30, 2010. Each succeeding full Lease Year shall commence upon the anniversary date of the first day of the first full Lease Year.

Section 2.4 Holding Over. Tenant shall pay to Landlord for each day Tenant retains possession of all or a part of the Premises after Termination or expiration of this Lease a sum equal to fifteen percent (15.0%) of the monthly rent for the last period prior to the date of such termination or expiration. In addition, Tenant shall pay Landlord for all damages sustained by Landlord by reason of such retention, or, if Landlord gives notice to Tenant of Landlord's elections, such holding over shall constitute renewal of this Lease for any period chosen by Landlord, not to exceed one year. If Landlord does not so elect, acceptance by Landlord of rent after termination or expiration shall not constitute a renewal or extension of this Lease, this provision shall not constitute a renewal or extension of this Lease, and this provision shall not be deemed to waive Landlord's right of re-entry or any other right under this Lease or at law.

Section 2.5 Possession. Landlord shall deliver possession of the Premises to Tenant no later than April 21, 2009. Tenant agrees that in the event of inability of Landlord to deliver possession of the Premises on April 21, 2009, Landlord shall not be liable for any damage thereby nor shall this Lease be void or voidable, but Tenant shall not be liable for any rent until Landlord delivers possession of the Premises to Tenant. The act of Tenant or Tenant's representatives taking possession of the Premises shall be conclusive evidence that the Premises are in satisfactory condition for occupancy.

ARTICLE III OCCUPANCY AND USE

Section 3.1 Occupancy. Tenant shall use and occupy the Premises solely for the operation of a charter school, as authorized by Indiana Code 20-24-1-1 *et seq.*, and for no other use or purpose without the Landlord's prior written consent, which consent may be withheld at Landlord's sole discretion.

Tenant and Tenant's employees, students, and invitees shall be permitted to use the parking lot to the east of the Building and north of Smith Avenue. Said parking lot is located behind the alley which runs north and south at the east side of the Building.

Section 3.2 Use of Premises – Rules and Regulations. Tenant shall be solely responsible for maintaining compliance with applicable federal, state and local laws and regulations which are applicable to the administration and operation of its program.

Tenant shall use the Premises for no unlawful purpose or act; shall commit or permit no waste or damage to the Premises; shall comply with and obey all laws, regulations, and orders of any governmental authority or agency, and all reasonable directions of the Landlord. Landlord shall not be responsible to Tenant for the nonperformance of any of the rules and regulations of Landlord.

Section 3.3 Use of Premises – Parks & Facilities Policies. The Premises are one of the facilities of the Bloomington Parks and Recreation Department overseen by its

Board of Park Commissioners which provides citizens with the unique opportunity to experience the benefits of recreation and leisure pursuits. Tenant agrees that the Premises may be used by others designated and approved by Landlord for activities in the evenings, on weekends, and school breaks when the Premises are not needed by the Tenant for its own activities, provided that Tenant receives for such use fees that are commensurate with those paid to other schools within the Monroe County Community School District for similar uses, that the person or entity engaged in such use, or the Landlord, as appropriate, shall have adequate insurance coverage for claims that could arise from such use, and that the person or entity engaged in such use, or the Landlord, as appropriate, shall return the Premises to the condition existing prior to such use and agrees to indemnify, defend and hold harmless Tenant from and against any and all claims and damages of any kind resulting from or related to such use. In the event that advance scheduling is required, the following priority system shall be utilized:

- 1st Priority – Tenant's sponsored activities;
- 2nd Priority – Landlord's sponsored activities;
- 3rd Priority – Landlord's partnership agency activities; and
- 4th Priority – Independent activities.

ARTICLE IV

RENT AND SECURITY DEPOSIT

Section 4.1 Rent During Initial Term. Tenant agrees to pay Seven Hundred Eighty Thousand Dollars ("780,000.00") as rent to Landlord during the Initial Term. Tenant shall comply with Section 4.2 below regarding rental payments made during Lease Years One (1) and Two (2). Tenant agrees to increase the amount paid as rent to Landlord in Lease Years Three (3) through Ten (10), as described in Section 4.3.

Section 4.2 Rent During Lease Years One (1) and Two (2). During Lease Year One (1), Tenant agrees to pay Thirty Thousand Dollars (\$30,000.00) with payments of Two Thousand Five Hundred Dollars (\$2,500.00) per month by Tenant to Landlord. During Lease Year Two (2), Tenant agrees to pay Forty-Five Thousand Dollars (\$45,000.00) with payments of Three Thousand Seven Hundred Fifty Dollars (\$3,750.00) per month by Tenant to Landlord. Payments shall be made by Tenant to Landlord by the first (1st) day of each calendar month.

Section 4.3 Rent During Lease Years Three (3) Through Ten (10). Tenant shall pay rent to Landlord during the Lease Years Three (3) through Ten (10) according to the following schedule.

Section 4.4 Rent During Any Extended Term. Should Tenant elect to extend the term of this Lease as described in Section 2.2, the rent payable by Tenant to Landlord during any such Extended Term shall be negotiated by the parties. Within sixty (60) days of receipt by Landlord of Tenant's written notice of its election to extend the term of the Lease, Landlord and Tenant shall begin said negotiations.

Section 4.5 Security Deposit. A security deposit of Ten Thousand Dollars (\$10,000.00) shall be required. In the event a claim is made upon the City's insurance for any incident related to the Premises during the Initial Term or any extension thereof, Landlord shall be entitled to use this security deposit for Landlord's related expenses, including but not limited to insurance deductibles. Said security deposit shall be paid within ninety (90) days of the Commencement Date of this Lease.

Section 4.6 Place for Payment of Rent. All rent shall be payable to Landlord or to such other person or place as the Landlord may designate in writing at the following address.

Section 4.7 Late Charges. In the event any installment of rent is paid later than ten (10) days after it is due, a late charge equal to Three percent (3%) of the amount of such shall be assessed by the Landlord against Tenant for the delinquent installment. An additional late charge shall be charged for each month that the delinquency continues.

ARTICLE V

REPAIRS AND IMPROVEMENTS

Section 5.1 Landlord's Obligations. Landlord shall keep the foundation, exterior walls and structural components of the Building in good condition and repair and make such modifications or replacements thereof as may be necessary or required by law or ordinance. Subject to Section 9.3 of this Lease, any maintenance, repairs or replacements to the foundation, walls, and structural components of the Building made necessary by any acts or negligence of Tenant shall be paid for by Tenant. Landlord reserves and at all time shall have the right to re-enter the Premises in any emergency, and also during regular business hours upon reasonable notice to Tenant, to inspect the same, and to alter, improve, or repair the Premises and any portion of the Building.

Section 5.2 Tenant's Obligations. Subject to Section 9.3 of this Lease, all maintenance, repairs, or replacements relating to the Premises that are not the obligation

of the Landlord, including maintenance and repair of the roof and HVAC system for the Premises, shall be the obligation of the Tenant and shall be made by Tenant at Tenant's sole cost and expense, and Tenant shall maintain the Premises in a manner commensurate with a first class school building in the Bloomington, Indiana area. The covenants of repair herein by Tenant shall be subject to any warranties of contractors given in connection with Tenant's build out of the Premises.

Section 5.3 Tenant Improvements. As of the date of this Lease, Tenant has submitted to Landlord and Landlord has approved those plans for improvement and addition to the Premises and the Building attached hereto as Exhibit "C" (the "Tenant Improvements"). Landlord acknowledges that Tenant intends to complete the Tenant Improvements prior to the start of Tenant's school year 2009 and that possession on or before April 21, 2009, prior to commencement of Tenant's obligation to begin paying rent, is a necessary accommodation to Tenant to enable such a completion date.

Any additional improvements or alterations to the Premises or Building, other than those shown on Exhibit C attached hereto, shall be approved by Landlord before said additional improvements or alterations are made.

Section 5.4 Cooperation. Landlord agrees to cooperate with and support Tenant in Tenant's negotiations with various governmental agencies and officials for the acquisition of funding for Tenant's Improvements.

ARTICLE VI

INSPECTION BY LANDLORD

Section 6.1 Inspection by Landlord. Tenant shall permit Landlord or Landlord's agents, representatives or employees to enter said Premises at all reasonable times and with reasonable notice for the purpose of inspecting said Premises to determine whether Tenant is complying with the terms of this Lease and for the purpose of doing other lawful acts that may be necessary to protect Landlord's interest in said Premises under this Lease or to perform Landlord's duties under this Lease.

ARTICLE VII

LIENS

Section 7.1 Liens. Tenant shall keep the Premises and the Building free from any liens created or suffered by Tenant, including but not limited to mechanics' and materialmen's liens. In the event any lien is filed against the Premises or the Building by virtue of an act or failure to act on the part of the Tenant, Landlord shall have the right, but no obligation to pay the amount of such lien, to cause its release, and such amount shall be considered additional rent to be paid to Landlord by Tenant on demand with interest at Eighteen percent (18%) per year from date of payment by Landlord of the lien. All liens and encumbrances created or suffered by Tenant shall attach to Tenant's interest only.

Section 7.2 Letter of Credit. Before Tenant commences work on Tenant's Improvements, Tenant shall provide Landlord with a letter of credit in the amount of Seven Hundred Fifty Thousand Dollars (\$750,000.00) (the "Letter of Credit"), with a lender and upon terms and conditions satisfactory to Landlord, granting to Landlord the right to draw on the Letter of Credit in order to complete the Tenant's Improvements as shown on Exhibit C to this Lease.

ARTICLE VIII ASSIGNMENT AND SUBLETTING

Section 8.1 Assignment. Tenant shall not assign this Lease or any interest therein without the Landlord's prior written consent. Any such assignment shall not release Tenant from liability for the performance of terms and conditions contained herein.

Section 8.2 Subletting. Tenant shall not have the right to sublet the Premises without the prior written consent of Landlord. No such subletting, if approved by the Landlord, shall release Tenant from its obligation hereunder.

ARTICLE IX INDEMNITY, INSURANCE, AND WAIVER OF SUBROGATION

Section 9.1 Indemnity. Subject to Section 9.3 of this Lease, Tenant shall indemnify and hold Landlord harmless from and against any and all claims arising from Tenant's lease or use of the Premises, or from the conduct of Tenant or Tenant's agent or from any activity, work or thing done, permitted to be done by Tenant or Tenant's agent in or about the Premises. Subject to Section 9.3 of this Lease, Tenant shall further indemnify and hold Landlord harmless from and against any and all claims arising from any breach or default in the performance of any obligation on Tenant's part to be performed under the terms of this Lease, or arising from any negligence of Tenant, or any of Tenant's agents, contractors or employees, and from and against all costs, attorneys' fees, expenses and liabilities incurred in the defense of any claim or any act in or proceeding brought thereon.

Section 9.2 Insurance. Tenant shall cause its insurer(s) to furnish to Landlord certificates evidencing the insurance required to be maintained hereunder and stating that no policy change or cancellation will be made without giving thirty (30) days notice to Landlord or Landlord's designee.

Tenant agrees that any contractors selected by Tenant to perform the Tenant Improvements to the Building shall be fully licensed, to the extent required by state or county or local law or ordinance, and bonded in the State of Indiana and shall provide evidence of same to Landlord.

At all times during the Initial Term or any extension thereof, Landlord shall maintain in force and effect, at its cost and expense, a policy or policies providing fire and extended coverage insurance on the Building, including the Premises, with the limits

of such coverage to be the actual replacement cost of the Building at an agreed value determined annually. Tenant shall be solely responsible for securing a policy or policies providing coverage for damage or loss of Tenant's personal property, equipment, trade fixtures or furniture. Notwithstanding any provision contained herein to the contrary, any proceeds of insurance maintained by Tenant for damage to the contents owned by Tenant within the Premises shall be and remain the sole property of Tenant.

At all times during the lease term, Tenant shall maintain in force and effect, at its own cost and expense, a policy or policies of liability insurance for the protection, indemnification and defense of Tenant (with Landlord named as an additional insured) against claims, demands and causes of action arising out of or in connection with the use, maintenance, operation and occupancy of the Premises. Tenant's policy or policies shall act as primary non-contributing insurance and shall have limits of not less than Two Million Dollars (\$2,000,000.00) for injuries (including death) to one person, Five Million Dollars (\$5,000,000.00) for injuries (including death) to more than one person in one accident, and Two Million Dollars (\$2,000,000.00) for damages to property in one accident.

Section 9.3 Waiver of Subrogation. Notwithstanding any other provision of this Lease to the contrary, Tenant and Landlord each hereby waive any and all rights of recovery against the other, or against the officers, employees, agents and representatives of the other, for loss of or damage to such waiving party or its property or the property of others under its control resulting from hazards covered by insurance required to be carried under this Lease (whether or not self-insured) to the extent of the amount of insurance proceeds such party would have received under that insurance if that party had maintained all insurance it is required to maintain under this Lease. All policies of property insurance required to be carried by either party for the Building, the Premises, or personal property or fixtures in the Building or in the Premises shall include a clause or endorsement denying to the insurer rights by way of subrogation against the other party to the extent rights have been waived by the insured before the occurrence of injury or loss.

ARTICLE X

UTILITIES AND SERVICES

Section 10.1 Utilities and Services. Tenant shall pay for all utilities and services which may be furnished to it or used by it in or about the Premises including without limitation water, sewer, electricity, telephone, and waste removal. Tenant at its cost shall provide usual and customary care to the Premises including custodial and maintenance. Landlord shall be responsible for snow removal on Smith Avenue, the parking lot to the east of the Building and north of Smith Avenue, and the alley which runs north and south at the east side of the Building.

ARTICLE XI

CONDEMNATION

Section 11.1 Condemnation. If the whole of the Premises subject to this Lease shall be taken or condemned by any competent authority for any public use or purpose, then the Term of this Lease shall cease on the day prior to the vesting of title in such authority and rent hereunder shall be paid and adjusted as of that day. If a portion of the Premises shall be take or condemned by any competent authority for any public use or purpose, such that, in the discretion of Tenant, Tenant's use of the Premises for its intended purpose is impaired, Tenant shall have the option of terminating this Lease by providing written notice to Landlord no later than ninety (90) days after possession is taken by such lawful authority. Tenant shall pay rent and perform all of its other obligations under this Lease up to such termination date. If this Lease is not so terminated, the rent per month due for the remainder of the then current Term shall be calculated by multiplying (i) the then current amount of rent per square foot of the Premises per year by (ii) the number of square feet remaining within the Premises after such taking, and then dividing the product by twelve (12). Any prepaid rent shall be proportionately credited to Tenant.

ARTICLE XII

DEFAULT AND REMEDIES

Section 12.1 Events of Tenant's Default. The following events shall be deemed to be events of default by Tenant under this Lease:

- (a) Failure by Tenant to pay rent or any other monies due and payable from Tenant to Landlord under this Lease within ten (10) days after the due date.
- (b) Tenant shall fail to comply with any term, condition or covenant of this Lease, other than the payment of rent, and shall not cure such failure within thirty (30) days after Tenant's receipt of written notice thereof from Landlord; provided, however, that if the nature of Tenant's obligation is such that more than thirty (30) days are required for performance, Tenant shall not be in default if Tenant commences performance within such thirty (30) day period and thereafter diligently prosecutes the same to completion.

Section 12.2 Landlord's Remedies Upon Tenant's Default. If a default occurs, Landlord shall have the option to pursue any one or more of the following remedies by giving Tenant written notice of Landlord's intention to do so:

- (a) Terminate this Lease, in which event Tenant shall surrender the Premises to Landlord on the date stated in such notice, and if Tenant fails to do so, Landlord may, without prejudice to any other remedy which it may have for possession or arrearages in rent, enter upon and take peaceful possession of the Premises without relinquishing Landlord's right to the rent or any other right given to Landlord hereunder or by law.

- (b) Enter upon and take peaceful possession of the Premises, and relet the Premises and receive the rent therefore; and Tenant agrees to pay to Landlord on demand any deficiency that may arise by reason of such reletting.
- (c) Enter upon the Premises without being liable for prosecution or any claim for damages therefore, and do whatever Tenant is obligated to do under the terms of this Lease, and Tenant agrees to reimburse Landlord on demand for expenses which Landlord may incur and thus effecting compliance with Tenant's obligation under this Lease, and Tenant further agrees that Landlord shall not be liable for any damages resulting to the Tenant from such action, unless caused by negligence of the Landlord.

Pursuit of any of the foregoing remedies shall not preclude pursuit of any of the other remedies herein provided or any other remedies provided by law, nor shall pursuit of any remedy herein provided constitute a forfeiture or waiver of any rent due to Landlord hereunder or of any damages accruing to Landlord by reason of the violation of any of the terms, conditions and covenants herein contained.

ARTICLE XIII **WAIVER**

Section 13.1 Waiver. The waiver by Landlord of any term, covenant, or condition contained in this Lease shall be in writing, and waiver in one instance shall not be deemed to be a waiver of such term, covenant, or condition in the future, or any subsequent breach of the same or any other term, covenant, or condition contained in this Lease. The subsequent payment of rent hereunder by Tenant and the acceptance of that payment by Landlord shall not be deemed a waiver of any preceding breach or any obligation hereunder by Tenant other than the failure to pay the particular rental so accepted.

ARTICLE XIV **SURRENDER OF PREMISES**

Section 14.1 Surrender of Premises. At the end of the Initial Term or any Extended Term or other earlier termination of this Lease, Tenant will peaceably deliver to the Landlord possession of the Premises, together with all improvements or additions upon or belonging to the same, by whomsoever made, in the same condition as received, or first installed, ordinary wear and tear, condemnation, earthquake, act of God, or the elements alone excepted., and except as otherwise provided in Section 9.3 of this Lease. Notwithstanding the foregoing or any other provision of this Lease, Tenant shall be entitled to retain possession of all storage units, trade fixtures and shelving within the Premises and installed by Tenant, provided that Tenant repairs any damage to the Premises or the Building caused by removing such items. Tenant shall indemnify the Landlord against any loss or liability to a succeeding tenant resulting from delay by Tenant in surrendering the Premises. If either party wishes to conduct a joint inspection at the time of surrender of the Premises, such party shall notify the other party at least forty-five (45) days prior to the surrender.

ARTICLE XV

NOTICES

Section 15.1 Notice. All notices and demands which may or are required to be given by either party to the other under this Lease shall be deemed effective if made in writing and delivered to the recipient at the address set forth below, or to such other address as such party may from time to time designate by notice to the other in accordance with this Section, by any of the following means: (a) hand delivery with recipient's signature acknowledging receipt; (b) United States first class mail, postage prepaid; (c) registered or certified mail, postage prepaid, with return receipt requested; or (d) Federal Express, United Parcel Service or like overnight courier service, with request for assurance of receipt in a manner typical with respect to communication of that type. Notice made in accordance with this paragraph shall be deemed delivered upon receipt of delivery by hand transmission, three (3) business days after mailing if by first class, registered or certified mail, or one (1) business day after deposit with an overnight courier service.

ARTICLE XVI

QUIET ENJOYMENT

Section 16.1 Quiet Enjoyment. Landlord covenants that Tenant, upon paying the rent and performing each and every covenant and agreement hereof, shall peacefully and quietly hold, occupy, and enjoy the Premises throughout the term of this Lease, without hindrance by any person claiming or holding under or through Landlord, except as provided in Sections 6.1 and 12.2.

ARTICLE XVII

RELATIONSHIP OF THE PARTIES

Section 17.1 Relationship of the Parties. It is understood and agreed that the relationship of the parties here to is strictly that of landlord and tenant and that Landlord has no ownership in Tenant's enterprise and that this Lease shall not be construed as a joint venture or partnership. Tenant is not and shall not be deemed to be an agent or representative of Landlord.

ARTICLE XVIII
PERSONAL PROPERTY

Section 18.1 Personal Property. The parties acknowledge that Landlord has no interest or obligation in any personal property or equipment or furniture which may be installed by Tenant upon the Premises. Tenant shall at Tenant's sole cost have the right to remove same at the termination of this Lease and shall be obligated to repair any damage caused by removal. Property not so removed shall be deemed abandoned at the Termination of this Lease by Tenant, and title to the same shall thereupon pass to Landlord.

ARTICLE XIX
RECORDING

Section 19.1 Recording. This Lease shall not be recorded; however, upon the request of either party hereto the other party shall join in the execution of a memorandum of this Lease for the purpose of recordation. The memorandum of this Lease shall describe the parties, the Premises, and the term of this Lease and shall incorporate this Lease by reference.

ARTICLE XX
ENTIRE AGREEMENT

Section 20.1 Entire Agreement. This Lease and the Exhibits, attached hereto and forming a part hereof, set forth all the covenants, promises, agreements, conditions and understandings between Landlord and Tenant concerning the Premises, and there are no covenants, promises, agreements, conditions or understandings, either oral or written, between them other than are herein set forth. Except as herein otherwise provided, no subsequent alteration, amendment, change or addition to this Lease shall be binding upon Landlord or Tenant unless reduced to writing and signed by them.

ARTICLE XXI
FORCE MAJEURE

Section 21.1 Force Majeure. Should events or conditions beyond the control of either party, such as acts of God, war, threats or acts of terrorism or similar acts, civil disturbance, or any other emergency beyond the parties' control, make it inadvisable, illegal or impossible for either party to perform their obligations under this Lease, the performance of such acts shall be excused for the period of such delay. The provisions of this section shall not operate to excuse Tenant from prompt payment of rent or other payments required by the terms of the Lease.

ARTICLE XXII
PARTIAL INVALIDITY

Section 22.1 Partial Invalidity. If any term, covenant or condition of this Lease or the application thereof to any person or circumstance shall, to any extent, be invalid or unenforceable, the remainder of this Lease, or the application of such term, covenant or condition to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby and each term, covenant or condition of this lease shall be valid and be enforced to the fullest extent permitted by law.

ARTICLE XXIII
MISCELLANEOUS PROVISIONS

Section 23.1 Governing Law. This Lease shall be governed by the laws of the State of Indiana.

Section 23.2 Amendment. No amendment or addendum to this Lease shall be valid or binding unless such amendment or addendum is in writing and executed by the parties.

Section 23.3 Headings. The headings, titles, and subtitles in the Lease have been inserted solely for convenient reference and shall be ignored in its construction.

Section 23.4 Time. Time is of the essence for this Lease and of all provisions hereof.

Section 23.5 Venue. If any litigation arises from a dispute between the parties with regard to the validity, performance, and enforcement of this Lease, the parties agree that such litigation shall be filed and conducted only in the courts of Monroe County, Indiana.

Section 23.6. Successors and Assigns. This Lease shall inure to the benefit of and be binding upon Landlord, its successors and assigns, and shall be binding upon Tenant, its successors and assigns, and shall inure to the benefit of Tenant and only such assigns of Tenant to whom the assignment by Tenant has been made and consented to in accordance with the provisions of this Lease.

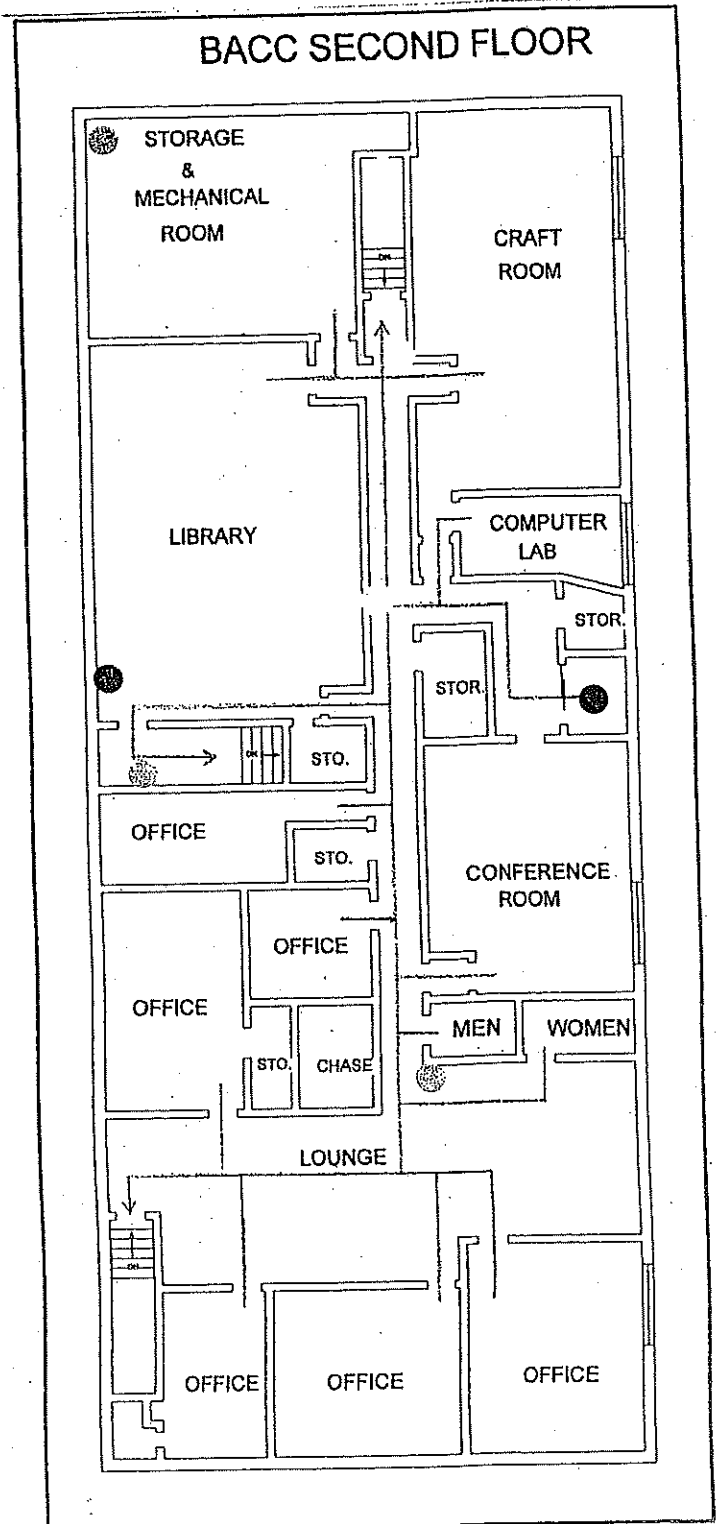

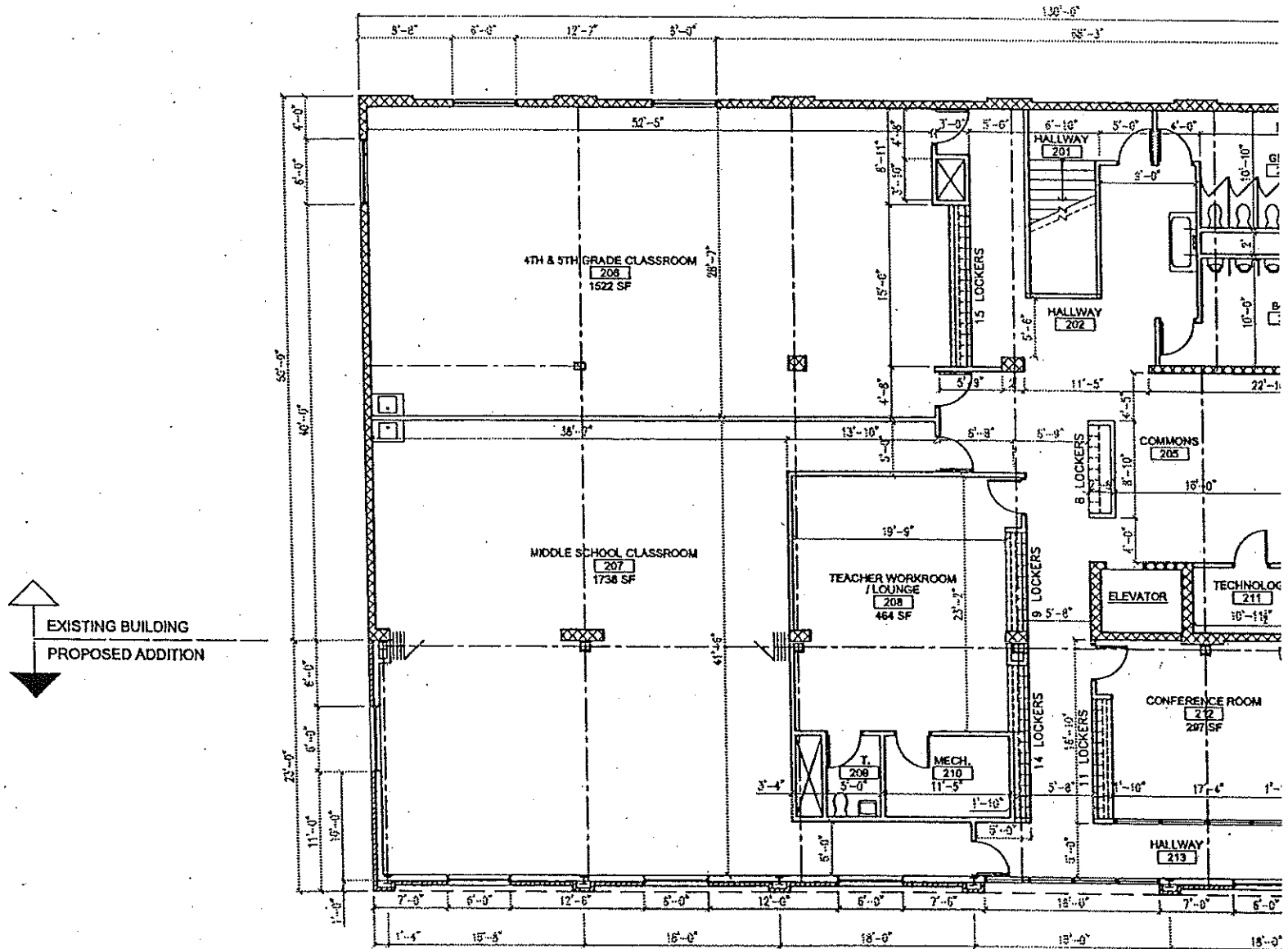

AMENDMENT TO LEASE AGREEMENT

THIS AMENDMENT TO LEASE AGREEMENT (this "Amendment") is made and entered into this ____ day of June, 2009, by and between the City of Bloomington Department of Parks and Recreation by its Board of Park Commissioners, ("Landlord"), and the Bloomington Project School ("Tenant").

RECITALS:

- A. Landlord and Tenant are parties to a Lease (the "Lease"), pursuant to which Landlord leased to Tenant certain premises located at 349 S. Walnut Street, Bloomington, Monroe County, Indiana, and more particularly described in the Lease (the "Premises").
- B. Landlord and Tenant now desire to alter the Lease as set forth in this Amendment.

NOW, THEREFORE, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Lease, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. As of the date of the Lease, Tenant had submitted to Landlord and Landlord had approved those plans for improvement and addition to the Premises and the Building attached to the Lease as Exhibit "C" (the "Tenant Improvements"). Landlord now agrees that the Tenant Improvements may be accomplished in two phases. The first phase of Tenant Improvements ("Phase 1") is summarized on Exhibit "A" to this Amendment and shall be completed prior to the start of Tenant's school year 2009. The second phase of Tenant Improvements ("Phase 2") shall consist of those Tenant Improvements not completed during Phase 1. Phase 2 shall be completed prior to the start of Tenant's school year 2010. Any additional improvements or alterations to the Premises or Building, other than those shown on Exhibit C to the Lease or Exhibit A to this Amendment, shall be approved by Landlord before said additional improvements or alterations are made.

2. Tenant has requested an alternative in lieu of compliance with Section 7.2 of the Lease under which Tenant was required to submit a Seven Hundred Fifty Thousand Dollar (\$750,000.00) letter of credit to Landlord prior to Tenant's commencement of work on the Tenant Improvements. Landlord hereby agrees to allow Tenant to comply with the following term in lieu of submitting the letter of credit.

3. Before Tenant commences work on Phase 1, Tenant shall provide Landlord with documentation, reasonably satisfactory to Landlord, indicating that funds sufficient for completion of Phase 1, in an amount equal to or greater than Four Hundred Sixty-Eight Thousand Seven Hundred Seventy-Four Dollars (\$468,774.00), are or shall be available to Tenant. Before Tenant commences work on Phase 2, Tenant shall provide Landlord with documentation, reasonably

satisfactory to Landlord, indicating that funds required for the completion of Phase 2 are or shall be available to Tenant.

4. Before tendering payment to contractors or any other person performing labor or furnishing materials for any portion of the Tenant Improvements, whether such payment is in the form of a progress draw or is final payment for completed work, Tenant shall obtain a lien waiver from said contractor whereby said contractor waives and releases any and all liens, or rights of lien and claims on or against the Premises and the Building and releases and agrees to save harmless the City from and against any and all claims for and on account of labor, services, material, fixtures, apparatus or machinery heretofore furnished for the Premises and the Building.

5. This Amendment shall not amend, modify or supplement the terms, conditions or provisions of the Lease, the terms and provisions of which are incorporated herein, except as expressly provided herein. Landlord and Tenant agree that, except as expressly provided herein, all of the provisions of the Lease shall remain and continue in full force and effect in accordance with their original terms.

6. This Amendment shall be governed by and construed in accordance with the laws of the State of Indiana, without regard to choice of law principles thereof.

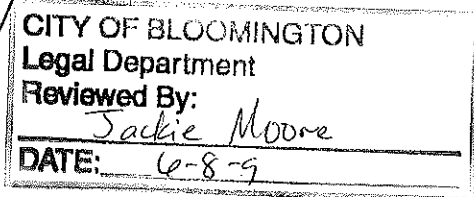

Walnut Street, Bloomington, Monroe County, Indiana and more particularly described in the Lease (the "Premises").

B. Landlord and Tenant now desire to alter the Lease as set forth in this Amendment.

NOW, THEREFORE, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Lease, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Section 2.2 of the Lease is hereby amended as follows:

Section 2.2 Option to Extend. Upon expiration of the Initial Term, if Tenant is not then in default, Landlord hereby grants to Tenant the right to extend the term of this Lease for four (4) additional terms of five (5) years each (each an "Extended Term" and together with the Initial Term, the "Term"). The Tenant shall exercise its options to extend this Lease by giving written notice to Landlord as provided in this Lease on or before the date that is fourteen (14) months prior to the last day of the Initial Term or the then current Extended Term, as the case may be. The parties agree that they may negotiate a potential purchase of the Building by Tenant at the end of the Initial Term and any Extended Terms, or the inclusion of an option to purchase in this Lease during the then following Extended Term, such negotiations to begin at least fourteen (14) months prior to the last day of the Initial Term or the then current Extended Term, as the case may be. No such option to purchase exists prior to fourteen (14) months prior to the expiration of the Initial Term. The rent payable by Tenant to Landlord during any Extended Term shall be determined as set forth in Section 4.4 of this Lease. If Tenant fails to give written notice of extension to Landlord within the time specified, or if this Lease is terminated, any subsequent option to extend shall expire and be of no force or effect. The exercise of any option to extent shall be ineffective if Tenant is in default on the last day of the prior Term.

2. This Amendment shall not amend, modify or supplement the terms, conditions or provisions of the Lease, the terms and provisions of which are incorporated herein, except as expressly provided herein. Landlord and Tenant agree that, except as expressly provided herein, all of the provisions of the Lease shall remain and continue in full force and effect in accordance with their original terms.

3. This Amendment shall be governed by and construed in accordance with the laws of the State of Indiana, without regard to choice of law principles thereof.

4. This Amendment shall be contingent upon Tenant's receipt of Qualified School Construction Bonds, Qualified Zone Academy Bonds or similar funds from the Indiana Department of Education. If the Tenant does not receive the fund specified above, this Amendment shall be null and void.

Landlord and Tenant are parties to a Lease dated as of April 27, 2009, as amended by that certain Amendment to Lease Agreement dated as of June 30, 2009, and that certain Amendment No. 2 to Lease Agreement dated August 25, 2009, (the "Lease"), pursuant to which Landlord leased to Tenant certain premises located at 349 South Walnut Street, Bloomington, Monroe County, Indiana and more particularly described in the Lease (the "Premises").
- B. Landlord and Tenant now desire to alter the Lease as set forth in this Amendment.

NOW, THEREFORE, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Lease, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Section 3.1 of the Lease is hereby amended and restated in its entirety as follows:

Section 3.1 Occupancy. Tenant shall use and occupy the Premises solely for the operation of a charter school, as authorized by Indiana Code 20-24-1-1 *et seq.*, and for no other use or purpose without the Landlord's prior, written consent, which consent may be withheld at Landlord's sole discretion, provided, however, that upon an event of default under the Tenant's loan documents, the Premises may be used by subsequent tenants for any lawful purpose with Landlord's prior, written consent, which shall not be unreasonably withheld.

2. Section 4.3 of the Lease is hereby amended and restated in its entirety as follows:

Section 4.3. Rent During Lease Years Three (3) Through Ten (10). Tenant shall pay rent to Landlord during Lease Years Three (3) through Ten (10) in an annual amount equal to Eighty-Eight Thousand One Hundred Twenty-Five Dollars and No/100 Dollars (\$88,125.00) with payments of Seven Thousand Three Hundred Forty-Three and 75/100 Dollars (\$7,343.75) per month.

3. Section 4.4 of the Lease is hereby amended and restated in its entirety as follows:

Section 4.4. Rent During Extended Term(s). (a) Should Tenant elect to extend the

term of this Lease as described in Section 2.2, the annual rent payable by Tenant to Landlord shall be computed as follows during the first and second Extended Term: (i) Lease Year Eleven (11) annual rent shall be an amount equal to \$88,125 plus the lesser of (A) the Consumer Price Index ("CPI") or (B) two percent (2%) ("Lease Increase Amount"); and (ii) Lease Years Twelve (12) through Twenty (20) annual rent shall be an amount equal to the preceding Lease Year rent plus the Lease Increase Amount. As an example, Lease Year Eleven (11) Rent based upon Two Percent (2%) rent increase amount would equal \$89,887.50, and Lease Year Twelve (12) rent based upon the same calculation using Year Eleven (11) above as a base rent would be \$91,685.25. Parties agree, however, that a negative CPI shall not be applied to annual rent and in no event shall rent decrease from year to year.

(b) Should Tenant elect to extend the term of this Lease beyond the second Extended Term as described in Section 2.2, the rent payable by Tenant to Landlord during any such Extended Term shall be negotiated by the parties. Within sixty (60) days of receipt by Landlord of Tenant's written notice of its election to extend the term of the Lease, Landlord and Tenant shall begin said negotiations.

4. This Amendment shall not amend, modify or supplement the terms, conditions or provisions of the Lease, the terms and provisions of which are incorporated herein, except as expressly provided herein. Landlord and Tenant agree that, except as expressly provided herein, all of the provisions of the Lease shall remain and continue in full force and effect in accordance with their original terms.

5. This Amendment shall be governed by and construed in accordance with the laws of the State of Indiana, without regard to choice of law principles thereof.

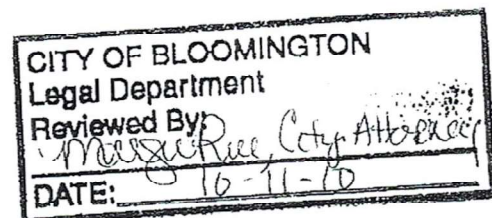

Witnesseth:

Whereas, the City of Bloomington Department of Parks and Recreation, by its Board of Parks Commissioners (Landlord) and The Project School (Tenant) first entered into a lease (Original Lease) for the property located at 349 S. Walnut, Bloomington, Indiana beginning on April 21, 2009; and

Whereas, the initial term of the Original Lease began on April 21, 2009 and ended on June 30, 2019; and

Whereas, the Original Lease provided the opportunity to extend the initial term by two additional five-year terms; and this was later modified to allow for additional terms in the Second Amendment to the Lease Agreement; and

Whereas, the parties agreed to Amendment Number 3 to the Original Lease on October 11, 2010, providing that the rental amounts for the first and second extended terms would be \$88,125.00 annually, plus the lesser amount of the consumer price index or two percent, adjusted annually;

Whereas, the parties hereby agree to extend the Original Lease by one additional five-year term, beginning on July 1, 2019, and ending on June 30, 2024; and

Whereas, in compliance with Amendment Number 3, the annual rental amount for the first year of the extended term will be \$89,711.25 annually, or \$7,476.94 monthly; and

Whereas, the rental amount will be adjusted annually in compliance with Amendment Number 3;

Now, therefore, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Original Lease, as amended, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to extend the Original Lease as follows:

TERM: The extended term began on July 1, 2019, and will end on June 30, 2024.

RENT: The annual rent for the first year of the extended term will be \$89,711.25, to be paid in monthly amounts of \$7475.93 a month.

FUTURE RENT ADJUSTMENTS: The rent for the remainder of this extended term will be increased annually, by the lesser amount of two percent (2%) or the consumer price index for the preceding twelve months. Parties agree that a negative CPI shall not be applied to annual rent and in no event shall rent decrease from year to year.

All other terms of the Original Lease, as amended by Amendments Number 1, dated June, 2009; Number 2, dated August, 2009 and Number 3, dated October 11, 2010, remain in effect.





Recommendation

Staff recommends approval of a contract with Commercial Services of Bloomington to install a water line, dog rinse water fixture, trough drainage, and drainage line at the Switchyard Park large dog chamber. Total cost not to exceed \$11,260. Funding source: 176-18-G21005-54310 (ARPA)

Background

The Switchyard Park dog park currently has a water fountain fixture with a 'dog water bowl' at the bottom. However this fixture is outside the fence line and does not have a hose hookup.

The added fixture will be inside the double entry fenced in chamber for the large dog chamber and will have two hose attachments that will allow dog owners to fill water bowls (that may be placed inside the fence line) and an opportunity to rinse dirt/mud off the dogs in a secure location. The fixture will have large push buttons with timers; once the button is pushed the water will run for approximately 20 seconds.

*This is a 'rinse station' and not a 'shower station' because the water will drain to the storm water system. Soap and other chemicals are not allowed into the storm water system.

This Agreement, entered into on this _____ day of _____, 2023, by and between the City of Bloomington Department of Parks and Recreation (the "Department"), and Commercial Service of Bloomington, Inc ("Contractor").

Article 1. Scope of Services

Contractor shall provide the Services as specified in Exhibit A, "Scope of Work", attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before December 31, 2023 unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services.

In the performance of Contractor's work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with HSIUNG MARLER, as the Department's Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. Standard of Care

Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The Department shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department

The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as expeditiously as is necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation

The Department shall pay Contractor for all fees and expenses in an amount not to exceed ELEVEN THOUSAND TWO HUNDRED FIFTY-NINE DOLLARS AND FORTY-FOUR CENTS (\$11,259.44). Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to:

Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. Appropriation of Funds

Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule

Contractor shall perform the Services according to the schedule set forth in Exhibit B, Project Schedule, attached hereto and incorporated herein by reference. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination

In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party.

The Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 10 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. Identity of the Contractor

Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Opinions of Probable Cost

All opinions of probable construction cost to be provided by Contractor shall represent the best judgment of Contractor based upon the information currently available and upon Contractor's background and experience with respect to projects of this nature. It is recognized, however, that neither Contractor nor the Department

has control over the cost of labor, materials or equipment, over contractors' method of determining costs for services, or over competitive bidding, market or negotiating conditions. Accordingly, Contractor cannot and does not warrant or represent that the proposals or construction bids received will not vary from the cost estimates provided pursuant to this Agreement.

Article 10. Reuse of Instruments of Service

All documents, including but not limited to, drawings, specifications and computer software prepared by Contractor pursuant to this Agreement are instruments of service in respect to this project. They are not intended or represented to be suitable for reuse by the Department or others on modifications or extensions of this project or on any other project. The Department may elect to reuse such documents; however any reuse or modification without prior written authorization of Contractor will be at the Department's sole risk and without liability or legal exposure to Contractor. The Department shall indemnify, defend, and hold harmless the Contractor against all judgments, losses, claims, damages, injuries and expenses arising out of or resulting from such unauthorized reuse or modification.

Article 11. Ownership of Documents and Intellectual Property

All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 12. Independent Contractor Status

During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 13. Indemnification

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.

- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment.

Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

Article 28. Living Wage Ordinance

Contractor is "covered employer" under City Ordinance 2.28, otherwise known as the "Living Wage Ordinance," or "LWO," and as such, is required to pay their covered employees at least a living wage. Currently, the living wage is \$15.29 per hour for covered employees, and up to 15% of that amount, or \$2.29, may be in the form the covered employer's contribution to health insurance available to the covered employee.

Contractor shall execute the Living Wage Ordinance Affidavit, attached as Exhibit E; shall abide by the LWO by paying their employees a living wage; and shall post the Living Wage Poster, provided by the City Legal Department, in areas frequented by their covered employees.

The Parties have effectuated this Agreement by executing it on the day and year first written above.

Recommendation

SUBJECT: PARTNERSHIP AGREEMENT WITH THE INDIANA ARBORIST ASSOCIATION (“IAA”)

Recommendation

Staff recommends the approval of a partnership agreement with the IAA to bring high level tree related classes, trainings, and workshops to the Bloomington area. This has the potential to draw people from not only the greater Bloomington area, but likely all of lower Indiana and adjacent states for these trainings.

Background

The IAA is a state level chapter of the International Society of Arboriculture, who certifies all arborists and other related certifications. The Indiana Arborist Association (IAA) strives to enhance the quality of life for Indiana residents by encouraging the planting, maintenance and preservation of trees. This lines up with the Department’s goals of increasing public awareness of the benefits provided by well-maintained trees, and promoting the advantages of working with qualified professional arborists who use current industry standards. IAA endeavors to efficiently serve the needs of its members by fostering opportunities for training and the exchange of ideas, and encouraging high ethical standards among its members and in the industry at large. Parks will provide the location for these trainings and IAA will provide the trainings.

COOPERATION SERVICES AGREEMENT PROGRAM PARTNERSHIP

Partner(s):

This agreement is made and entered into this ____ day of ____ 2023, by and between the City of Bloomington Parks and Recreation Department (“BPRD”), Indiana Arborist Association (“IAA”)

WHEREAS, BPRD wishes to bring tree related educational events to Bloomington; and

WHEREAS, The IAA wishes to conduct tree related educational events in the Bloomington area; and

WHEREAS, BPRD is authorized to plan and develop partnerships and contractual arrangements with non-city organizations to promote urban forestry related education.

NOW, THEREFORE, the parties do mutually agree as follows:

1.0 Purpose of Agreement:

The purpose of this Agreement is to outline a partnership agreement, which will provide a mutual understanding between both parties for tree related educational classes, trainings or workshops to take place in Bloomington Indiana.

2.0 Duration of Agreement:

This Agreement is in effect from the date of signing until December 31, 2028 unless terminated earlier as provided under Article 7.0.

3.0 Bloomington Parks & Recreation:

3.1 The goal of BPRD is to increase educational opportunities related to trees in the Bloomington area.

3.2 BPRD agrees to:

1. Provide a location for the IAA to conduct tree related educational classes, trainings, or workshops.
2. Act as liaison to the IAA, assist with set up, tear down, or anything reasonable required for the class, training or workshop for function properly.

3. Promote the IAA classes, trainings, or workshops if desired by the IAA.

4.0 Indiana Arborist Association (“IAA”):

- 4.1 The goal of IAA is to conduct tree related educational classes, trainings, or workshops in Bloomington Indiana.
- 4.2 Indiana Arborist Association agrees to:
 1. Conduct and lead educational classes, trainings, or workshops based on current best management practices on various topics in the world of arboriculture.
 2. Communicate and plan effectively far enough in advance to allow for BPRD to allocate a facility and/or resources.

5.0 Terms Mutually Agreed To By All Partners to This Agreement.

- 5.1 The intent of this Agreement is to document a mutually beneficial partnership between the IAA and BPRD.
- 5.2 The staff and personnel involved in this Agreement will at all times represent all parties to this Agreement in a professional manner and reflect the commitment of all parties to quality services and customer satisfaction.
- 5.3 The IAA shall maintain comprehensive general liability insurance, with a minimum combined single limit of one million dollars (\$1,000,000.00) per occurrence and two million dollars (\$2,000,000.00) in the aggregate. The policy shall name the City of Bloomington Parks and Recreation Department as an additional insured, and the IAA shall provide Parks with a certificate of insurance prior to the commencement of operations under this Agreement. The IAA and its insurer shall notify Parks within ten (10) days of any insurance cancellation.
- 5.4 The commitment of personnel, facilities, supplies and payments will be honored according to the timetable agreed upon by all partners.
- 5.5 The IAA is recognized as having the expertise and experience to conduct tree related educational classes, training or workshops. BPRD shall have the right to review risk management, agreement terms, and service quality issues.
- 5.6 Municipal Code sections 6.12.020 and 14.36.090, respectively, prohibit smoking and vaping inside city facilities and the consumption of alcoholic beverages on city property.
- 5.7 Pursuant to Indiana code 35-47-11.1-2 and 3, the City is prohibited from enforcing a firearms policy in public parks and city facilities as of July 1, 2011. However, per Indiana Code 35-47-11.1-4(10), The IAA may develop and implement, at its own discretion, rules of conduct or admission

regarding the carrying and storage of firearms, upon which attendance at and participation in its activities is conditioned, and the City is hereby authorized to enforce said policy for purposes of this Agreement. If the IAA implements such a policy, it shall provide a copy of the policy to the City to be attached to this Agreement and incorporated herein by reference.

- 5.8** The IAA shall release, hold harmless, and indemnify the City of Bloomington, its Parks and Recreation Department, and its officers, employees, agents, and assigns (Releasees) from any and all claims which may arise as a result of the IAA's negligence in conducting activities under this Agreement. This includes claims for personal injury, property damage, or any other type of claim which might be brought against Releasees or the IAA, or its employees, agents or patrons, by any third party, except where such personal injury, property damage or claim is caused by the negligence of Release.

6.0 Notice:

7.0 Termination

Either party may unilaterally terminate this partnership Agreement as long as they provide at least thirty (30) days' written notice to the other party.

- 7.1** The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the

terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Haskell Smith- Urban Forester (812)349 - 3716 of any such termination and the reasons therefore in writing.

8.0 E-Verify

- 8.1** Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.
