The CAPS Commission has already applied and been accepted by the IU Cinema to be a community partner in sponsoring a screening of the film <u>Reimaginging Safety</u> at the cinema on Feb. 24, 2024. This is an opportunity for the Commission to improve its outreach and awareness of evidence-based understandings of public safety with Indiana University students, faculty and staff. It is also an opportunity to invite scholarly experts on the topic to attend the event.
