
ABOUT GUARANTEED SAVINGS CONTRACTS (GSC)

- ☐ GSC is one of the five ways to hire a Contractor in Indiana
- ☐ GSC focuses on re-investment in existing systems and infrastructure
 - ☐ Upgrades in technologies
 - ☐ Reductions in operational costs
 - ☐ Improvements in energy profiles
- ☐ GSC Providers carry both engineering and contractors licenses

PROCUREMENT USING GSC

- ☐ Early selection of a Contractor
 - Participates during design to develop costs and schedules
 - ☐ Works as a partner to the designer for constructability
 - ☐ Development of a Guaranteed Maximum Price
- ☐ No obligation until GMP is accepted and the contract is executed
- ☐ Contract models
 - ☐ Single Project Style: scope for a single project (most similar to bid)
 - ☐ Program Style:
 - ☐ Single agreement and calculation of savings
 - ☐ Scope, schedules, and budget amended by phases
 - ☐ Master Service Agreement Style
 - ☐ Single agreement
 - ☐ Scope, schedules, budget and savings amended by phases



GSC CONTRACTING APPROACH

Build off CBU Standard Agreement Modify to point to the appropriate codes Incorporate GSC language on savings Exhibits for scope and savings definitions Kokosing proposes use of Time & Materials Not-to-Exceed Contract Monthly Pay Applications on a Schedule of Values, reconciled to actual costs As project progresses, remaining unspent budget are identified as savings. Savings can be: Returned to CBU as a deductive change order Applied to additional scopes (with no additional Provider Fee) Rolled to offset GMP for future phases or task orders

Use of Limited Notice to Proceed

Project Savings Examples

Higher than budgeted efficiency

Lower than budgeted materials cost

Change in construction equipment used

Scope removed

CBU self-performs activities

Reduction in subcontractor costs

Alternative construction approach shortens time, increases efficiency

Shorter project time reduces General Construction costs

GSC SAVINGS CALCULATIONS

- ☐ Savings Calculated must be greater than cost of the project
- Stipulated versus Actual Savings
- Concept of Deferred Capital Savings
- Operational & Maintenance Savings
 - □ Not restricted to CBU as the beneficiary
 - ☐ Internal cost savings
 - ☐ External cost savings
- Energy Savings
 - ☐ Present versus Future
 - ☐ Standard versus Actual

Calculated Savings Examples

Reduced OT for staff

Reduced / Eliminated staff time for a task

Reduced clean-up for flooding

Reduced cost to customers for interrupted service

Elimination or reduction of contract services

Reduced electric bill due to increased motor efficiency

Reduced electric bill due to addition of Variable Frequency Drive (VFD)

GSC PATH FORWARD

- 1. Resolution to authorize CBU to work with Kokosing
- 2. Kokosing supports CBU and Designer to price, schedule, and Value Engineer the designs
- Kokosing works with CBU attorney on agreement language and savings calculations
- Kokosing submitted a GMP proposal included price, scope, and schedule
- 5. CBU accepted GMP Proposal
- 6. Kokosing integrates proposal into GSC Agreement & Exhibits
- 7. Kokosing develops required internal savings report
- 8. Contract submitted for authorization
- 9. Kokosing submits executed contract to Indiana DLGF
- 10. Addition of next Phase or New Task Order
