**Proposed Amendment:**

1. Section I D of Ordinance 23-24 shall be amended by inserting the words “, with the exception of Captains, Chauffeurs, Firefighters 1<sup>st</sup> Class, and Probationary Firefighters,” after the words “Fire personnel” in the first sentence so that the entire section reads as follows:

Fire personnel, with the exception of Captains, Chauffeurs, Firefighters 1st Class, and Probationary Firefighters, will receive \$500. Those who are current employees at the time of payment are eligible to receive the payment.

2. Section I F of Ordinance 23-24 shall be amended by deleting the section in its entirety and replacing it with the following:

Active Firefighters 1st Class, Chauffeurs, and Captains shall receive the annual equivalent of the pay listed in the table below. In order to be eligible for the pay, employees must be active Firefighters 1<sup>st</sup> Class, Chauffeurs, and Captains during the pay period for which the payment is issued. Pay will be prorated for those who are not in one of these positions on January 1, 2024.

Position	Retention Pay
Firefighter 1st Class	\$5,534
Chauffeur	\$5,555
Captain	\$5,598

**Synopsis**

This amendment was prepared at the request of the Human Resources Department to provide certain employees of the Fire Department with additional compensation in the form of retention pay and to facilitate paying additional pay.

**Proposed Amendment:**

1. Ordinance 23-24 shall be amended by inserting a new Section 4 and renumbering subsequent sections accordingly. The new Section 4 shall read:

SECTION IV. The maximum number of sworn officers within the Police Department for the year 2024 shall be set at 95.

**Synopsis**

This amendment is sponsored by Cm. Volan. Under authority granted to the Council under Indiana Code § 36-8-3-3, it provides that the maximum number of sworn officers within the Bloomington Police Department shall be set at 95. This amendment is proposed with the sole intent that the administration will use the savings from ten unfillable positions to offer sworn employees an increase to the salaries of the remaining funded officers equivalent to the savings.
