# 1. Call to order and quorum confirmation:

3. Reports from: Tree Commission (TC), Monroe County Environmental Commission (MCEC), Bloomington Commission on Sustainability (BCOS), Environmental Resource Advisory Council (ERAC), Metropolitan Planning Organizing-Citizens Advisory Council

# (MPOCAC), Friends of Lake Monroe (FOLM), & Monroe County-Identify and Reduce Invasive Species (MC-IRIS), Environmental Commission Planning Committee (ECPC).

**TC:** The committee did not meet this month. However, David will send the foresters report to the EC when he receives it from Erin Hatch.

**MCEC:** Sam was unable to attend this meeting. However, on their website they did include their minutes from the month of January. During this meeting they discussed senate bill 411. This bill is related to commercial solar and wind energy. They also discussed the Bloomington and Monroe County Hoosier Resiliency Index. They also had a climate action site discussion, which Sam will send more information about in an email. Lastly, they discussed the court ruling on the U.S. Forest Service Houston Logging Project.

**BCOS:** Laura Clemens discussed a website that they are developing in which you can report actions related to decreasing emissions. It is a similar project in regard to our connectivity plan just with emissions. Unfortunately, they spent the bulk of their meeting going over Robert's Rules of Order.

**ERAC:** The commission met at lower cascades. This area previously had a lot of erosion that has been replaced by limestone steps. The Clear creek trail has been granted extensions..... David needs to send minutes

**MPO-CAC:** We are not sure when this committee meets. Dedaimia is conditionally interested if they meet at a time that works for her.

FOLM: Currently not active because they are waiting for a government grant to come in.

**MC-IRIS:** They have been working in Jackson Creek and Southeast Park conducting restoration work. The plant Celandine is spreading very rapidly in Bloomington according to Don. In just two years it has spread through Southeast Park. However, on an uplifting note, the work MC-IRIS has done in these areas has allowed for many native species to flourish. Glyphosate was brought up again and was discussed as being a necessary evil. For more information you can refer to the previous month's meeting when we had two licensed applicators discuss this chemical.

**ECPC:** At the last meeting the group developed two ideas. The first was to come up with a checklist to give to the planning department that ensures that they are looking at all the environmental aspects of a plan. Another option is to ask the counsel to ensure the planning department gives plans that don't address environmental issues of the UDO, to the EC to look at. This will allow the ECPC to carry out their work. The language that we would use would be if a proposal had site specific concerns. So, the action items the EC needs to do is to come up with items to put on the check list of site-specific concerns to give to the counsel. The ECPC will develop this and have an emergency session to vote on this. The emergency meeting will be next Thursday the 28<sup>th</sup>. Mike, Dedaimia, and David will meet with The Planning Director as soon as possible.

### 4. Discussion from active working groups:

# A. Biodiversity working group:

1. Update on Connectivity Plan

Ben just needs to combine the pledge with the Map instructions. Everything else is complete. Adopt a greenspace is similar to the Habitat Connectivity Plan, however, it helps manage public land and not private.

### 2. Next steps of biodiversity working group

During this meeting the working group discussed the next steps. Essentially, what needs to be done to get more people to participate in the plan.

The small and simple grant is not enough to cut down these trees. Dedaimia suggested looking at federal grants and applying to some. It would be a good idea to mention this to MC-IRIS.
