The meeting was called to order by Ellen Rodkey at 4:14 pm Present: Ellen Rodkey, Israel Herrera and Jim Whitlatch

Ellen Rodkey, Vice President commented: staff would like to move from C. Other Business agenda item C-4 Partnership 2024 Bug Fest to A: Consent Calendar. The Partnership 2024 for Bug Fest could be approved with the Consent Calendar

Jim Whitlatch made a motion to move agenda item C-4 Partnership 2024 Bug Fest to A. Consent Agenda. *Israel Herrera* seconded the motion. Vote taken: motion unanimously carried 3-0.

Jim Wh	nitlatch made a motion to approve the Consent Calendar. Israel Herrera seconded the motion. Vote taken: motion

B.PUBLIC HEARINGS/APPEARANCES

B-1	Emily Buuck, Community Relations Coordinator presented Rob Cronk with the June Bravo Award for the many Park events Rob had been involved with as a volunteer. Rob was a Network Administrator with the City's ITS Department. Staff could count on Rob to show up and do whatever was needed, even assisting with technical issues. Staff was grateful for Rob's support as a volunteer, a colleague and friend. Rob Cronk commented: he loved his community and loved being outside.	
B-2	Staff Introduction – Alec Curry had recently accepted the position of Sports Specialist with Bloomington Parks and Recreation. Alec had grown up in Bloomington, had played hockey at Frank Southern Center, baseball at Winslow, lacrosse in high school, had attended North High School, and had attended college in Northwest Indiana. Alec was in his 4 th year as a coach for the high school team. Alec's goal was to help people have an enjoyable experience using and playing at parks facilities and programs. Alec was excited for his new role, and looked forward to working with everyone.	

C. OTHER BUSINESS

Tim Street, Director presented the Addendum with Reed & Sons for Bicentennial Gateway Change Orders. The addendum captured change orders needed for the Bicentennial Gateway Project for change orders that were made in Fall 2023 related to the installation of an accessible sidewalk for detour needs, as well as to capture the changes to the site improvements needed for the redesigned gateway itself. Both parties were in agreement to the changes. Proposed changes would increase cost of project \$79,462.44. Funding would be from Bond 980-18-18018C-54510 Project code 980 2020D. Staff recommended approval of the addendum.

Park Board Comments: Jim Whitlatch commented: Bicentennial Funds were separate from Park Funds, and could not be used for anything besides those approved projects, the project would not take away from the

Parks Funds. Tim Street responded: correct. When the Bond was issued and approved by Council, there was

a list of approved projects that funds could be used for. Jim Whitlatch inquired: were other City Departments on board with the project. Tim Street responded: yes, we were in a good position to move the project forward. Israel Herrera inquired: on removal of trees, and lighting concerns. Tim Street responded: any trees removed would be replaced with new trees. The lights would be soft white back lite system, not change in color, and should not be distracting. Jim Whitlatch made a motion to approve the Addendum with Reed and Sons for the Bicentennial Gateway Change Order. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0. Tim Street, Director presented the contract with Reed & Sons for Bicentennial Gateway Limestone Wall. As part of the updated Bicentennial Gateway project design, staff wished to have a limestone block wall fabricated and installed at Millers Showers Park. The work would be separate and distinct, though related, to the original site improvements contract that had been awarded to Reed & Sons in 2023. The scope of work had been bid separately. Staff recommend approval of the contract with Reed & Sons in and amount not to C-2 exceed of \$249,750. Funding for project would be from 980-18-18018C-54510 Project Code 98 2020D Jim Whitlatch made a motion to approve the contract with Reed and Sons for the Bicentennial Gateway Limestone Wall. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0. Tim Street presented the contract with bo-mar industries for Bicentennial Gateway lettering. Staff wished to have custom "BLOOMINGTON" metal lettering and LED lighting designed, fabricated, and installed on the Bloomington Bicentennial Gateway Wall. The contract had been approved as a sole source contract due to the custom nature of the coordination needed to design, fabricate, and install the letters as part of the greater project. Staff recommended approval of the contract with bo-mar Industries in an amount not to exceed \$65,000. Funding would be from Bicentennial Bond 980-18-18018C-54510 Project Code 980 2020D. Adam Lee, Bo-Mar Industries Director of Business Development commented: Bo-Mar Industries was a 34 year old family owned business out of Indianapolis. The letters would be 4ft tall, and made out of aluminum, LED C-3 white lights would be internal and give a soft glow onto the wall. The letters would be powder coated for durability. Everything would be done internally at Bo-Mar engineering design, fabrication and installation team. Board Comments: Ellen inquired: if vandalism was a concern. Adam Lee commented: they would be designed with fasteners that could not be easily turned. Public interaction would be taken into consideration. Israel Herrera inquired: if the public could take pictures at the wall. Tim Street responded: it was not a high traffic area, but the public would be able to interact with it. Jim Whitlatch made a motion to approve the contract with Bo-Mar Industries for the Bicentennial Gateway Limestone Wall lettering. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0. C-4 Bug Fest 2024 Partnership had been moved to, and approved as part of the A. Consent Calendar Hsiung Marler, Recreation Facilities General Manager presented the contract with All Pro Integrated Systems for Switchyard Pavilion projector and screen. Staff wished to upgrade the video system at Switchyard Park Pavilion. The purchase and installation of a ceiling mounted projector and screen would greatly improve the visibility and ease of the current system. Staff recommended approval of the contract with All Pro Integrated Systems in an amount not to exceed \$45,382. Funding for project would be from Switchyard Park General Fund. Board Comments: Jim Whitlatch inquired: what was wrong with the old system. Hsiung Marler responded: C-5 the weight of the screen was too heavy and pulled out, connectivity issues, projector on portable cart drastically effected floor plans, projector not adequate for natural lighting of building. The new system would address all of those issues. Jim Whitlatch inquired: if the old system could be used. Hsiung Marler responded: it would be used as a backup, as an additional system, or could be used at different locations. Ellen Rodkey inquired: if there was an upcharge to use the projector. Hsiung Marler responded: yes, and it would remain, the new system should be easier to use by all. Jim Whitlatch made a motion to approve the contract with All Pro Integrated Systems for Switchyard Park. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0. Becky Higgins, Recreation Division Director presented the Partnership Agreement with Visit Bloomington. Bloomington Parks and Recreation wished to partner with Visit Bloomington for the second year on a Thursday night concert series held in Switchyard Park on two different nights. BPRD would provide the venue, staffing support, coordination of alcohol sales, food trucks and the Homeland Security permit. Visit Bloomington would coordinate all aspects of the entertainment, security, port-o-potties and parking. No C-6 money would be exchanged. Staff recommended approval of the partnership with Visit Bloomington. Board Comments: Israel Herrera inquired: how many artist would be at the events. Becky Higgins responded there would be an opening act, then the main performance. The events usually started at 7pm and go to 9:30pm. The last event had 12,000 people in attendance and was a regional draw. Great way to identify new

	and upcoming musicians regionally as well as nationally.
	Jim Whitlatch made a motion to approve the partnership with Visit Bloomington. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0.
C-7	Satoshi Kido, Sports Division Director presented the contract with Cassady Electric. Staff wished to upgrade the lighting at Winslow Sports Park tennis courts. The contractor would upgrade the old lights by installing new LED technology and a push button activation that would prevent the lights from remaining on all night. Staff recommended approval of the contract with Cassady Electrical Contractors Inc. in an amount not to exceed \$19,900. The project would be funded from 977-18-18016C-54510 and ED-LIT Parks electrification funding 153-p04-0400000-53960. Contract was pending Legal approval.
	Jim Whitlatch made a motion to approve the contract with Cassady Electric for Winslow Sports Lighting upgrade. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0.
C-8	Satoshi Kido, Sports Division Director presented request to waive fees for Park Foundation Golf Tournament. Staff recommended waiving cart and green fees for the 32st Annual Parks and Recreation Foundation Don Brineman Golf Scramble, to be held Wednesday, August 28, 2024. The event was the primary fundraiser for the Bloomington Parks Foundation which supported the Lloyd Olcott Youth Endowment Fund. The tournament generally raised between \$5,000 and 9,000 in scholarship funding, which provided assistance to community youth with financial needs.
	Jim Whitlatch made a motion to approve waiving fees for the Park Foundation Golf Tournament. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0.
C-9	<u>Tim Street, Director</u> presented the contract with E&B Paving for RCA Park Shelter Concrete Work. Staff wished to replace the large shelter at RCA Park in a new location, with a new accessible sidewalk from the parking lot. Contractor would install the twelve concrete footers for the new shelter, as well as the sidewalk. Installation of the shelter would be completed internally. Staff recommended approval of the contract with E&B Paving in an amount not to exceed \$30,210. Funding for project would be from ARPA Funds 176-18-G21005-54510.
	Jim Whitlatch made a motion to approve contract with E&B Paving for RCA Park Shelter concrete work. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0.
C-10	<u>Tim Street, Director</u> presented contract with Bledsoe, Riggert, Cooper & James (BRCJ) for Switchyard parcel work. To ease the process of closing the Switchyard Park project with the Indiana Department of Environmental Management, and Environmental Restrictive Covenant (ERC) must be recorded on the deed detailing information about the sequestration of coal ash and cinder (CAC) on site. Staff wished to combine the eight separate parcels at Switchyard Park into one parcel. Contractor would use site surveys to prepare a new legal description to combine the eight separate parcel. Staff recommended approval of the contract with BRCJ in an amount not to exceed \$6,800. Funding would be from Switchyard Park and Operations General Funds.
	Jim Whitlatch made a motion to approve contract with Bledsoe, Riggert, Cooper & James for Switchyard parcel work . Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0
	<u>Tim Street, Director</u> presented contract with Mader Design for Building Trades Phase I. Due to age, staff wished to make improvements to Buildings and Trades Park. Contractor would provide design services for Phase I accessibility improvements derived from the recent Building Trades Park Master Plan. Staff recommended approval of the contract with Mader Design in an amount that would not exceed \$59,000. Funding would be from ARPA funds 176-18-G21005-54510.
C-11	Board Comments: <u>Ellen Rodkey inquired</u> : if the picnic shelter couldn't be taken out of the \$59,000, would that be moved into the budget of the rest of the Master Plan. <u>Tim Street responded</u> : yes, there was some room to move things around, possibility there were other APRP funds that hadn't been used, or could be funded from another source.
	Jim Whitlatch made a motion to approve contract with Bledsoe, Riggert, Cooper & James for Switchyard parcel work. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0
C-12	<u>Tim Street, Director</u> presented the Easement for the Power Line Trail. The easement was granted by Monroe county for the Parks and Recreation Department to build and operate a multi-use train in the preexisting utility easement on county property. Staff recommended approval of the easement.
	Jim Whitlatch made a motion to approve easement from Monroe County for the Power Line Trail. Israel Herrera seconded the motion. Vote taken: motion unanimously carried 3-0

When the National Weather Service HeatRisk index was Category 2 or higher admission to pools were free.

- 8 consecutive days of Heat Risk Category 2 or higher June 16-23 & 25
- Bryan Park Pool averaged 912 visitors per day, Mills Pool averaged 335 visitors per day on those nine days
- Bryan Park Pool sponsored admission \$43,812, Mills Pool sponsored admission \$16,122
- Funds had already been depleted
- ESD and BPRD would continue to meet to review program and search for additional funding

SERVICE AGREEMENT/SHORT CONTRACT BETWEEN CITY OF BLOOMINGTON PARKS AND RECREATION DEPARTMENT AND BRUCE WILDS SECURITY

This Agreement, entered into on the date last entered on the signature lines below, by and between the City of Bloomington Department of Parks and Recreation (the "Department"), and **BRUCE WILDS SECURITY** ("Contractor").

Article 1. Scope of Services. Contractor shall provide security services during the deer hunt at Griffy Lake Nature Preserve from 5:00 a.m. until 11:00 a.m. and from 1:00 p.m. until 7:00 p.m. on November 16, 17, 23 and 24, 2024. Duties include monitoring the parking lots at the Griffy Boathouse and at the dam, informing visitors that the property is closed and contacting the Bloomington Police Department if necessary. ("Services").

Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before DECEMBER 31, 2024, unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with STEVE COTTER as the Department's Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. <u>Standard of Care.</u> Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The Department shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department. The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation. The Department shall pay Contractor for all fees and expenses in an amount not to exceed FOUR THOUSAND SIX HUNDRED AND FIFTY DOLLARS (\$4,650.00). Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to: STEVE COTTER, City of Bloomington, 401 N. Morton, Suite 250, Bloomington, Indiana 47404. Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses. Article 5. Appropriation of Funds. Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement

Article 5. Appropriation of Funds. Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

 $\textbf{Article 6.} \ \underline{\textbf{Schedule.}} \ \textbf{Contractor shall perform the Services according to the following schedule:}$

The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination. In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 9 herein.

Article 8. <u>Identity of the Contractor.</u> Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Ownership of Documents and Intellectual Property. All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 10. Independent Contractor Status. During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 11. Indemnification. Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 12. <u>Insurance.</u> During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident; c) Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and such policies shall stipulate that the insurance will operate

as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest.</u> Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. <u>Waiver</u>. No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. Severability. The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 16. Assignment. Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. Third Party Rights. Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. Governing Law and Venue. This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. Non-Discrimination. Contractor shall comply with City of Bloomington Ordinance 2.23.100 et seq. and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment.

Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. Compliance with Laws. In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. E-Verify. Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. Notices. Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 23. <u>Integration and Modification.</u> This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 24. Non-Collusion. Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit B, affirming that Contractor has not engaged in any collusive conduct. Exhibit B is attached hereto and incorporated by reference as though fully set forth.

Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 14. Insurance

During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect:

- a. General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate.
- b. Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident.
- c. Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate.
- d. Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code.

All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder.

Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement. Approval of the insurance by the Department shall not relieve or decrease the extent to which Contractor may be held responsible for payment of damages resulting from Contractor's provision of the Services or its operations under this Agreement. If Contractor fails or refuses to procure or

maintain the insurance required by these provisions, or fails or refuses to furnish the Department's required proof that the insurance has been procured and is in force and paid for, the Department shall have the right at its election to terminate the Agreement.

Article 15. Conflict of Interest

Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 16. Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 17. Severability

The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 18. Assignment

Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 19. Third Party Rights

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Department and Contractor.

Article 20. Governing Law and Venue

This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 21. Non-Discrimination

Contractor shall comply with City of Bloomington Ordinance 2.23.100 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 22. Compliance with Laws

In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after

attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 23. E-Verify

Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit C, affirming that Contractor does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Contractor and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Contractor or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Contractor or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Contractor or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Contractor or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Contractor or subcontractor did not knowingly employ an unauthorized alien. If the Contractor or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Contractor or subcontractor is liable to the City for actual damages.

Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 24. Notices

Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 25. Intent to be Bound

The Department and Contractor each binds itself and its successors, executors, administrators, permitted assigns, legal representatives and, in the case of a partnership, its partners to the other party to this Agreement, and to the successors, executors, administrators, permitted assigns, legal representatives and partners of such other party in respect to all provisions of this Agreement.

Article 26. Integration and Modification

This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous

communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 27. Non-Collusion

Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit D, affirming that Contractor has not engaged in any collusive conduct. Exhibit D is attached hereto and incorporated by reference as though fully set forth.

The Parties have effectuated this Agreement by executing it on the day and year first written above.

BPRD agrees to:

- 3.1. Create and coordinate the distribution of promotional materials including printed material as well as social media.
- 3.2. Communicate to the public and participants regarding concerns or questions about cooperative programs and activities.
- 3.3. Email sponsorship/vendor information to past participants.
- 3.4. Promote Drool in the Pool at other major family-friendly BPRD events prior to the event.
- 3.5. Share all marketing/promotional material with Mad 4 My Dog.
- 3.6. Provide the Community Events Coordinator and additional full-time/part-time staff necessary for the event.
- 3.7. Coordinate recruitment and scheduling of volunteers.
- 3.8. Contact and schedule Animal Control officers to be onsite during event to check dog vaccination records.
- 3.9. Provide maintenance staff who shall be assigned to maintain and prepare the facility for the day of the event. Additional maintenance support staff needed to perform other repairs, tasks and services shall also be provided.
- 3.10. Facilitate the pool area during the event.
- 3.11. Be responsible for on-site registration and check-in.
- 3.12. Take any citizen concerns, reports or problems regarding the facility, improvements to the facility, services provided by staff or other issues by referral to BPRD on the designated form within 24 hours of observation.
- 3.13. Provide Mills Pool as the facility to house the event.
- 3.14. Work with the Sports Facility Manager to open and close the facility and assist with facility-related matters.
- 3.15. Provide tables and chairs necessary for all activities for the event.
- 3.16. Provide temporary fencing for the event.
- 3.17. Provide regular checking, stocking and maintenance of locker rooms.
- 3.18. Develop all sponsorship materials for distribution.

- 3.19. Design and order the event t-shirts.
- 3.20. Provide a sound system.
- 3.21. Provide an emcee and contest judges for the event.

4. Mad 4 My Dog

The goals of Mad 4 My Dog are to partner with another community agency and to provide an opportunity for the Bloomington community, specifically dogs and their owners, to participate in an affordable and fun summer event called Drool in the Pool. The event, to be held at Mills Pool, on Wednesday and Thursday, August 7 and 8, from 4:00-8:00 pm is designed to create social, safe, and fun opportunities for dogs and their owners.

Mad 4 My Dog agrees to:

- 4.1. Maintain close contact with Bill Ream, Community Events Coordinator, and address any related issues to his attention.
- 4.2. Assist with marketing the event including social media posts.
- 4.3. Secure all prizes for contests.
- 4.4. Refer any citizen concerns, reports or problems to BPRD within 24 hours of observation.
- 4.5. As possible, provide staff for each night of the event.

5. Terms Mutually Agreed to By All Partners:

The intent of this Agreement is to document a mutually beneficial partnership between Mad 4 My Dog and BPRD for Drool in the Pool.

BPRD and Mad 4 My Dog agree to:

- 5.1. Coordinate safety management and regulate visitor flow of Drool in the Pool.

SERVICE AGREEMENT/SHORT CONTRACT BETWEEN CITY OF BLOOMINGTON PARKS AND RECREATION DEPARTMENT AND

Odin & Ollie's Painting

This Agreement, entered into on the date last entered on the signature lines below, by and between the City of Bloomington Department of Parks and Recreation (the "Department"), and Odin & Ollie's Painting ("Contractor").

Article 1. Scope of Services. Contractor shall power wash all wooden poles and platforms to remove loose paint and debris; shall prime any areas over bare wood or rusted spots; shall paint all wooden poles blue on all side; and shall paint all platforms yellow on top of bottom ("Services").

Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before September 30, 2024, unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Mark Marotz, Operations Superintendent as the Department's Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

- Article 2. <u>Standard of Care</u>. Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The Department shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.
- Article 3. Responsibilities of the Department. The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.
- Article 4. Compensation. The Department shall pay Contractor for all fees and expenses in an amount not to exceed Eight thousand eight hundred dollars (\$8,800.00). Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to: Mark Marotz Operations Superintendent, City of Bloomington, 401 N. Morton, Suite 250, Bloomington, Indiana 47404. Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.
- Article 5. <u>Appropriation of Funds.</u> Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.
- Article 6. Schedule. Contractor shall perform the Services according to the following schedule: Contractor may start Services on August 12, 2024 and must complete Services by September 30, 2024

The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

- Article 7. Termination. In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 9 herein.
- Article 8. <u>Identity of the Contractor</u>. Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.
- Article 9. Ownership of Documents and Intellectual Property. All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.
- **Article 10.** <u>Independent Contractor Status.</u> During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.
- Article 11. Indemnification. Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.
- Article 12. <u>Insurance.</u> During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident; c) Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and such policies shall stipulate that the insurance will operate

as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest.</u> Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. Waiver. No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. Severability. The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 16. <u>Assignment.</u> Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. Third Party Rights. Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. Governing Law and Venue. This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. Non-Discrimination. Contractor shall comply with City of Bloomington Ordinance 2.23.100 et seq. and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment.

Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. <u>Compliance with Laws.</u> In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. E-Verify. Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. Notices. Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Department: City of Bloomington, Attn: Mark Marotz, 401 N. Morton, Bloomington, IN 47404. Odin & Ollie's Painting, ATTN: Zackery Johnson. Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 23. <u>Integration and Modification.</u> This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 24. Non-Collusion. Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit B, affirming that Contractor has not engaged in any collusive conduct. Exhibit B is attached hereto and incorporated by reference as though fully set forth.

SUBJECT: Updates to Parks Policies 2140 and 11080

Recommendation

Staff recommends the approval of the updates made to policies 2140 and 11080. The Parks and Recreation Department maintains a Policy Manual that guides the procedures and processes for the Department.

Background

Policy 2140 - Dress Code: This policy has been updated to include language concerning full time staff and now included more specific expectations for staff working both in the office and in the field. Language concerning business casual attire and more detail on what is and what is not acceptable work attire is included.

Policy 11080 - Behavior Guidelines: This policy has been updated to exclude number 6 under the Rules of Conduct section. After recent park activities and discussions with our Legal Department it was determined that this rule should no longer be included in the policy.

POLICY RE: Behavior Guidelines

Facilities and programs under the authority of the Board of Park Commissions of the Bloomington Department of Parks and Recreation are intended for the recreational use and enjoyment of residents of the City of Bloomington and its guests. Selected programs and services are available for individuals, groups and others which may be more specialized in nature. This policy is intended to regulate participant's conduct through consistency and to protect the rights of those participating in our programs and services.

The Bloomington Parks and Recreation Department abides by a zero tolerance atmosphere with respect to unwelcome and or offensive behavior in parks, facilities, programs and services. This includes vulgar language and verbal abuse to our staff and participants. Conduct in these categories constitutes ejection without warning.

Due to the unique nature of individual areas within Bloomington Parks and Recreation Department, each facility, program, park, and service area may establish its own rules and regulations, which shall augment this policy, and shall become the policy of said area. A copy of the regulations for an individual area or program shall be available upon request.

Rules of Conduct

- Any behavior which is disruptive or which hinders use of Bloomington Parks and Recreation
 Department programs or services is prohibited. This includes but is not limited to verbal or
 physical harassment or assault, profanity, persons under the influence of a mind altering
 substance, or fighting.
- 2. Some parks and facilities, based on their size, location or design purpose, can attract a large gathering of participants, users or spectators. In these situations staff has observed that the inclusion of animals in this environment poses some threat for possible injury to other park users or where food products are sold the possibility of unsanitary conditions. For this reason the following parks have restrictions where animals, other than a service animal assisting persons with disabilities, can not be brought into the park or facility in order to protect other park users. (see policy 13090)

Twin Lakes Sports Park (inside the fenced in area where the ball fields, bleachers and concessions areas are located)

Bloomington Community Farmers' Market (on the blacktop and in the Food and Beverage Artisan Area)

- 3. The violation of federal, state, or local laws and ordinances will not be permitted at the Bloomington Parks and Recreation Department or on its property.
- 4. Tobacco, alcohol, illegal drugs are prohibited on Bloomington Parks and Recreation Department property. (A copy of the protocol for violation of tobacco use policy follows.)
- 5. The sale of products or services is not permitted on Bloomington Parks and Recreation Department property without prior approval of the department.
- Taking surveys, asking people to sign petitions, taking video or audio footage, distributing leaflets, and other similar activities must be approved in advance by the department.
- 7. Parents are responsible for the behavior and actions of their children while they are in department facilities and participating in department programs and services. Children age seven and under must be accompanied by a parent or other responsible caregiver age eighteen or older at all times while on department property, unless the child is participating in a department program or service that is supervised by department employees.
- 8. Harassment of any person on the basis of race, sex, color, ancestry, national origin, religion, or sexual orientation is strictly forbidden. This includes unwelcome sexual advances or requests for sexual favors, and unwelcome and/ or offensive sexual comments.
- 9. The use of roller skates, roller blades, bicycles, and other wheeled vehicles or toys is not allowed inside department facilities except as expressly permitted by the Department.
- 10. Sleds, skis, toy vehicles, or any piece of equipment must be approved by an appropriate staff member. Dangerous or unsafe equipment is prohibited.

- 11. Speed limits must be adhered to while on Bloomington Parks and Recreation Department property.
- 12. Designated parking is available at most Bloomington Parks and Recreation Department sites. Parking in areas or spaces not designated as parking is strictly prohibited.
- 13. Unnecessary noise from vehicles, radios, equipment, or from another device or a person which disrupts any participant's ability to appropriately participate in a Bloomington Parks and Recreation Department activity or facility is prohibited.
- 14. It shall be considered trespass if anyone is found after hours on Bloomington Parks and Recreation Department properties that have established closing times. This rule extends to parking lots, playgrounds, surrounding walls, stages, and fences, etc.
- 15. No one shall interfere or hinder any officer, agent, employee, or volunteer of the Bloomington Parks and Recreation Department while engaging in duties of his or her office or employment.
- 16. Participants shall not engage in any sport, game, activity, etc. on Bloomington Parks and Recreation Department property in a rough or reckless manner as to endanger, injure or damage any person or property.
- 17. No one shall climb upon trees, plants, fences, walls, or other structures or property at Bloomington Parks and Recreation Department properties except such recreational equipment as may be installed by the department and intended for use by the public.

Disruptive Behavior

The Bloomington Parks and Recreation Department expects its staff to exercise good judgement and use sensitivity when intervening with participants whose behavior is interfering with other patrons use or enjoyment of department facilities, programs, and services. In some cases, participants are simply unaware that their behavior is disruptive and a few words from a staff member are sufficient. Whenever these methods are ineffective, the following procedures may be followed in order to protect participants, department staff, and property.

- 1. The first contact with a participant should be a request to cease a specific behavior. If the participant does not cease the behavior, the staff member will repeat the request and give a verbal warning that if the behavior does not cease or is repeated, the participant will be evicted from the property for the remainder of the day. If the patron continues or resumes the disruptive behavior, the staff member will tell the participant to leave the property for the remainder of the day. Whenever possible, two staff members should be present when a participant is told to leave the property. Note: Structured programs and services, ie. Day camps have separate and distinct disruptive behavior policies.
- If a child under the age of eighteen is causing a disturbance, the appropriate parent, guardian or caregiver shall be reminded of and/or given a copy of the Department's Parental Responsibility statement.
- 3. Under extreme circumstances, disruptive participants may be suspended from Bloomington Parks and Recreation Department property, programs, and or services according to the Sanctioning Guidelines set forth below. Repeated or particularly severe behavior problems that seem to warrant harsher penalties should be referred to the appropriate supervisory staff member. If the participant is a child, the parent will be informed of this action in writing and the parent will be required to contact the appropriate supervisory staff member before the child can be readmitted.
- If a patron behaves in a violent or threatening manner, staff members may call the police immediately.

Sanctioning Guidelines

Major Violations

Assault, battery, intimidation, fighting, or other violence, theft, harassment, criminal damage to property, extreme disorderly conduct, and repetitive or consistent negative behaviors may be considered a major violation. In addition, other offenses that violate the basic safe and civil atmosphere expected at Parks facilities, programs or services may be considered to be major violations.

The following guidelines shall be used to determine sanctions for major violations:

Minor aged participants (17 yrs and under): 6 months to 1 year suspension Adult aged participants (18 yrs and over): 6 months to 1 year

Minor Violations

Disruptive behavior, use of profane language, minor infractions of house rules, and other similar behaviors may be considered minor violations.

The following guidelines shall be used to determine sanctions for minor violations:

Minor aged participants (17 yrs & under): 0 days to 1 month suspension Adult aged participants (18 yrs & over): 1 day to 3 months suspension

In determining the appropriate sanction for a major or minor violation, the department shall consider the age of the participant, the age(s) of the victim(s), the extent of damage to any property, and any other circumstances relating to the violation. If the department deems it appropriate, it may consider additional or alternative sanctions in special circumstances.

Conduct Response Policy

The following procedures shall be used in addressing violations of parks policies:

- 1. At the time that Bloomington Parks and Recreation Department staff becomes aware of the violation, staff shall address the violation with the offending participant.
- 2. Staff shall make an initial, on-site response to the participant, and shall complete incident reporters.
- 3. When appropriate, the department may augment the staff on-site response according to the Sanctioning Guidelines set out above. The participant shall be notified of department sanctions by telephone or in writing.
- 4. If the participant does not agree with the on-site response or any additional department response, the participant may submit a written appeal to the department Administrator within 14 days of the date of notification.

- 5. The Administrator shall submit the appeal to the Board of Parks Commissioners for review; however, the board may delegate the appeal to an advisory council if the board determines that the circumstances of the incident make the delegation appropriate.
- 6. Review of an appeal shall take place as an agenda item at a public meeting of the board or relevant advisory council. Upon review of an appeal, the board (or advisory council) shall take statements from the participant, Bloomington Park and Recreation Department staff, witnesses, and other interested persons. The board (or advisory council) may uphold, repeal, or modify the sanction imposed by the department. The board may, at its election, choose to review any matter heard on appeal by an advisory council.

Parental Responsibility Statement

Parents are responsible for the behavior and actions of their children while they are in Bloomington Parks and Recreation Department facilities and participating in department programs and services. Children age 7 and under must be accompanied by a parent or other responsible caregiver age 18 or older at all times while on Bloomington Parks and Recreation Department property unless the program or service is supervised by a department employee.

Dropped-Off Children

Parents should be aware that staff supervision at any Bloomington Parks and Recreation Department facility, or any pool, may be limited. No child under the age of seven shall be admitted to these facilities without adult attendance (age 10 for pools). All parents or guardians who are dropping off children at a Bloomington Parks and Recreation Department facility shall sign a release allowing medical attention in the event of an emergency.

Protocol for Violation of Tobacco Use Policy in Parks/Facilities

- 1. Staff is not expected to seek out smokers and ask them to cease smoking.
- 2. If staff notices non-compliance or another patron brings it to staff's attention, staff will request the individual to cease the activity.
- 3. Staff will not take any further action to cause a confrontation.
- 4. In extreme cases, staff can call the police for assistance.

POLICY RE: Dress Code

The following dress code guidelines are designed to ensure parks and recreation personnel (full time, or seasonal, or temporary) are presentable when they are working in the city parks, programs, and facilities. Employees represent the department and the City of Bloomington while wearing staff uniforms.

Employees are not expected to "dress up" to come to work; however, it should be understood that business casual attire is expected for those employees who represent the department at meetings, expos, conferences and when outwardly facing the public, these Thesepublic. These guidelines are a condition of employment and help to illustrate a basic safe standard of dress and level of professionalism. Each division area may add to this policy to meet the needs of their area (for example, Urban Greenspace may require long sleeve shirts, golf course may require polo shirts with a collar, etc.). Staff should It is recognized that staff dressshould dress appropriately for their work environment (for example, loading, unloading, working a program/event, etc.) and may require modify dress accordingly).

- Clothing should be neat & clean and wrinkle free without rips or tears and free of offensive language or advertisement of anything alcohol related. Shirts with graphics are prohibited.
- Shirts must not be altered, i.e. cutting off sleeves, neckline, or bottom of the shirt. Only Parks
 logo'd tshirts are acceptable as office attire. T-shirts with the Parks and Recreation logo (or
 other Bloomington Parks t-shirts) are acceptable office attire, but other graphic t-shirts
 should not be worn.

- 2-3. Parks & Recreation department uniforms will be worn on official duty and to/from work.

 They are may not to be worn while not atoutside of work (including but not limited to liquor stores or bar establishments).
- 3.4. <u>Seasonal sStaff uniforms will must</u> be returned at the <u>end-termination of their of the season</u> employment.
- 4.5. Damaged or soiled shirts will be replaced upon request.
- 5. Shirts must not be altered, i.e. cutting off sleeves, neckline, or bottom of the shirt.
- Closed toe footwear must be worn based on each division's requirements and during any program/event.
- 7. Shorts may be worn under the following conditions:

Recommendation

Staff recommends approval of a service agreement between Bloomington Parks and Recreation and Indiana University School of Public Health - Bloomington, whereas IU School of Public Health and Bloomington Parks and Recreation will identify and facilitate mutually beneficial community-based program, services, and research opportunities. No funds will be exchanged through this service agreement.

Background

This is the first service agreement between IU School of Public Health – Bloomington and Bloomington Parks and Recreation. The purpose of this Agreement is to outline a community-academic partnership which will identify and facilitate mutually beneficial community-based program, service, and research opportunities. BPRD and SPH-B desire to cooperate in the development of community-based service and research projects by sharing physical workspace.

BPRD will provide a physical workspace within their department for a SPH-B faculty member, staff member, and student. BPRD will identify priorities for the partnership and work with SPH-B to develop, implement, and evaluate programs, events, projects, research, or other initiatives that will positively impact the public health of the residents of Bloomington. BPRD will utilize the existing framework from Health First Indiana when identifying public health priorities and to ensure community partners are working in collaboration and not duplicating efforts.

SERVICE AGREEMENT BETWEEN CITY OF BLOOMINGTON PARKS AND RECREATION DEPARTMENT AND

IU SCHOOL OF PUBLIC HEALTH-BLOOMINGTON CENTER FOR COMMUNITY-ENGAGED DISSEMINATION AND IMPLEMENTATION RESEARCH

This Agreement, entered into on the last date entered on the signature lines below, by and between the City of Bloomington Department of Parks and Recreation (the "Department"), and IU School of Public Health – Bloomington Center for Community-Engaged Dissemination and Implementation Research (CCEDIR) ("Contractor").

Article 1. Scope of Services. Contractor shall provide the Services as specified in Exhibit A, "Scope of Work", attached hereto and incorporated into this Agreement. Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before July 31, 2026 unless the parties mutually agree in writing to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Shelby Drake as the Department's Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. <u>Standard of Care</u>. Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The Department shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. Responsibilities of the Department. The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. Compensation. No money exchanged.

Article 5. Appropriation of Funds. Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. Schedule. Contractor shall perform the Services according to the following schedule: Parks and Recreation Office or other determined Parks location 2-3 days per week or a minimum of 12 hours per week, beginning Aug 5, 2024 through July 31, 2026.

The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. Termination. In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department and the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 9 herein.

Article 8. <u>Identity of the Contractor.</u> Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. Ownership of Documents and Intellectual Property. All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 10. <u>Independent Contractor Status.</u> During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 11. Indemnification. Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 12. <u>Insurance.</u> During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident; c) Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest.</u> Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. Waiver. No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. Severability. The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 16. Assignment. Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. Third Party Rights. Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. Governing Law and Venue. This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. Non-Discrimination. Contractor shall comply with City of Bloomington Ordinance 2.23.100 et seq., and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment.

Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. Compliance with Laws. In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. E-Verify. Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. Notices. Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Department: City of Bloomington, Attn: Shelby Drake, 401 N. Morton, Bloomington, IN 47404. IU School of Public Health – Bloomington, ATTN: Cheryl Kilmark. Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 23. <u>Integration and Modification.</u> This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

BPRD will provide a physical workspace within their department for a CCEDIR faculty member, staff member, and student. BPRD will identify priorities for the partnership and work with CCEDIR to develop, implement, and evaluate programs, events, projects, research, or other initiatives that will positively impact the public health of the residents of Bloomington. BPRD will utilize the existing framework from Health First Indiana when identifying public health priorities and to ensure community partners are working in collaboration and not duplicating efforts.

Roles and Responsibilities:

City of Bloomington Parks and Recreation Department agrees to:

- Provide a physical workspace for one faculty member, staff member, and student for 3 days every week
- Collaborate with CCEDIR in selecting student
- Identify a plan for parking and building access for CCEDIR personnel
- Provide access to BPRD networks (i.e. internet, Google Drive, etc.)
- Provide opportunities for CCEDIR to meet and interact with BPRD staff and leadership
- Identify priorities and areas of focus for the partnership with CCEDIR
- Work in partnership with CCEDIR on the development, implementation, and evaluation of identified projects*
- Attend monthly meetings of all BPRD partners
- Represent all partners to this Agreement in a professional manner and reflect the commitment of both partners to quality services and customer satisfaction.

IU School of Public Health-Bloomington CCEDIR agrees to:

- Provide one faculty member, staff member, and student to work onsite at the BPRD 2-3 days per week, or minimum of 12 hours per week
- Provide their own computers
- Provide supervision and coaching for the onsite student
- Provide expertise, resources, and support to BPRD-identified and BPRD-led projects, programs, and research initiatives
- Lead evaluation and research efforts on identified projects*
- Coordinate all BPRD and CCEDIR partnership efforts across different areas
- Facilitate monthly meetings of all BPRD partners to share information and resources
- Represent all partners to this Agreement in a professional manner and reflect the commitment of both partners to quality services and customer satisfaction

*If grant funding is received for these projects, a new agreement will be developed detailing exchange of money between BPRD and CCEDIR.
