Regular Session Followed by Committee of the Whole on Wednesday, November 12th

There are two meeting scheduled for next Wednesday. The first is a Regular Session where four items are ready for final action and one is ready for introduction. The four items ready for final action next week include two resolutions ($\underbrace{\text{Res } 08\text{-}14}$ and $\underbrace{\text{Res } 08\text{-}15}$) that can be found in this packet, one ordinance ($\underbrace{\text{Ord } 08\text{-}12}$) that can be found in the November 5th Council Packet, and one ordinance ($\underbrace{\text{Ord } 08\text{-}21}$) that can

be found in the October 15th Council Packet. Please note that the Council will also vote on the Annual Council Schedule for 2009 at this meeting as well. The second meeting is a Committee of the Whole where the one item being introduced at the Regular Session will be discussed. That item (App Ord 08-07) can be found in this packet and is summarized herein.

Annual Schedule

The Council decided to postpone decision on its Annual Schedule from November 5th to next week. This packet includes the proposed Council Schedule for 2009 and a memo explaining it that first appeared in your November 5th Council Packet.

Here are some of the meetings or deadlines that do not follow the usual first-four-Wednesdays-a-month schedule:

- **January** proposed Organizational and Committee of the Whole on Wednesday, January 7th (rather than the first Monday of the month);
- <u>March</u> proposed doubling up meetings on the fourth Wednesday with a Regular Session immediately followed by a Committee of the Whole in order to take off during Spring Break;
- <u>April</u> The first Committee of the Whole in April falls on the first night of Passover. Rather than deciding what to do about the conflict now, the Annual Schedule notes the conflict and lets the Council take action next year when it has a better idea of the work load that month.
- Budget Meetings (May, July, and September)

This schedule proposes holding the:

- Budget Advance on Wednesday, May 13th;
- Departmental Budget Hearings on the fourth week of July (July 20th 23rd), and
- Usual budget hearings on the first and second Wednesdays in September.

Please note that the Controller's Office has confirmed these dates.

• Other Meetings in July – proposed Committee of the Whole on the fifth Wednesday (in order to avoid doubling up earlier in the month or canceling the Committee.)

- <u>November</u> proposed doubling up of Regular Session and Committee of the Whole on November 4th and November 18th because the Council will not meet on Veteran's Day (November 11th) and the Wednesday before Thanksgiving (November 25th.)
- <u>Fifth Wednesdays</u> note that there are five Wednesdays in April, July, September, and December (which affect deadlines for filing legislation and provide opportunities to shift your meetings.)

Please note that at the Internal Work Session on Friday, November 14th, members discussed the schedule and suggested that the:

- Council President and Administrator/Attorney strive to keep agendas light when the Council has scheduled two meetings in one night;
- 7:30 p.m. starting time continues to be suitable for Council members and is expected by the public; and
- Departmental Budget Hearings might be preceded by a Work Session (or two) to give Council members a chance to track their proposals and learn about any significant developments in the budget process.

New Legislation for Final Action

Item 3 – Res 08-14 (Supporting Preserve America Designation for the City of Bloomington)

Res 08-14 supports the City's application for the designation as a *Preserve America* Community. The City is pursuing the application at the request of the Indiana Division of Historic Preservation and Archaeology, which is asking all certified local governments to take this step.

According to the memo from Nancy Hiestand, the Preserve America Program promotes "preservation of cultural heritage through economic development." It began as a White House initiative in 2003 and has now been embraced by the Department of Commerce, Agriculture, National Endowment for the Humanities and Congress (which permanently authorized this program in July). It has three components: community designations, annual grants, and Presidential awards. The grants "assist local communities in the development of resource management strategies and sound business practices for the use and preservation of heritage

assets" which, according to Heistand, "promises to be advantageous to many ongoing venues in town including the Buskirk-Chumley (Theatre) and the B-Line Trail."

The resolution, in particular, says that the Common Council will:

- Apply for the designation; and
- Agree to:
 - Protect and celebrate our heritage;
 - Use our historic assets for economic development and community revitalization; and
 - Encourage people to experience and appreciate local historic resources through education and heritage tourism programs.

Item 4 – Res 08-15 (Extending Peak Oil Task Force)

Res 08-15 is sponsored by Councilmember Rollo and requests that the Council extend the Task Force until July 31, 2009. Recall that the Council established the Task Force in December 2007 via *Resolution 07-16: Establishing a Peak Oil Task Force.* Res 07-16 charges the Task Force with assessing Bloomington's vulnerability to a liquid fuels shortage and developing prudent, researched strategies to mitigate a decline in cheap oil. It also called for the Task Force to sunset once its final report is approved by both the Mayor and the Council and requires the report to be submitted no later than December 31, 2008. As explained in the accompanying *Memo* from Councilmember Rollo, his original vision was for the Task Force to commence its work in early January 2008. However, it took a while to make appointments to this Task Force and the group did not hold its first meeting until late March 2008.

Since that time, the group has met at least bi-weekly (often more frequently) to assess our community's vulnerabilities and to develop mitigation strategies. These meetings are open to the public and are broadcast on Community Access Television (CATS).

After studying reports from other communities and reflecting on what makes sense for Bloomington, the Task Force divided its analysis into the following subject-matter areas:

- The Built Environment *This category includes:*
 - Transportation
 - Housing
 - Municipal Services

- Land Use
- Sustenance
- Economy
- Energy Production

Each Task Force member has assumed responsibility for analyzing one or more of these subject areas.

The Task Force is aiming to take a comprehensive look at each of these areas. This calls for close collaboration with community stakeholders and City staff. To date, the Task Force has worked closely with Bloomington Transit, City Planning, alternative energy stakeholders, HAND, other governmental agencies and the local food production community, among others.

As pointed out by Councilmember Rollo, this sort of analysis is labor intensive. As also pointed out by Councilmember Rollo, the Task Force is composed is very dedicated and hard-working volunteers who dedicate a substantial amount of their time to this effort. It is important to the Task Force that its final report be an accurate glimpse of the current community situation and one that maps out strategies that are prudent, implementable and fully vetted by City staff and community stakeholders. For this reason, and the reason of the Task Force's delayed start date, Councilmember Rollo respectfully requests your support for this extension.

First Readings

Item 1 – App Ord 08-07 (End of the Year Appropriation Ordinance)

App Ord 08-07 is what is commonly known as the end-of-the-year appropriation ordinance. It would *transfer* monies *within* departmental budgets and, in a few instances, *add* monies to departmental budgets. The additional appropriations amount to \$353,165 which, once you account for the new revenues from grants valued at \$347,190, results in a net increase of about \$5,975. Please note, however, that because of reversions of unspent funds expected at the end of the year, this ordinance will not lead to an increase in the overall appropriations for the year.

The following summary is derived from the enclosed memo from Mike Trexler, Controller as well as conversations I've had with Mike and other City staff about the appropriations.

<u>Transfers within Departmental Budgets - No Additional Monies - Listed by Fund</u>

General Fund

Fire Department – wishes to transfer \$68,000 from Category 1 (Personal Services [Regular Salaries]) to Category 2 (Supplies [Fuel and Oil - \$16,000]) and Category 3 (Other Services and Charges [Medical - \$52,000]). This department realized some savings in salaries due to the hiring of new fire fighters at a lesser rate than the retiring fire fighters and wishes to put the money towards fuel and annual medical exams for all of its fire fighters (rather than about half of them).

Police Department – wishes to transfer \$14,986.50 from Category 4 (Capital Outlays [Motor Equipment]) to Category 2 (Supplies [Other Supplies - \$12,000]) and Category 3 (Other Services and Charges [Line 399 - Other Services and Charges - \$2,986.50]). This department wishes to use about \$15,000 in unspent funds for motor vehicles to purchase and install equipment for the new firing range and training facility. (See below for appropriation of grant funds.)

Animal Care and Control Division – wishes to transfer of \$10,000 from Category 1 (Personal Services [Regular Salaries - \$5,000 and Overtime Salaries - \$5,000]) to Category 2 (Supplies [Institutional and Medical - \$5,000]) and Category 3 (Other Services and Charges [Natural Gas - \$5,000]). This department realized some savings due, in part, to turnover of personnel early in the year and wishes to use it to pay for various medical supplies and for natural gas to operate its incinerator. Please note that the funds for the latter are due to the increased cost of natural gas and not the increased use of the incinerator.

Public Works Department – wishes to transfer \$55,000 from Category 3 (Other Services and Charges [Postage - \$27,000] and [Electrical Services - \$28,000]) to Category 4 (Capital Outlays [Other Capital Outlays]). This department realized significant savings in regard to heating and cooling City Hall and has unspent funds in the postage line which it wishes to use to replace the City's old and failing voice mail system.

Planning Department – wishes to transfer \$8,600 from Category 3 (Other Services and Charges [Consultants and Workshops]) to Category 1 (Personal

Services [Regular Salaries and Wages]). This department placed some contingency funds in its consultants line to cover unforeseen projects. Funds for such projects were not needed this year and Planning wants to shift this money to another line in order to provide for some possible, end-of-the-year payroll expenses.

Parks General Fund

Parks and Recreation Department – wishes to transfer \$25,904 from Category 2 (Supplies [Motor Vehicle Repair]) to Category 3 (Other Services and Charges [Lease Payments]). This department recently purchased new golf carts and wishes to use the savings in the maintenance of carts to make the lease payments.

Risk Management Fund

Risk Management Department – wishes to transfer \$48,000 from Category 1 (Personal Services [Regular Salaries]) to Category 3 (Other Services and Charges [Special Legal Services]). The department experienced turnover and deferred hiring one position in order to provide funds for outside counsel on a matter that is now resolved.

Fire Pension Fund

Fire Department – wishes to transfer \$100 from Category 3 (Other Services and Charges [Line 399 – Other Services and Charges]) to Category 1 (Personal Services [Employee Benefits – FICA]) in order to pay for payroll expenses associated with a new Pension Secretary.

Sanitation Fund

Sanitation Department – wishes to transfer \$41,600 from Category 1 (Personal Services [Regular Salaries and Wages - \$40,000]) and Category 3 (Other Services and Charges [Landfill Fees - \$1,600]) to Category 2 (Supplies [Fuel & Oil - \$40,000] and [Other Supplies - \$1,600]). This department realized some savings due, in part, to employee turnover this year and wishes to use the unspent funds for fuel and liners for trash receptacles in the downtown area.

Increased Appropriations – General Fund

<u>General Fund - \$347,190 Covered by Grants and \$5,975 Taken from Reserves</u>

Office of City Clerk - is requesting an additional \$4,000 for Category 1 (Personal Services [Regular Salaries and Wages - \$3,500]) and Category 3 (Other Services and Charges [Advertising - \$500]). The funds for personnel will help cover the costs due to unforeseen leaves of absence and the funds for advertising will help cover the cost of advertising public hearings and ordinances.

Office of Common Council – is requesting an additional \$1,975 for Category 1 (Personal Services [Temporary Salaries and Wages - \$1,350]) and Category 3 (Other Services and Charges [Temporary Contractual Employment - \$625]). Funds were spent to help the Peak Oil Task Force over the summer and are now needed to cover the costs for the Council Office intern for the rest of the year (\$1,350). The Council Office also began participating in the SPEA Core Fellow program this year and needs money to fund the fall semester (\$625).

Information and Technology Services (Grants) – received a \$3,000 grant from the Indiana Geographic Information Council (IGIC) and wishes spend the money to purchase a server (Category 4 [Capital Outlay - Purchase of Equipment]) for the IGIC Address Integration Pilot Program. This program will foster the sharing of addresses and their geographical coordinates with the State and, thereby, help with emergency response and other services.

Police Department (Grants) – received a \$344,190 Community-Oriented Policing Services (COPS) grant from the Department of Justice to purchase 800 MHz radios. As you may recall, the department purchased some of these radios a few years ago and obtained an appropriation to purchase the rest in 2006. However, soon after the appropriation, the department learned of this opportunity to be reimbursed for the purchase of these radios and now seeks funds for this purpose. These radios cost about \$4,000 a piece and allow police officers to communicate with each other and officers of other agencies without going through central dispatch.

SYNOPSIS

The City of Bloomington, as a certified local government, was asked to apply for Preserve America designation by the Indiana Division of Historic Preservation and Archaeology. In order to recognize the City of Bloomington's substantial efforts to steward endangered historic properties and to further its lengthy advocacy of heritage tourism as an economic development tool, the City will request this designation. The Preserve America program offers competitive grants to assist communities in the successful redevelopment of historic properties and areas.

RE: Resolution in support of the Preserve America Application for the City of Bloomington Certified Local Government

A White House Executive Order established the Preserve America Program in 2003. It has evolved to include three major components: community designations, an annual grants program, and Presidential Awards.

A principal objective of the Preserve America program is to promote preservation of cultural heritage sites through economic development. Although for several years the program was unfunded, in the last three years money has become available for grants. Unlike the Historic Preservation Acquisition and Development funds that have been used locally to improve the Coca Cola Building, Banneker Center, Indiana University's Legg House, and the Hinkle Garten Farmstead, Preserve America money is not intended for building restoration. Instead funds assist local communities in the development of resource management strategies and sound business practices for the use and preservation of heritage assets. Several other departments of the federal government work in support of this initiative, including the Department of Commerce, Agriculture, and National Endowment for the Humanities among others... In 2008, the program awarded more than \$4.3 million to 44 projects in 24 states. The grants range from \$20,000-\$150,000. Successful applications include marketing strategies for heritage tourism, the development of heritage trails, film shorts, web sites and podcasts. This promises to be advantageous to many on-going venues in town including the Buskirk-Chumley and the BLine Trail.

In July of this year the Congress permanently authorized the Preserve America Program. In summary the stated goals of the program are to endorse and promote a "greater shared knowledge about the nation's past, strengthened regional identities and local pride, increased local participation in preserving the country's cultural and natural heritage assets, and support for the economic vitality of our communities." In Indiana there are currently 14 Preserve America Communities, ranging from county governments to larger organized neighborhoods within cities. The Indiana Division of Historic Preservation and Archaeology has requested that all certified local governments in the state of Indiana complete an application this year.

RESOLUTION 08-15

EXTENDING THE WORK OF THE BLOOMINGTON PEAK OIL TASK FORCE

Attached please find a copy of <u>Resolution 08-15</u>: Extending the Work of the Bloomington Peak Oil Task Force. The Task Force has worked diligently since late March to analyze our community's vulnerability to a decline in cheap oil and work through ways to make our community more oil independent. This sort of analysis requires a deliberate and thorough examination of key community systems. In the interest of generating the best and most pragmatic report possible, the group respectfully requests that the Common Council extend the work of the Bloomington Peak Oil Task Force until July 31, 2009.

The Council established the Task Force in December 2007 by way of <u>Resolution 07-16</u>: *Establishing a Bloomington Peak Oil Task Force*. Appointments were made to the Task Force in late March 2008 and since that time, the Task Force has met at least bi-weekly to identify our community's vulnerabilities and to develop prudent and researched mitigation strategies.

The Task Force has parsed its analysis up into specific community sectors for examination. Each Task Force Member has assumed the lead role in analyzing at least one of the following subject-matter areas:

- The Built Environment (Travis)

 This category includes: "Transportation" (Glaser & Silberstein); "Housing" (Kimball);

 "Municipal Services" (Rollo) and "Land Use" (Rollo & Travis)
- Sustenance (Bane)
- Economy (Charbonneau)
- Energy Production (Silberstein & Kimball)

While the group has started to shift from needs assessment to solutions, it is still largely in the thick of analyzing community vulnerabilities. Toward that end, it has researched answers to over 150 questions it posed early in its tenure. Once these questions are unpacked and scrutinized, the Task Force will outline a pragmatic action plan. The plan will fall out into short, medium and long-term recommendations.

A key part of the group's approach to a systemic review of City practices, is working in close communication with community stakeholders and City staff. To date the group has hosted the following guest speakers: Lew May (General Manager, Bloomington Transit), Michael Simmons (Parks and Recreation), Tom Micuda (Planning) and Terry Usrey (Southern Indiana Renewal Energy Network [SIREN]). The Task Force also plans to discuss a post-peak economy with the Chamber of Commerce and the Bloomington Economic Development Corporation.

The group also relies on public participation and a transparent approach to problem-solving: all meetings are noticed, open to the public, provide for public comment and are broadcast on Community Access Television (CATS).

The Task Force is comprised of hard-working and deeply-committed volunteers. I respectfully request that you permit them to extend their work until July 31, 2009.¹

Please note that the accompanying letter from the Task Force requests extension until June 30, 2008. As late June's Council agenda is already substantial, Council staff recommends the Task Force present its report to the Council in late July 2008.

- WHEREAS, the Public Works Department desires to transfer funds from Classification 3 Services and Charges to Classification 4 Capital Outlays for a new voice mail system; and
- WHEREAS, the Planning Department desires to transfer funds from Classification 3 Services and Charges to Classification 1 Salaries & Wages for possible end of year payroll needs; and
- WHEREAS, the Information Technology Services Department has received and wishes to expend a grant from the Indiana Geographic Information Council (IGIC) and would like to appropriate these funds to purchase server hardware to participate in the IGIC's Address Integration Pilot Program; and
- WHEREAS, the Police Department has been awarded and wishes to expend a grant from the Office of Community Oriented Policing Services (COPS) within the Justice Department for the purchase of 800 MHz radios; and
- WHEREAS, the Common Council Office desires to increase its budget in order to fund a regular Council Office intern and a SPEA Service Corp Fellow for the remainder of the year; and
- WHEREAS, the City Clerk office desires to increase its budget for personnel and advertising;

Re: Appropriation Ordinance 08-07

Appropriation Ordinance 08-07 is our comprehensive 2008 year end appropriation. The total Appropriation comes to \$353,165. \$347,190 of this amount will be reimbursed through grants. The remaining \$5,975 will be entirely offset by 2008 reversions (savings).

- 1. **General Fund Fire.** The Fire Department has requested to transfer \$68,000 from Line 51110 Salaries & Wages Regular to Line 52240 Fuel & Oil (\$16,000) and Line 53130 Medical (\$52,000).
- 2. **General Fund Police.** The Police Department has requested to transfer \$14,986.50 from Line 54440 Motor Equipment to Line 52420 Other Supplies (\$12,000) and Line 53990 Other Services and Charges (\$2,986.50).
- General Fund Animal Care & Control. The Animal Care & Control Department has requested to transfer \$5,000 from Line 51110 – Salaries & Wages – Regular to Line 52210 – Institutional & Medical, and \$5,000 from Line 51130 – Salaries & Wages – Overtime to Line 53540 – Natural Gas.
- 4. **General Fund Public Works.** The Public Works Department has requested to transfer \$27,000 from Line 53220 Postage and \$28,000 from Line 53510 Electrical Services to Line 54510 Other Capital Outlays (\$55,000).
- General Fund Planning. The Planning Department has requested to transfer \$8,600 from Line 53170 Consultants and Workshops to Line 51110 Salaries & Wages Regular.
- 6. General Fund ITS. The Information Technology Services Department has received a \$3,000 grant from the Indiana Geographic Information Council (IGIC) and would like to appropriate the full amount into Line 54420 – Purchase of Equipment. These funds will be used to purchase server hardware to participate in the IGIC's Address Integration Pilot Program.
- 7. **General Fund Police.** The Police Department has been awarded and wishes to expend a grant from the Office of Community Oriented Policing Services (COPS) within the Justice Department for the purchase of 800 MHz radios. COPS will reimburse the department up to \$344,190 after the equipment has been purchased.

- 8. **General Fund Council.** The Common Council Office desires to increase its budget by \$1,350 in Line 51120 Salaries and Wages Temporary and \$625 in Line 53960 Grants in order to fund a regular Council Office intern and a SPEA Service Corp Fellow for the remainder of the year.
- 9. **General Fund Clerk.** The City Clerk office desires to increase its budget by \$3,500 in Line 51110 Salaries & Wages Regular and \$500 in Line 53960 Grants for personnel and advertising.
- Parks General Fund. The Parks & Recreation Department has requested to transfer \$25,904.50 from Line 52320 – Motor Vehicle Repair to Line 53840 – Lease Payments.
- 11. **Risk Management Fund.** The Risk Management Department has requested to transfer \$48,000 from Line 51110 Salaries & Wages Regular to Line 53120 Special Legal Service.
- 12. **Fire Pension Fund.** The Fire Department has requested to transfer \$100 from Line 53990 Other Services and Charges to Line 51210 FICA.
- 13. **Sanitation Fund.** the Sanitation Department has requested to transfer \$40,000 from Line 51110 Salaries & Wages Regular to Line 52240 Fuel & Oil, and \$1,600 from Line 53950 Landfill Fees to Line 52420 Other Supplies.

The grand total of the appropriation is \$353,165. Of that amount, \$347,190 will be offset grants.
