A. YIMBYana

A representative, Matt Gleason, from YIMBYana expressed that the organization is interested in removing parking mandates, reducing lot size, increasing density per lot, increasing mixed use zoning, and improving mobility infrastructure for public transport, among other things.

David asked about parking mandates, and the representative clarified that currently businesses are required to have a certain number of parking spaces, and YIMBYana is not in favor of this requirement.

Shannon and Megan M asked about the logistics of advocating for additional criteria beyond what was outlined in the letter, and the representative explained that support for more specific policies down the line would be welcome, but that the letter was kept broad intentionally.

Adam, who helped draft the letter, clarified that signatures are intended to display support of the general outline, and that more specific policies would be advocated for on a case by case basis down the line.

Carrie commented that it is important to be thinking about access for people with disabilities, who may not have bike-riding options, or access to other traditionally environmentalist alternatives.

Shannon asked for more information about the organization YIMBYana. Our guest explained that they are a new organization with focus on advocating for increasing density, housing equity, and affordability.

Matt said that upon second look of the packet, it appears that the EC is being asked to sign support for the first sentence and the first sentence of the last paragraph, and not every single detail laid out in the letter. It was agreed that signing the letter would indicate support for the spirit of the organization's goals in congruence with environmental issues, and not any specifics beyond that. Matt stated that he was comfortable with signing the letter as is.

Carrie asked what groups have been asked for support so far, and the guest answered that individuals from city council and the affiliate national organization were looking to discuss further opportunities for finding support.

Shannon suggested that some of the language could be cut so that it does not appear that the EC is endorsing every individual policy goal.

Megan M motioned to postpone voting on the letter until next month. David seconded the motion. All present voted yes. The motion passed.

B. Invasive Amendment

Rachael provided background on the letter and offered to answer questions. David motioned to approve the letter as is, Matt seconded the motion. All present voted yes. The motion passed.

A. WFHB Public Service Announcement

WFHB suggested the EC be involved in the activate program for a 5 minute segment. We are a housing advocacy group focused on housing affordability, alongside issues relating to the urban environment, like transit access, walkability, and environmental sustainability.



- Entire staff Hoosier Riverwatchtrained
- Monthly sampling

Illicit Discharge Uptick

- Better communication with City
 Departments more reports
- Utility strikes throughout the City
- 10 discharges in 2023, 34 in 2024 so far
- Enforcement, especially on repeat violators, has escalated





Post-Construction Inspections

- IDEM requires that all postconstruction BMPs be inspected every 5 years.
- Bloomington has aging stormwater infrastructure not functioning well
- The challenge: compliance for privately-owned infrastructure (HOAs, citizen-owned)

Green Infrastructure Crew

- Maintain green and grey infrastructure that is Cityowned
 - Rain gardens
 - Hydrodynamic separators
- Dredging project at Miller Showers and maintenance activities for the 6 hydrodynamic separators
- 2 new rain gardens in 2024, additional proposed in future



Goals Going Forward

- Implement full street sweeping plan in 2025
- Begin system-wide assessment of all storm infrastructure
- Complete design manual that is a companion to Title 13
- Continue to educate designers, developers, landscapers, HOAs, and homeowners on water quality best practices



Questions and Discussion



2.12.050 Environmental Quality and Conservation Commission.

- (1) Purpose. It is declared to be the public policy of the City of Bloomington and the purpose of this section to achieve and maintain such levels of environmental quality as will protect human health and safety, and to the greatest degree practicable, prevent injury to plant and animal life and property, foster the comfort and conveniences of the people, promote the economic and social development of Bloomington and facilitate the enjoyment of the natural attractions of the City of Bloomington.
- (2) Definitions. As used in this section unless the context clearly requires otherwise:
 - (a) "Environment" means the sum total of the physical, chemical and biological factors affecting the populace of the City of Bloomington and the surrounding community.
 - (b) "Pollution" means the presence in the environment of one or more contaminants, or noise, in such quantities, characteristics or duration as is or tends to be injurious to human health or welfare, or property, or would interfere with the enjoyment of life or property.
 - (c) "Commission" means the Bloomington Environmental Quality and Conservation Commission, as created in this section.
 - (d) "Person" means any individual, partnership, co-partnership, firm, company, public or private corporation, association, trust, estate, or any agency, board, department or bureau of the city or any other legal entity.
 - (e) "Bloomington" means the City of Bloomington, its corporate limits, and any areas within its legal purview.
- (3) Appointments. The commission shall consist of twelve members, six appointed by the mayor and six appointed by the common council.
- (4) Qualifications. Preference for appointments shall be given to persons with expertise in one or more areas of physical sciences, biological sciences, engineering, business, sanitation, public health, conservation, and recreation.
- (5) Meetings. The Commission shall meet a minimum of once each month.
- (6) Powers and Duties. The Commission shall have the following powers and duties:
 - (a) To adopt administrative rules and regulations for the conduct of its business.
 - (b) To hold hearings relating to any aspect of or matter in the administration of this section and in cases of non-compliance request the city legal department to take legal action.
 - (c) To retain, employ, provide for, and compensate, within appropriations available thereof, such consultants, assistants, deputies, clerks, technical and other employees, on a full or part-time basis as may be necessary to carry out the provisions of this section and prescribe the times at which they shall be appointed, the duration of their appointments and their powers and duties.
 - (d) To secure necessary scientific, technical, administrative and operational services including laboratory facilities, by contract or otherwise with any educational institution, experiment station, or any board, department, or other agency of any subdivision of state or the federal government.
 - (e) To determine by means of field studies and sampling the degree of pollution in Bloomington.
 - (f) To encourage and conduct studies, investigations, and research relating to pollution and its causes, effects, prevention, abatement and control in Bloomington, and make recommendations to the appropriate public and private bodies with respect thereto.

- (g) To classify contaminant sources, which in the commission's judgment may cause or contribute to pollution.
- (h) To prepare and develop a comprehensive plan or plans for the prevention, abatement and control of pollution in Bloomington.
- To encourage voluntary cooperation by persons and affected groups to achieve the purposes of this section.
- (j) To collect and disseminate information and conduct educational and training programs relating to pollution and environmental quality and conservation.
- (k) To advise, consult, contract and cooperate with other agencies of the State and the City of Bloomington, other local governments, industries, other states, interstate or interlocal agencies, and the federal government, and with interested persons or groups.
- (I) To apply for, accept, receive and administer grants or other funds or gifts from public or private agencies including the state and federal governments for the purpose of carrying out any of the provisions or purposes of this section. Such funds received by the commission pursuant to this subdivision shall be deposited in accordance with the administrative regulations of the commission. The commission is authorized to promulgate such rules and regulations or enter into contracts as it may deem necessary for carrying out the provisions of this subdivision.
- (m) To make appropriate inquiry into and give constructive consideration to the operations and policies of all departments and governmental branches of the City of Bloomington concerning their adherence to a commitment for environmental quality and the conservation of natural resources.
- (n) To prepare reports and recommendations to the mayor, common council, board of public works, and the planning commission as needed.
