- 3. Staff update Holly
 - a. Public Art Database is now in development
 - i. currently all data is collected in a spreadsheet and will eventually turn into a complete map
 - ii. Map will be used to plan future Public Art Projects, specifically focused on finding areas with little to no public art currently
 - b. \$16 million has been granted by Lilly Foundation for development of the Trades District with stipulation that public art be incorporated
 - c. \$500,000 will be allocated (from 1% for the arts budget) to the convention center being built specifically to have a public art component
- 4. Presentation- Benjamin Rardin, Reimagining Opera for Kids
 - a. Nonprofit that provides workshops and entertainment for kids which double as performance opportunities for musicians, singers, and actors in the community
 - b. All programs are free, almost all involved are volunteers
 - c. Generally programs occur in schools during school hours, featuring 4-6 performers, followed by a Q&A
 - d. Most compositions are created and adapted specifically for ROK, so content is more modern; sometimes kids are included in the narrative writing process
