Two Items Ready for Final Action and Two Items Ready for Introduction at the Regular Session on May 21st

There are two items ready for final action and two items ready for introduction at the Regular Session next week. The two items ready for final action include <u>Ord 08-08</u>, which can be found in the <u>7 May 2008 Legislative Packet</u>, and <u>Res 08-07</u>, which can be found in this packet. The two items ready for introduction include <u>App Ord 08-02</u> and <u>Ord 08-09</u> which can be found in this packet and are summarized below (along with the aforementioned resolution).

Final Actions:

Item Two - Res 08-07 - Appointing Agent to Accept Pension Liability

The second item ready for final action is **Res 08-07**. It appoints certain persons to certify records for the Public Employee Retirement Fund (PERF) for the City's three pension accounts and is necessary now because our former Controller, Susan Clark, served in that capacity. Please note that the City's three pension accounts are for: 1) the main City of Bloomington, 2) the City of Bloomington Utilities, and 3) the Bloomington Public Transit Corporation (BPTC).

According to I.C. 5-10.2-3-1(1)(e), the Council must perform those tasks or appoint an agent to do so. Given the recent departure of Susan Clark, this resolution appoints Michael Trexler, the new Controller, as well as Daniel Grundmann, Director of Employee Services, the pension agents for first two accounts. It also appoints Christa Browning, Controller of the Bloomington Public Transit Corporation, the pension agent for the third account.

First Readings:

Item One – <u>App Ord 08-02</u> – Appropriating Monies from the General Fund, Parks General Fund, Parks Land Acquisition Fund, and Risk Management Fund

<u>App Ord 08-02</u> is the first appropriation ordinance coming forward under our new Controller, Mike Trexler. It appropriates \$232,000 from the General Fund, Parks General Fund, Parks Land Acquisition Fund and Risk Management Fund. The following paragraphs rely on Trexler's Memo to the Council and briefly explain these appropriations.

General Fund – Appropriate \$11,000 of Unspent Jack Hopkins Social Services Funds from 2007 for Use in 2008

The Jack Hopkins Social Services Funding (JHSSF) Committee requested the reappropriation of an unspent grant funds from 2007 for use in 2008. Earlier this year the Committee declined a first-ever request to modify and extend an \$11,000 unspent grant from 2007 through the end of 2008. The Committee would have preferred to have these funded used during the original funding cycle but, absent that, wished to make the money available for allocation in 2008. The JHSSF program awards funds addressing local social services needs on a competitive grant basis and will be presenting its recommendations for allocation of \$165,000 (plus this appropriation if approved) in the form of a resolution on June 18th.

Parks General and Land Acquisition Funds - Reimburse the Parks General Fund for \$21,000 Spent to Pave Site of Former Motorcycle Shop at Cascades Park

The Parks and Recreation Department acquired the site of the former motorcycle shop in Cascades Park and paved over the area as part of the remediation required by the Indiana Department of Environmental Management. The funds for acquiring and remediating the site were placed in the Parks Land Acquisition Fund last year. The paving, however, was done this Spring by Public Works with monies provided from the Parks General Fund. This appropriation reimburses the Parks General Fund for this outlay with monies from the Parks Land Acquisition Fund.

Risk Management Fund - Appropriate \$200,000 to Cover Worker's Compensation Expenses

The Employee Services Department has requested an additional \$200,000 from the Risk Management Fund to cover unanticipated Worker's Compensation expenses. The City budgeted \$300,000 for Worker's Compensation expenses in 2008 which, although sufficient based upon past trends, will not cover the costs of a few expensive incidents. The Risk Management Fund was budgeted for approximately \$679,000 this year and covers tort claims, safety management programs, and non-health-related insurance for the City along with Worker's Compensation. This appropriation will leave approximately \$100,000 cash balance in the Fund at the end of the year – which amounts to about two months worth of the annual expenditures.

Item Two – Ord 08-09 – Amending the City of Bloomington Salary Ordinance for 2008 (Ord 07-18) - Regarding Jobs in the Employee Services, Public Works, Parks and Recreation, and Utilities Departments

Ord 08-08 amends Ord 07-18 which established the salaries for appointed officers, non-union and A.F.S.C.M.E. employees for all the departments in the City for 2008. These amendments affect jobs in the Employee Services, Public Works, Parks and Recreation, and Utilities departments. They come forward as a result of revised job descriptions that department heads submit to the Employee Services department. Daniel Grundmann and Jean Joque, Manager of Training and Organizational Development, then review them and convene the Job Evaluation Committee (JEC) to assign a grade to jobs with significant changes in duties. Please note that the JEC is comprised of employees from almost every department and across most grades. The following paragraphs draw upon the Memo from Daniel Grundmann, Director of Employee Services, to explain these proposed amendments.

Employee Services – Two Upgrades

Benefits Manager – Upgrade from Grade 7 to 8 More involvement with the financial analysis of the health care plan and the administration of the Worker's Compensation and Family Medical Leave Act (FMLA) have made the job of Benefits Manager more complex and led the JEC to recommend the increase in grade from 7 to 8.

Office Manager – Upgrade from Grade 3 to 4 Revisions in the job description to reflect supervisory duties led to the increase in grade – which is consistent with other Office Manager positions within the City.

Fiscal Impact: These changes will not require an additional appropriation and would amount to \$5,908 in 2008 if they had been made at the beginning of the year. While we are almost half-way through the year, the Memo from Grundmann calculates the costs of these changes on an "annualized basis" in order to provide a gauge of future costs.

Public Works – Two Upgrades with One Change in Title

Traffic: Assistant Traffic Control Specialist – Change Title to "Assistant Traffic Control Manager" and Upgrade from 4 to 5 The Public Works department renamed and rewrote the description for this job and, upon review, the JEC concluded that the increase in responsibility for traffic signal operations warranted the upgrade from 4 to 5.

4 to 6 The JEC concluded that the greater duties connected with project management, inspection, and public education for both public construction and private development led to an increase in the complexity, experience, independent judgment and consequences associated with the position and warranted the upgrade from 4 to 6.

Fiscal Impact: These changes will also not require an additional appropriation and would amount to \$13,845 in 2008 (on annualized basis).

Parks and Recreation – One Upgrade and Downgrade with Two Changes in Title

Youth Services Coordinator (Vacant Position) – Change Title to "Health/Wellness Coordinator" and Reduce Grade from 7 to 6

The Parks and Recreation department took advantage of some vacancies to review its organizational structure and revise several job descriptions and one job title. The JEC agreed that the new Health/Wellness Coordinator job should be at Grade 6.

Working Foreman – Change Title for One of Six Positions to "Crew Leader" and Upgrade It from 108 to 110 The Parks and Recreation Department also changed one Working Foreman to a Crew Leader to better reflect leadership responsibilities and the JEC concluded the changes warranted an upgrade fro 108 to 110.

Fiscal Impact: On an annualized basis, these changes would result in a *reduction* of \$9,893 in 2008.

Utilities – One Upgrade with Change in Title and One Additional Budgeted, But Unlisted Job

Accounting and Finance: Budget/Research Analyst (Vacant Position) – Change Title to "Accounting Manager" and Upgrade It from 6 to 7

The Utilities Department changed the title of this vacant position and expanded its duties to include more in-depth review of financial documentation and the reconciling of transfers between the water, wastewater, and storm water utilities. The JEC recommended an increase in grade from 6 to 7.

Customer Relations: Customer Relations Representative – Add One Position to Reflect One Budgeted, But Unlisted Position (Now 4) The Employee Services department discovered that the City had budgeted for four Customer Relations Representatives but had only included three in the salary ordinance. This amendment corrects that oversight.

Fiscal Impact: The Memo indicates that the fiscal impact of these changes will be "negligible."

RE: Public Employees' Retirement Fund

An Indiana state law provision, related to the Public Employees' Retirement Fund ("PERF"), authorizes municipalities to name agents for the purpose of accepting pension liability on their behalf. The City of Bloomington ("City") previously named former City Controller Susan Clark as its sole agent, via a resolution passed by the Common Council of the City of Bloomington. Ms. Clark's recent resignation requires the City to name a new agent or agents.

The resolution presented to you names City Controller, Mike Trexler, and Employee Services Director, Daniel Grundmann, as the City's agents. State law does not limit the number of possible agents. It seems appropriate to have more than one named agent so that, in the absence of one agent, the City remains covered. A connection exists between the PERF accounts for the City and Bloomington Public Transit Corporation ("BPTC"); therefore, this resolution also names BPTC's agent. Christa Browning, BPTC's controller, shall remain their sole agent.

WHEREAS, the Housing and Neighborhood Development Department desires to increase its budget

money from the Parks Land Acquisition Fund to the Parks General Fund in order to

pave the motorcycle shop at Lower Cascades; and

WHEREAS, the City has determined the need to appropriate additional funds for Worker's

Compensation and a sufficient balance remains in the Risk Management Fund to pay

these expenses;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. For the expenses of said municipal corporation, the following additional sums of money are hereby appropriated and ordered set apart from the funds herein named and for the purposes herein specified, subject to the laws governing the same:



Lastly, it appropriates money from the Risk Management Fund for Worker's Compensation (to fund additional expenses).

Re: Appropriation Ordinance 08-02

General Fund – Housing and Neighborhood Development. The Jack Hopkins Social Services Funding (JHSSF) Committee is requesting that \$11,000 of unspent grant funds from 2007 be reappropriated for use in 2008. The Committee recently heard a request from one agency that wished to modify its \$11,000 grant and extend it until the end of 2008. None of these funds were utilized in 2007. The Committee decided to deny the request due to concerns for setting the precedent of allowing money to lie fallow for the whole funding cycle while not being made available to other agencies that were in a position to use it. This reappropriation will allow the Committee to add this amount to its 2008 awards.

Parks General Fund & Parks Land Acquisition Fund. The final step of the acquisition and remediation of the former Motorcycle Shop property in Cascades Park included paving over the site after the building was removed. Cost of the paving was included as part of the acquisition of the site which was paid for by the land acquisition fund approved by Council. The paving plants closed last fall before this work could be done. Public Works staff completed the paving earlier this spring when it fit into their work schedule. Parks paid for the paving materials out of the parks general fund. This appropriation pays back the parks general fund from the land acquisition fund as originally intended as part of this transaction.

Risk Management Fund. The Employee Services Department has requested an additional appropriation of \$200,000 from the Risk Management Fund in order to cover Workers Compensation (W/C) expenses. After authorization of this appropriation, the projected year end cash balance in the Risk Fund will be approximately \$100,000 which is approximately equal to a two month reserve.

The grand total for this appropriation is \$232,000. Sufficient balances exist in each of these funds to support the appropriation request. Feel free to contact me by email at trexlerm@bloomington.in.gov or by phone at 349-3412 at any time.

The Jack Hopkins Social Services Funding (JHSSF) Committee met on February 28, 2008 to review the program for 2008 and, among many other actions, decided to request that \$11,000 of unspent funds from 2007 be reappropriated for use in 2008.

During that meeting, the Committee heard a request from one agency that wished to modify its \$11,000 grant and extend it until the end of 2008. After considerable discussion, the Committee decided to deny the request (largely out of concern for setting the precedent of allowing money to lie fallow for the whole funding cycle while not being made available to other agencies who were in a position to use it.)

At the same time, in recognition of the strong evidence of unmet needs for social services in this community, the Committee decided to respectfully request the reappropriation of these funds for allocation in 2008.

A brief background on the JHSSF program may be in order here. This grant program began in 1993 at the behest of former Councilmembers Jack Hopkins, John Fernandez and others. Since that time, the City has allocated over \$1.3 million through competitive grants to applications that:

- Address a gap identified in a community-wide survey of social services needs;
- Request a one-time investment in a program or project that is leveraged by other contributions;
 and
- Will lead to broad and long-lasting effects.

The Committee also wanted to express its appreciation to the Mayor for increasing the appropriation for this program in 2008 from \$145,000 to \$165,000 and notes that this \$11,000 appropriation (of reverted funds) would bring the amount available this year to \$176,000. Since that meeting in February, the Committee received 29 applications requesting a total of about \$384,446 and decided to hear presentations on May 9th from 20 agencies who are requesting about \$336,272. Later this month (on May 22nd) the Committee should make its recommendations to the Council, which is scheduled to consider them in the form of a resolution on June 18th.

Please note that this program is done in cooperation with the HAND Department which helps agencies with their applications (upon request), aids in the deliberations, and monitors the implementation of the grants. For this reason, the appropriation would go into Line 399 (Grants) of the HAND Department's budget.

This ordinance amends the City of Bloomington Salary Ordinance for the year 2008 (Ordinance 07-18). The amendments change the grades of the Benefits Manager and Office Manager (Employee Services) along with the Engineering Field Specialists and the grade and title of the Assistant Traffic Control Specialist (Public Works Department). The amendments also change the grade and title of the Youth Services Manager and one of the Working Foremen positions (Parks and Recreation), converting them to Health/Wellness Coordinator and Crew Leader respectively. They also change the grade and title of the Budget/Research Analyst (Utilities), and include the addition of a Customer Service Representative, which was accounted for in the 2008 budget but not added to the Salary Ordinance.

We respectfully request the following changes to the 2008 Salary Ordinance (07-18).

Employee Services

The *Benefits Manager* position has evolved over the last two years and involves greater participation in financial analysis of the health care plan, and administration of Worker's Compensation and FMLA. The result is an in increase in complexity as determined by the Job Evaluation Committee (JEC) and a request for a grade change from 7 to 8. The *Office Manager* position also received review from the committee due to job description revisions. Those revisions reflected supervisory duties that were previously not captured and drove the recommendation to change the grade from 3 to 4, consistent with other Office Manager positions in the organization. The total estimated annualized budgetary impact for these positions, including PERF and FICA, is \$5,908. No additional appropriation is required.

Public Works

In the Traffic Division the *Assistant Traffic Control Specialist* position was reviewed due to increased responsibility associated with traffic signal operations. The JEC review process resulted in a recommendation of grade change from 4 to 5.

In the Engineering Division the *Engineering Field Specialist* position was reviewed to reflect significantly enhanced duties with project management, inspection, and public education in relation to construction and development. The increased complexity, experience required, independent judgment and consequence of errors drove the JEC review and subsequent recommendation to change the grade from 4 to 6.

The total estimated annualized budgetary impact for these positions, including PERF and FICA, is \$13,845. No additional appropriation is required.

Parks and Recreation

Due to position vacancies the Parks and Recreation Department reviewed organizational structure and made changes to several positions. One of the positions was altered significantly and required review by the JEC. The Parks Department would like to change the title of *Youth Services Manager* to *Health/Wellness Coordinator* and reduce the grade from 7 to 6.

Additionally, we would like to change one Working Foreman (grade 108) position in Parks and Recreation to a Crew Leader (grade 110) to better reflect leadership responsibilities of the position and the evolving needs of the Operations Division.

The total annualized budgetary impact for these positions, including PERF and FICA, is a reduction of \$9,893.

Utilities

The Utilities Department has revised the *Budget/Research Analyst* position to better reflect the current duties of the position. Those changes include, among others, analyzing, interpreting, and verifying financial documentation and assuming responsibility for inter-related transfers of monies between water, wastewater, and storm water utilities in order to repay amounts advanced from or due to these utilities. The JEC recognized increased complexity and independent judgment which resulted in our request of a grade change from 6 to 7. We also seek approval for a title change to *Accounting Manager*. There is no current incumbent, thus fiscal impact is undetermined. It will likely be negligible and no additional appropriation is required.

Additionally, Utilities would like to add a Customer Service Representative position to the salary ordinance. It was included in the budget but left out of the salary ordinance. There is no fiscal impact and no additional appropriation is required.
