Background

This inquiry is in response to a concern brought to our attention by the Street Department about a northbound stop sign on Fairview Street. An additional request for signs telling the northbound traffic not to turn east on Wylie Street because it is one way.

During the investigation into the concern stated by the Street department about the stop sign, staff notice no stop signs on Fairview Street are in code, yet one exists for southbound traffic. The road is currently one way on S Fairview Street from 1st Street to E Wylie Street and switches to two way traffic at E Wylie Street.



The picture above shows the existing condition of the Fairview Street & Wylie Street intersection.



The picture above shows the engineering recommendation for Fairview Street & Wylie Street intersection.

We assumed Fairview Street was one way due to a wall on the southeast corner on 1st Street was blocking the line of sight. With the new construction on 1st Street that wall has been removed. Due to that, a stop sign needs to be added for the northbound traffic at Fairview Street if the above proposal is approved to change from one way to a two way.

Recommendation:

City staff evaluated the street and determined that S Fairview from 1st St to E Wylie can be two way traffic instead of one way. Additionally Staff recommends to remove the stop sign and no enter sign from the north side of that intersection and add a stop sign at the southeast corner of 1st St and Fairview after the end of the construction on 1st St. A more detailed title 15 amendment would be prepared if this request is forwarded to the Common Council for their consideration.
