






YTD Incident Types on the IU Campus






Heat Response Map for All Incidents January 2025




Travel Time for1st Fire Suppression (January 2025)

Travel Time for 1st fire suppression apparatus on fire suppression incidents 90th Percentile: 00:05:12



MIH "WINS"

The MIH team collaborated with STRIDE to get a patient connected with a therapist immediately AND established with a rehabilitation facility.

The MIH team witness an overdosed patient go into cardiac arrest. The team, alongside BFD, were able to obtain ROSC (return of spontaneous circulation) prior to the arrival of EMS. (The patient is still alive.)

The MIH team was able to help secure permanent housing for an unhoused patient.

The MIH team collaborated with the local health department to get an expectant mother who uses the transit system for transportation a stroller/carseat combo to ensure safe transport for the new baby.

The MIH team was able to disperse warm wear from a coat collection drive to various community partners working with the unhoused after hours.



This figure represents a 19.5% increase in 2025.








CRIME INVOLVING WEAPONS


- So far in 2025, there have been 17 incidents where weapons were reportedly involved.

2024-2025 Adult Arrests




2024-2025 Juvenile Referrals

Officer Recognition on SR-54 Call

Officer Pedigo,

Hello! My name is Megan Tarlton and I am a paramedic with IU Health LifeLine out of Lawrence County. I apologize for the delay of this email getting to you to recognize your officer that was involved in an incident we had in Lawrence County on SR-54 in late December of 2024.

To give an overview of our scene without getting into too much detail, your officer was one of the first on scene to a serious two vehicle MVC where the driver of one vehicle was rendered unconscious from the wreck. Upon our arrival, he provided a thorough report that allowed us to focus our assessment on the patient and have an understanding of the events leading up to the wreck. The driver of our vehicle was seriously injured, and all four occupants of both vehicles required extrication.

Your officer jumped right into action and helped alongside our VFDs and paid department to assist me and our other crews with extricating our patients and assisted with coordinating between Lawrence County and Monroe County dispatch and attempting to ascertain availability of HEMS units we desperately needed. Without his efforts and coordination, our scene would not have run as smoothly as it did. All patients were able to be safely transported to Bloomington Hospital in stable condition, with some eventually making their way to Indianapolis area hospitals later on due to severity of injuries.

I, again, apologize for the delay in this email! Your officer has my thanks, my crew members thanks, and the thanks of all other responders that were on that scene the day of the incident.
