The Common Council will go into its August Recess after the Regular Session on August 2nd and convene again on September 6th for consideration of the City Budget

for 2007 at a Regular Session immediately followed by a Committee of the Whole. There are two items ready for final action at next week's meeting. These include **App Ord 06-03**, which appropriates grant-related funds for equipment for the Fire Department, and **Ord 06-12**, which would expand the Elm Heights Residential Permit Parking Zone to include Ballantine Road and Highland Avenue south of Maxwell lane. Please note that there is an amendment to this ordinance from Councilmember Ruff that would remove Highland Avenue from the expansion, but that you can expect citizen comment both for and against it.
