Three Items are Ready for Final Action at the Regular Session on Wednesday, January 18, 2006

There are two items coming forward from the Committee of the Whole as well as one new resolution ready for final action at the Regular Session on Wednesday, January 18, 2006. The two items coming forward from the Committee of the Whole include a resolution approving an interlocal agreement (**Res 06-01**) and an ordinance proposing a vacation of right-of-way (**Ord 06-01**), which can be found in the Council Legislative Packet for January 3, 2006. The new resolution modifies and confirms the tax abatement for IMA just off South Sare Road (**Res 06-02**) and information regarding it can be found in this packet and the Council Legislative Packet for December 14, 2005.

No First Readings or Resolutions in the Next Few Weeks Motion to Cancel Committee of the Whole Proposed

The Mayor's Office indicates that there are no pieces of legislation to be presented for consideration during the second legislative cycle in January. This means that you should consider a motion to cancel the Committee of the Whole on January 25th. By Wednesday we may know more about what is happening in the first legislative cycle in February, which may lead to another proposal for the rescheduling of those meetings as well.

<u>Two Committee Reports</u> <u>– Telecommunications Council and Council Sidewalk Committee</u>

Telecommunications Council

The first of two committee reports will be from the Telecommunications Council (TCC). Concerned citizens, including former Mayor Tomi Allison, have approached Chris Sturbaum, Council President, about SB 245 and its House complement which would:

- Deregulate phone rates;
- Offer tax abatements to companies installing broadband infrastructure;
- Transfer the regulation of cable franchises from localities to the State while, at this point, still keeping the fees and the public access services for the localities; and

• Prohibit cities and towns from developing community broadband services. Members of the TCC have been following this bill with alarm and discussed it at their last meeting. The Chair of the TCC, Duane Busik, has agreed to organize a presentation for this meeting and co-present it with State Representative Matt Pierce, who has also been following this initiative and may be able to offer judgments regarding its implications and prospects of passage.

Council Sidewalk Committee Report - 2006

The second report is from the Council Sidewalk Committee and will need your approval before its recommended allocations can be put into effect. The report and accompanying record of recommendations, project summaries, and history of funding are all included in this packet.

The Committee consists of four council members appointed by the President of the Council which include Council members: Mayer (Chair), Rollo, Sturbaum, and Volan. It is assisted by personnel from the Public Works, Engineering, Planning, HAND, Parks and Recreation, and Council departments. (Please see the Report for the names of these persons – who make the work of this Committee possible.)

The Committee meets and makes recommendations to the full Council regarding the allocation of Alternative Transportation Fund monies. These monies are surplus revenue from the City's residential neighborhood parking program and have increased from \$185,000 to \$200,000 for 2006. After meeting five times over the last three months it made the following recommendations:

1. Allocate the \$200,000 of Alternative Transportation Funds (ATF) appropriated in 2005 in the following manner:

\$200,000	Annual Appropriation
<u>- \$15,000</u>	Traffic Calming
\$185,000	Sidewalk Projects

* Justin Wykoff indicated that ATF monies would not pay for all the projects funded in 2005, but that it was probable that Greenways funds could cover the shortfall by funding at least one project which appears on the Greenways Plan (Nancy Street).

2. Recommend ATF Funding for the Following Projects in 2006 - \$183,240

Construction – Queens Way and Roosevelt - \$153,239.47

• <u>Queens Way</u> - Sussex to High (south side) -- \$25,969.68

- It is the missing link connecting High to Renwick and does not have a large storm water component.

• <u>Roosevelt Street</u> - Fourth to Fifth (east side) -- \$127, 269.79 (with curbs on the opposite of the street)

- This project ties in with the recent improvements made by the private sector (Doug McCoy) which made this a through- street.

Design Only – Maxwell Lane, Arden, East Second & East Eleventh -\$30,000 - The Committee agreed to initiate <u>design</u> of the following projects in the interest of furthering them along. The total project costs noted below include design and construction of the sidewalk.

• East Maxwell Lane – Highland to Sheridan (north side) - \$10,000 Total Project Cost: Two blocks - \$138,138.86

- This project would complete the missing links on the north side of this street from Henderson to High Street.

- Arden From High to Windsor (south side) -- \$5,000 Total Project Cost: Two blocks - \$59,486.72
 This project provides a safe walk way to Southeast Provides a safe walk was safe walk was safe walk way to Southeast Provides a safe walk
 - This project provides a safe walk way to Southeast Park for the neighborhood's many children.

- East Second Street Woodcrest to 300' east (north side) \$5,000 Total Project Costs: Half a block - \$31,574.66
 This project completes the missing link on the north side of the street from College Mall to the west.
- East Eleventh Street Washington to Lincoln (north side) \$10,000 Total Project Cost: One block - \$60,151.41
 This project would install a missing sidewalk in the City's urban core area.

3. Meet in early 2006 to discuss ways to share the burden of the stormwater costs and to streamline the deliberations for the 2007 round (which should begin early this fall).

Resolutions and Second Readings

<u>Res 06-02</u> Modifying and Confirming <u>Res 05-22</u> – Re: Granting a Tax Abatement for the Construction of a Medical Office Building for IMA Just off South Sare Road (Rogers Property Management, Petitioner)

<u>Res 06-02</u> modifies and confirms <u>Res 05-22</u>, which granted preliminary approval for a tax abatement for Rogers Property Management, LLP, to build a 39,000 s.f. structure to house Internal Medicine Associates (IMA) East on Glen Magna Way in the Canada Farm PUD just off South Sare Road. Information and materials regarding this tax abatement can be found in the December 14, 2005 Council Legislative Packet which is available online at:

The previous resolution (Res 05-22) was passed on December 21^{st} . As noted in that packet memo, it took three actions which included:

- designating an Economic Revitalization Area (ERA);
- approving a Statement of Benefits; and
- authorizing a 10-year tax abatement on improvements to real estate.

The proposed resolution modifies the approval of the Statement of Benefits by including a letter of additional commitments submitted by the Petitioner to the Council on December 19, 2005 and then confirms these three actions. Those commitments include the provision of at least \$200,000 in indigent health care each

year and continuing a list of on-going community contributions. Please note that the Statement of Benefits and Letter are attached and made a part of this resolution and can be found in this packet.

I.C. 6-1.1-12.1-2.5 requires the Council to hold a legally-advertised public hearing before voting on the adoption of this resolution. That hearing will take place during the public comment on this resolution at the January 18th Regular Session and will provide the public with an opportunity to object to the designation of the ERA. Please note that the City Clerk has filed information regarding the proposed abatements and their benefits in the requisite governmental offices and also published notice of those filings and the upcoming public hearing. Please also note that the public hearing was changed from January 3rd to the 18th in order to comply with those notice and filing requirements.

Report of the Common Council Sidewalk Committee January 18, 2006

Schedule and Topics of Meetings

The Committee met five times in the fall of 2005 in the course of making its recommendations for funding allocations in 2006. Here is a brief overview of what occurred at those meetings (the memoranda of which are available in the Council Office):

October 5th and October 17th, 2005 at noon in the McCloskey Room

- Elected a Chairperson (Tim Mayer);
- Requested the Council Office to make a record of the meetings;
- Reviewed money available in the Alternative Transportation Fund for 2006 (this money derives from neighborhood parking revenues that

are in excess of program expenses and was increased from \$185,000 to \$200,000 in 2006)

- Discussed sidewalk standards (in particular the INDOT ramp regulations);
- Reviewed previous allocations and projects (see Chart);
- Reviewed other recent, ongoing, or future sidewalk projects and heard presentations from:
 - Planning (e.g. revising the Greenways Plan)
 - Parks and Recreation (Southeast Park Trail, Lower Cascades Park, Renwick, CSX Corridor, Jackson Creek Trail, and Thomson Park)
 - HAND (various projects in targeted neighborhoods including Broadview and upper Westside areas)
 - Public Works (Hazard Elimination and Safety Fund projects at 17th and Fee Lane and Basswood and West Second Street)
- Reviewed the Sidewalk Inventory;
- Reviewed and affirmed a statement of criteria for selecting sidewalk proposals that include:
 - Safety considerations, Roadway classification, Pedestrian usage, Proximity to points of destination, and Costs/feasibility.
- Discussed the role of City of Bloomington Utilities in funding some projects with Nathan Schulte.
- Began receiving estimates and reviewing proposed projects in the following order:
 - Continuation of previously funded projects
 - Extension of previously funded projects
 - Other previously discussed projects
 - Reconsideration of previously denied projects
 - New projects

November 14th and December 5th, 2005 at noon in the McCloskey Room:

- Continued receiving estimates and reviewing proposed projects
- Heard from Todd Thompson, a property owner on North Kinser, advocating for the sidewalk project on North Kinser being reconsidered by the Committee after a denial last year.

December 12, 2005 at noon in the McCloskey Room to:

• Recommended allocation of \$153,239.47 to fund the construction of two projects (on Queensway and Roosevelt) and \$30,000 for the design of four projects (on Maxwell Lane, Arden, East Second, and East 11th) (See Recommendations and Chart for further details).

- Found that stormwater costs amount to about half of these sidewalk project costs and are the primary constraint on completion of many of them. Discussed sharing labor and material and perhaps dedicating a small portion of stormwater revenues as a means to move these projects along.
- Approved the minutes from the October 3rd and 17th, 2005 and delegated the approval of the minutes for the remaining meetings to the President after review and comment by members.
- Agreed to submit the Sidewalk Report to the Council by mid-January, 2006; and
- Agreed to meet by early February in order to explore:
 - 4) how the Committee might better partner with CBU to address the stormwater component of sidewalk projects; and

4) how to make the Committee more efficient given the amount of money it allots and the time and resources it takes to make that decision.

• Agreed to meet in mid-September to begin the deliberations for 2007.

Highlights of Committee Deliberations

<u>Alternative Transportation Fund – 2006 – Increased from \$185,000 to</u> <u>\$200,000</u>

The Committee makes recommendations regarding the use of the Alternative Transportation Fund (ATF), which is funded primarily by surplus revenues from the Neighborhood Parking Program (BMC 15.37.160). This year those funds were increased from \$185,000 to \$200,000. Please see the recommendations below for information regarding the 2006 allocations and fund balances.

Review of Proposals

The Committee deliberations regarding sidewalk proposals are summarized in the attached chart of Recommendations for Use of Alternative Transportation Funds for 2006. After reviewing the status of previously funded projects, the committee considered proposals for funding in the following order: continuation of previously funded projects; Extension of previously funded projects; Previously discussed but unfunded projects; Reconsideration of previously denied projects; and New projects. At the end of the deliberations, the Committee was faced with requests of around \$2 million in sidewalks and about \$185,000 in funding. Given this gap between requests and funding, it recommending:

- funding the construction of two projects on Queens Way and Roosevelt,
- funding design for four projects on Maxwell Lane, Arden Drive, East 2nd and East 11th Street;
- awaiting design work for Marilyn Drive and the availability of other funding for Jefferson Street; and
- not funding the remaining ones.

Issues for Attention Early in 2006

The Committee decided to meet early in 2006 to find ways to move projects with a large stormwater component forward and to streamline the decision-making process.

Committee Recommendations:

After five meetings the Committee made the following Recommendations:

1. Allocate the \$200,000 of Alternative Transportation Funds appropriated in 2006 in the following manner:

Construction – Queens Way and Roosevelt - 53,239.47

• <u>Roosevelt Street</u> - Fourth to Fifth (east side) -- \$127, 269.79 (with curbs on the opposite of the street)

- This project ties in with the recent improvements made by the private sector (Doug McCoy), which make this a through-street.

Design Only – Maxwell Lane, Arden, East Second & East Eleventh -\$30,000 The Committee agreed to initiate <u>design</u> of the following projects in the interest of furthering them along. The total project costs noted below include design and construction of the sidewalk.

• East Maxwell Lane – Highland to Sheridan (north side) - \$10,000 Total Project Cost: Two blocks - \$138,138.86

- This project would complete missing links on Maxwell Lane between Henderson and High Street.

- Arden From High to Windsor (south side) -- \$5,000; Total Project Cost: Two blocks - \$59,486.72
 - This project provides a safe walk way for the neighborhood's many children.
- East Second Street Woodcrest to 300' east (north side) \$5,000; Total Project Costs: Half a block - \$31,574.66

- This project is the missing link on the north side of the street from College Mall to the west.


• East Eleventh Street – Washington to Lincoln (north side) - \$10,000 Total Project Cost: One block - \$60,151.41


- This project would install a missing sidewalk in the urban core area.

Note: At the end-of-the-year, Justin indicated to the Council Office that there was a shortfall in funding for projects bid-out or constructed in 2005, but that the Greenways fund will be able to cover the shortfall by applying funds to the Nancy Street project because it is on the Greenways Plan.

RESOLUTION 06-02

TO MODIFY AND CONFIRM <u>RESOLUTION 05-22</u> WHICH DESIGNATED AN ECONOMIC REVITALIZATION AREA, APPROVED A STATEMENT OF BENEFITS, AND AUTHORIZED A PERIOD OF TAX ABATEMENT, - Re: Glen Magna Way, Canada Farm PUD, Phase I, Parcel E (Rogers Property Management, LLP, Petitioner)

- WHEREAS, Rogers Property Management, LLP ("Petitioner") has filed an application for designation of property at East Glen Magna Way, described as Parcel E, Phase I, in the Canada Farm PUD, Bloomington, Indiana as an "Economic Revitalization Area" ("ERA") pursuant to I.C. IC 6-1.1-12.1 et. seq.; and
- WHEREAS, petitioner intends to construct a new building that will be leased to IMA (Internal Medicine Associates, Inc.) for operation as a 39,000 square foot medical outpatient treatment facility; and
- WHEREAS, pursuant to state law, petitioners seeking designation for their property as an Economic Revitalization Area must complete a Statement of Benefits and must provide information in a timely fashion each year to the County Auditor and the Common Council showing the extent to which there has been compliance with the Statement of Benefits; and
- WHEREAS, the application has been reviewed by the Planning Department, and the Economic Development Commission has passed a resolution recommending that the Common Council designate an "Economic Revitalization Area," approve a Statement of Benefits, and authorize a ten (10) year period of tax abatement; and
- WHEREAS, the Common Council has investigated the area and reviewed the Application, which is attached and made a part of <u>Resolution 05-22</u>, as well as the modified Statement of Benefits, which is attached and made a part of this resolution, and has found the following:
 - A. the estimate of the value of the redevelopment or rehabilitation is reasonable;
 - B. the estimate of the number of individuals who will be employed or whose employment will be retained can be reasonably expected to result from the proposed described redevelopment or rehabilitation;
 - C. the estimate of the annual salaries of these individuals who will be employed or whose employment will be retained can be reasonably expected to result from the proposed described redevelopment or rehabilitation;
 - D. the redevelopment or rehabilitation has received approval from the Planning Department, is consistent with the Growth Policies Plan, is expected to be developed and used in a manner that complies with local code, and provides housing in the downtown area; and
 - E. the totality of benefits is sufficient to justify the deduction; and
- WHEREAS, the property described above has experienced a cessation of growth; and
- WHEREAS, the Common Council adopted <u>Resolution 05-22</u> on December 21, 2005, which designated the above property as an "Economic Revitalization Area," approved a Statement of Benefits which has since been modified, and authorized a ten (10) year period of tax abatement; and
- WHEREAS, the City Clerk published notice of the passage of that resolution, which requested that persons having objections or remonstrance to the designation appear before the Common Council at its meeting on January18, 2006; and
- WHEREAS, the Common Council has reviewed and heard all such objections and remonstrance to such designation; and
- WHEREAS, in accordance with Section 2.28.020 (b)(2) of the Bloomington Municipal Code, which requires the legislation authorizing tax abatements that are subject to the Living Wage requirements to include the projected value of the abatement over the period of abatement, the tax calculations submitted to the Council by the Director of Economic Development, shall serve that purpose;

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

1. Pursuant to Indiana Code 6-1.1-12.1-1 et seq., the Common Council hereby modifies and affirms its determination made in <u>Resolution 05-22</u> that the area described above is an "Economic Revitalization Area" and that the totality of benefits of the Project entitle the owner of the property or its successor(s) to a deduction from the assessed value of the related improvements for a period of ten (10) years.

2. In granting this designation and deduction the Common Council incorporates I.C. 6-1.1-12.1-12. It also expressly exercises the power set forth in I.C. 6-1.1-12.1-2(I)(5) to impose additional, reasonable conditions on the rehabilitation or redevelopment beyond those listed in the Statement of Benefits. In particular, failure of the property owner to make reasonable efforts to comply with the following conditions is an additional reason for the Council to rescind this designation and deduction:

- a. the improvements described in the application shall be commenced (defined as obtaining a building permit and actual start of construction) within twelve months of the date of this designation; and
- b. the land and improvements shall be developed and used in a manner that complies with local code; and
- c. the provisions of Chapter 2.28 of the Bloomington Municipal Code entitled Bloomington Living Wage Ordinance shall be followed.

This resolution modifies and affirms the determination of the Common Council expressed in <u>Resolution 05-22</u> to designate the property located on East Glen Magna Way, described as Parcel E, Phase I, of the Canada Farm PUD, as an "Economic Revitalization Area," approve a Statement of Benefits, and authorize a tax abatement for a period of ten (10) years for the project proposed by the petitioner, Rogers Property Management, LLP. The petitioner is seeking a tax abatement for construction of a medical outpatient treatment facility to be operated by Internal Medicine Associates, Inc. and known as IMA East.
