Two Items Ready for Final Action and One Item Ready to be Introduced at the Regular Session on Wednesday, May 3, 2005

There are two ordinances ready for final action and one appropriation ordinance ready to be introduced at next week's Regular Session. The two ordinances ready for final action can be found in the packet for the April 20<sup>th</sup> Regular Session (and include one amendment). The appropriation ordinance, summary and background material can be found in this packet.

## **First Readings**

App Ord 05-03 – Appropriating Money from the General Fund (\$161,034), Risk Management Fund (\$14,250), Municipal Arts Fund (\$5,000), and Telecommunications Infrastructure Fund (\$63,320)

<u>App Ord 05-03</u> appropriates \$161,034 from the General Fund, \$14,250 from Risk Management Fund, \$5,000 from the Municipal Arts Fund, and \$63,320 from the Telecommunications Infrastructure Fund. These appropriations are explained in the attached memo from Susan Clark, Controller, and are briefly noted below:

## **General Fund**

**Animal Control** – \$136,500 – PetSmart Grant, Spay/Neuter Supplies & Services, and Reimbursement for Percent for the Arts Project

The Animal Care and Control Division wishes to expend a \$7,500 grant from PetSmart to reimburse the Monroe County Humane

Association for the purchase of \$15,000 in shelter operational software. It also is requesting \$129,000 for medical supplies and services related to the new program of spaying and neutering animals prior to adoption. According to the attached spreadsheet from Public Works and the Controller's Office, the higher adoption fees approved late last year will generate the revenues sufficient to offset these expenses. Lastly, it requests a reimbursement of \$5,000 from the Municipal Arts Fund for the money it paid for a Percent for the Art project at the new facility (see the Municipal Arts Fund below).

**Community and Family Resources Department** - \$24,534 - Increase Hours for Two Program Assistants and Continue Hours of One Intern

The Community & Family Resources department has increased the hours for two Program Assistants from 30 to 40 per week in order to focus more staff time on community events (as arranged last January with the Mayor's Office in concert with the creation of the Assistant Director of Economic Development position). It also requests an additional \$6,000 to retain an intern in order to maintain continuity in the *Plaza Communitario* program. This program began last October with the help of the Mexican Consulate in Indianapolis and offers adult education classes to Spanish-speaking residents. The appropriation would allow the intern to continue arranging these classes and other initiatives aimed at Spanish-speaking residents at 20 hours per week.

## **Risk Management Fund**

Risk Management Department - \$14,250 - Additional Hours for Attorney

The Legal Department wishes to increase the hours for the Risk Management Division's Assistant City Attorney from 30 to 40 due to increased responsibilities. Note: This position went from 40 to 30 hours in 2003 when the former risk attorney returned from maternity leave.

## **Telecommunications (Infrastructure) Fund**

**Information & Technology Services Department -** \$63,320 - Bloomington Digital Underground, Remote High-Speed Access in City Hall, and High-Speed Access for Other City Buildings

The Information Technology Department requests \$35,520 in order to install conduit for the BDU along the new road under construction in the Indiana Enterprise Center. This money will purchase conduit, manholes and handholes for this leg of the BDU. It also requests \$7,800 to provide high-speed remote internet access to all points within City Hall. Please note that this will entail upgrading the access point in the Council Chambers so that it can handle more users. Lastly, it requests \$20,000 to purchase conduit and material for small projects that could provide high speed access for some City buildings currently without it.

## **Municipal Arts Fund**

Animal Control - \$5,000 Reimbursement for Percent for the Arts Project

The Animal Care and Control Division paid \$5,000 this year for a Percent for the Arts project installed at the Animal Shelter in 2005 and wishes to be reimbursed from the Municipal Arts Fund. That project was a limestone statue of a dog and cat which now stands in front of the new shelter.

WHEREAS, the Legal Department wishes to increase the hours from 30 to 40 for the Risk Management Division's Assistant City Attorney due to increased responsibilities; and

WHEREAS, the Information & Technology Services Department wishes to install conduit for the BDU along the new road under construction in the Indiana Enterprise Center; purchase conduit, manholes and handholes for the BDU; and improve the availability and quality of wireless Internet access within City Hall;

This ordinance appropriates \$136,500 from the General Fund – Animal Care & Control Division for a grant, for additional expenses related to new adoption policies, and for a reimbursement from the Municipal Arts Fund; \$24,534 from the General Fund – Community & Family Resources Department for increased hours for two employees and for interns; \$14,250 from the Risk Management Fund for increased hours for the Assistant City Attorney; \$63,320 from the Telecomm Infrastructure Fund for the Bloomington Digital Underground and wireless internet access; and \$5,000 from the Municipal Arts Fund to reimburse the General Fund for a Percent for the Arts Project.

## Memorandum

Appropriation Ordinance 05-03 Re:

In Appropriation Ordinance 05-03, we are requesting authorization for expenditures from four funds.

#### 1.) General Fund – Animal Care & Control

- a) The Animal Care & Control Division has received a \$7,500 grant from Petsmart Charities for the purchase of computer software. This general purpose shelter management software, "Animal Shelter Net," tracks the status of the animals that are accepted by the Shelter, complaints from citizens, foster animal locations, and fines and fees. The total cost of the software is \$15,000 and Animal C&C has partnered with the Monroe County Humane Association to keep from spending any funds "out of pocket".
- b) The Animal Care & Control Division has enacted new policies requiring that all animals be spayed or neutered, and have a microchip identification implanted. The costs of these additional services will be covered by the fee increases that went into effect January 1, 2005 per Ordinance 04-34. Animal C&C projects \$136,000 in additional revenue, and the appropriation request for the new services is \$124,000.
- c) The Animal Care & Control Division has paid \$5,000 for a limestone statue as part of the Percent for the Arts project in conjunction with the shelter expansion. The money was paid from the General Fund and Animal C&C would like to reappropriate those funds after the Municipal Arts fund has reimbursed the General Fund. See Number 2 below.

#### 2.) **Municipal Arts Fund**

The Public Works Department has requested \$5,000 from the Municipal Arts Fund to reimburse the General Fund for the cost of the Percent for the Arts project associated with the recent animal shelter expansion. (The artist was paid out of the General Fund earlier this year.)

#### 3.) General Fund – Community and Family Resources

Two employees in the Community and Family Resources Department (CFRD) have taken on additional duties for community events as part of an administration initiative launched in January. The cost to increase the hours of two part time employees is \$18,075, including benefits. In addition, in order to maintain continuity over the summer in the Plaza Comunitaria program, CFRD has requested \$6,000 plus FICA for an intern. The Plaza Comunitaria program, sponsored by the Mexican government, links our Spanish speaking residents to a local adult education program. The local committee includes Ivy Tech, MCCSC, Women in Connection, St. Paul Catholic Center and City of Bloomington.

#### 4.) Risk Management Fund

The Risk Management Division of the Legal Department would like funding to restore the hours of the Assistant City Attorney. This position was full time until 2003 when the previous incumbent requested a reduction in hours. The cost to restore the position to fulltime is \$14,250, including benefits. The balance in this internal service fund is sufficient to cover this increase without drawing additional allocations from the contributing departments.

#### 5.) Telecom Fund – Infrastructure

- a) The Information Technology Services Department has requested \$35,520 to install fiber optic conduit along the new public road under construction in the Indiana Enterprise Center.
- b) The Information Technology Services Department has requested an appropriation of \$20,000 to maintain a small inventory of BDU components including conduit, manholes and handholes.
- c) In order to improve the availability and quality of wireless Internet access within City Hall, the Information Technology Services Department has requested an appropriation of \$7,800. This will extend Internet access for City of Bloomington staff members and for Bloomington citizens to all public meeting areas in City Hall.

As for the spay-neuter amount, it may be Monday before we can give you an answer on that. I'll do my best to at least give you a status report before the end of the day today.

#### Assumptions:

- 1. Approximately 10% of the incoming animals are 5 years are older so I assumed that 10% of the adoptions would also be 5 years or older.
- 2. I used the highest numbers as the cost for surgeries \$40 for cats and \$45 for dogs. These are the numbers from Pets Alive.
- 3. I did not include in the expenses those things we are already doing and have in our budget the vaccinations and the cat carriers. The costs above are only for those things we would need to add to our budget.
- 4. I did not include the rabies vaccine.

In 2004, Public Works paid the % for the Arts fund \$5,000 for the 1% match of the Animal Shelter construction. That money was paid from 601.02.00000.53610.0.2004, and was deposited into 402.02.00000.53990.0.2004.

Early in 2005, the Arts Commission celebrated the installation of a sculpture at the Shelter and presented us with a \$5,000 invoice payable to the artist. Rather than make the artist wait for an appropriation, we paid him from General Fund 101.01.00000.53990.0.2005, and we are requesting that this line be reimbursed, by appropriating the money from the % for the arts fund and transferring it into our budgeted line to cover other expenditures in 2005.

#### Plaza Comunitaria is:

A center of educational services and community training in Spanish using the latest technology. The Center has an area of networked computers and internet access, a television and VCR, and a traditional classroom. The Center offers levels that range from literacy to continuing education, including testing and certification, and free access to learning resources (books, workbooks, videos, etc). Currently there are four Plaza Comunitaria projects in the state of Indiana (Gary, Indianapolis, South Bend, and Bloomington). #### **About Plaza Comunitaria Bloomington:**

Plaza Comunitaria Bloomington opened in October 2004. Currently there are 25 students registered and a group of 5 dedicated volunteer tutors. Our Plaza communitarian is sponsored by the Mexican Consulate in Indianapolis and a consortium of 4 local agencies (The City of Bloomington, Ivy Tech State College, St. Paul Catholic Center, and Mujeres en Conexión). Tutoring sessions are currently held at Ivy Tech State College Mondays and Wednesdays 6-8pm. Council President Ruff gave the Agenda Summation

There were no minutes to be approved.

Chris Gaal announced a CubAmistad event on February 5, 2005 which would celebrate an agreement with Indiana University and a Universidad Central de Las Villas in Santa Clara, Cuba, one of Bloomington's Sister Cities.

Maren McGrane, Council Liaison for the Mayor's Office introduced city staff for reports.

Rick Dietz, Director of Information Technology Services, provided information on the Bloomington Digital Underground strategic planning process. He announced that InfoCom, consultant for the project, would hold a meeting for the purpose of gathering public input for the overall telecommunications plan for the City of Bloomington on February 8, 2005 at the Monroe County Public Library.

J.R. Logan and Susannah Karls, Service Corps graduate students with Indiana University's School of Public and Environmental Affairs gave a report on the history and city activities surrounding Black History Month. They showed pictures of the kickoff reception and announced the unveiling of the Colored School Historic Marker at Washington and Sixth Streets on February 13, 2005.

Chris Sturbaum, chair of the Sidewalk Committee, thanked staff for their help and reviewed the allocation of \$185,000 of Alternative Transportation Funds for 2004. He also outlined proposals for the 2005 funds and projects which were not funded this year, which included a project on Maple Street, funded by the HAND department.

Sturbaum also noted off-site consequences of development with special note to the Renwick PUD. He noted that \$18,000 worth of materials would be donated by the Wininger/Stolberg Group for the sidewalk on Winfield Road near that development.

Tim Mayer recommended when the city approves major developments that the cost of need infrastructure improvements should be budgeted by Public Works or HAND rather than City Council sidewalk funds. He reiterated that the money City Council had to work with was minimal.

Sturbaum responded that much of the cost of the sidewalk projects included stormwater improvements, and finding some utilities funding would greatly complement the council sidewalk money to help it go further.

Ruff thanked the committee for their work. It was moved and seconded to accept the Sidewalk Committee Report. The motion was approved by a roll call vote of Ayes: 9, Nays: 0.

fundraiser. They invited the council and interested citizens to attend.

Jason Banach announced that he attended the event last year with Ruff and commended the students and the group's sponsor, Pat Wilson, for their work.

It was moved and seconded that Mike Szakaly be appointed to the Redevelopment Commission. Szakaly and his family were present, and Ruff thanked him for his commitment to serve on the commission.

It was moved and seconded that Tim Henke and Jeff Ehman be reappointed to the Utilities Services Board.

The appointments were approved by voice votes.

It was moved and seconded that <u>Resolution 05-01</u> be introduced and read by title and synopsis. Deputy Clerk Weber read the legislation and synopsis, giving the Committee Do-Pass Recommendation of 9-0-0. It was moved and seconded that <u>Resolution 05-01</u> be adopted.

Ron Walker, Director of Economic Development, said the agreement being considered was a standard one used by the State of Indiana Department of Commerce. He reviewed the history of the project and stated that the application was submitted in October, a site visit occurred in November, and an agreement was offered in December, 2004. He added that a request was made that the boundaries of the park be revised. The revision was made by the city and had been approved by the City of Bloomington Redevelopment Commission.

Walker outlined that the agreement would provide a certified allocation area of over 65 acres to collect incremental growth in payroll and sales taxes generated within the district. He noted that the city could collect up to \$5 million over the life of the technology park, which would be committed to public infrastructure improvements and other projects which would qualify as public facilities. He added that it would provide an opportunity and funds to improve the area for employment growth.

Walker said a high-tech business, committed to growth, had signed on to the application. He added that the success of the application would rely on partnership with Indiana University, a technology business incubator, bandwidth and a proximity to business services downtown.

Sabbagh asked Walker to clarify if the Certified Technology Park and CRED district overlapped. Walker said downtown was covered with both tools, but they did not overlap.

Rollo asked if the decision was solely up to the Department of Commerce, which Walker said was the last step in the process.

Sturbaum asked what the city should tell businesses that wanted to locate in the technology park. Walker responded that a current business, needing more space, is considering locating there. They have special interest in being near other high tech business' and proximity to the downtown area. He noted cost of space, parking and security needs have to be considered, also.

Banach asked what the term of the agreement was, and Walker replied the agreement was for a period of 15 years. He said he did not know what the process would be at the end of that period of time, nor what would happen with the reorganization of the Indiana Department of Commerce. While Walker said he was concerned about the ramifications of the state administrative changes; he added his certainty LEGISLATION FOR SECOND READING

for the project's support.

Ruff asked if there were any more levels of approval necessary after the vote of the Council. Walker said that the only other thing needed was a signature from the Director of the Department of Commerce, and that he would hand deliver the document to the director later that week. Ruff asked when the majority of the application process took place. Walker replied that it occurred in late 2004.

There were no comments from the public on this agreement proposal.

Ruff facetiously asked if a person who was anti-business or antieconomic development would have trouble supporting this initiative.

Banach commented that Sabbagh had been a long time proponent of the development of bandwidth in the area, and it had now come to pay off. Banach responded to Ruff's comments by saying that this proposal deserved unanimous council support.

Volan said that while Sabbagh had been talking about bandwidth early on, he, himself, was in the business of supplying it to the community with his former business. He said the Bloomington Digital Underground provided much needed bandwidth, and it should be used to attract businesses to the area. He voiced his support of the agreement.

Mayer stated the council should thank the administration and especially Walker for their efforts in bringing this forward.

Resolution 05-01 received a roll call vote of Ayes: 9, Nays: 0.
