Committee of the Whole Followed By Special Session on February 25th

There are two meetings next week. The first one will be a Committee of the Whole where you will consider **Res 04-03** and **Ord 04-06**, which propose a tax abatement for the construction of a new building by Bloomington Paint and Wallpaper at the northwest corner of Grimes Lane and South Walnut. (Please see the February 12th packet for the summary and materials).

The second meeting will be a Special Session to discuss and take final action on <u>Ord</u> <u>04-04</u> (the PUD proposal for Southern Indiana Medical Park II, LLC). (Please see the January 30th packet for the summary and materials as well as information placed in your boxes since then). In last week's memo I suggested that the Council may want to move the discussion forward on this item and avoid unnecessary repetition.
