Regular Session for October 1st Rescheduled to October 8th (To be Immediately Followed by Committee of the Whole)

The Council voted this week to reschedule the Regular Session on Wednesday, October 1st to October 8th. The Regular Session that evening will begin at the usual time and be immediately followed by the Committee of the Whole.

Preview of Items on Next Legislative Cycle

This next legislative cycle should include as many as three items relating to the infrastructure portion of the Telecommunications (TeleCom) Fund and the operation of the Bloomington Digital Underground (BDU), a traffic ordinance, and a tax abatement for another infill project on West Kirkwood (which, by the way, calls for wood siding). The items relating to the TeleCom Fund and BDU would allow the infrastructure portion of the TCC Fund to be used to repair and maintain the Bloomington Digital Underground and appropriate money from that fund for repairs, and may also propose policies for the operation of the BDU.
