CALL TO ORDER

The meeting was called to order by Mr. Les Coyne at 4:00 p.m.

Mr. Joe Hoffman made a motion to approve the Consent Calendar. Ms. Kathleen Mills seconded the motion. Motion unanimously carried.

B. PUBLIC HEARINGS/APPEARANCES

B-1. Public Comment Period

Mr. Ron Edge approached the podium. Mr. Edge resides at 1813 West Rosewood Drive in Northwood Estates. Mr. Edge stated he is representing the Homeowners Association of Northwood Estates. Mr. Edge stated he presented the Board with a petition protesting the planned cell tower at North Cascade Park. The neighborhood's concerns are the short notice given to the community regarding this project, decrease in property values and health issues which include the threat of cancer.

Mr. Kimball Wolf approached the podium. Mr. Wolf resides at 3967 North Ironwood Court in Northwood Estates. Mr. Wolfe read a statement on how the neighborhood felt a cell tower would affect the ascetics of the area. Mr. Wolfe presented a picture of what the area might possibly look like with a tower.

Ms. Cynthia McCullough approached the podium. Ms. McCullough resides at 711 West Rosewood Drive. Ms. McCullough commented on how she and her family have used the park over the years. Ms. McCullough showed a picture of her family at the Lion Den Shelter House. Ms. McCullough was concerned about the tower attaching lighting during a storm.

Resident from 3971 North Ironwood Court. For eleven years he was employed by Indiana University cyclotron, when the facility housed a cancer treatment center. Citizen stated studies of cancer related to cell towers does not include the effects on children. Citizen is concerned a cell tower will be placed near a playground.

B-2. Bravo Award - Carson Bickley

Nikki Wooten, Special Service Coordinator, presented Mr. Carson Bickley with the February Bravo Award for exceptional services inspiring his peers to demonstrate philanthropy and leadership by volunteering as tutors. Mr. Bickley, a junior at Indiana University, serves as the liaison between the Parks and Recreation Department and Hutton Honors College. He recruits the majority of volunteer tutors, or Banneker Buddies, for the Banneker Afterschool Program. This program currently offers one-on-one or small group tutoring, in math and reading, to fifty students. Beyond his organizational

assistance with the program, Mr. Bickley serves as a tutor himself. Volunteers not only provide a crucial service in helping students have positive and successful school experiences, but also function as role models to students who may find themselves in challenging circumstances. We are pleased to present Mr. Bickley with our February 2016 BRAVO Award.

Mr. Bickley approached the podium, accepted the award and thanked the Board.

B-3. Parks Partner Award – Bluestone Tree

Ms. Julie Ramey, Community Relations Manager, presented Bluestone Tree with the Winter-Spring 2016 Parks Partner Award for showing their dedication to the City of Bloomington, and for leading by example. In 2014, one of the City's oldest and largest tree was evaluated and determined to be a hazard by a professional tree care firm. The tree needed to be removed. Due to the busy location, the size and questionable stability of the tree, estimated cost was between \$6,000 and \$8,000 for removal. Although the Parks and Recreation Departmental approached the Indiana forest products industry in order to find a firm that would be willing to remove the tree in exchange for its lumber, there were no takers. Then Jerad Oren from Bluestone Tree, a company based here in Bloomington, offered the time, expertise, equipment and staff to remove the Seminary Park white oak at no cost to the city. On January 28, 2016, Mr. Oren and his seven person crew safely and flawlessly removed the tree. We are grateful to Bluestone Tree not only for their generosity, but also for the care they showed during the removal process.

Ms. Ramey stated, the Parks Department would also like to thank the numerous city departments and staff who worked throughout the day to keep the removal process going smoothly. We especially want to recognize the Bloomington Police Department and the city's Street Department, who contributed manpower and truck power to secure the removal site for safety, and to haul the logs to a staging facility throughout the day.

Mr. Oren approached the podium. Mr. Oren thanked the Board for giving Bluestone Tree the opportunity to be a part of this special event, taking this old and special tree to its final resting place. The City's departments put a lot of effort, time and work into the coordination of this project, Bluestone was only there for a day.

The Board thanked Mr. Oren and inquired if there was an estimation on the age of the tree.

Ms. Ramey stated it was estimated to be between 170 and 177 years old.

C. OTHER BUSINESS

C-1. Review/Approval of Partnership Agreement with Indiana University Department of Recreation, Parks and Tourism Studies/School of Public Health

Ms. Paula McDevitt, Acting Director, this is the eighth year that formalizes the relationship between the City of Bloomington Parks and Recreation Department and the Indiana University department of Recreation, Parks and Tourism Studies. This partnership is an opportunity for both departments to collaborate with sharing expertise on the academic side combined with the expertise on the practitioner's side. Ms. McDevitt invited Dr. Lynn Jamieson, the Chair of the Department of Recreation, Parks and Tourism Studies to the podium.

Dr. Jamieson approached the Board, this relationship has been long standing and goes back to 1961 when Ted Deppe, of Indiana University began working with Bill Wilson. Only recently has this relationship been formalized due to the great amount of interaction. We have benefited from working with not only an accredited organization but a gold medal award winning City. While Indiana University's reach goes further than the local setting, the kinds of innovation that have taken place in Bloomington over the years is very interesting. Student interest has increased as well as the number of internships with more students completing the 320 hours. We have recently asked Ms. McDevitt to provide a list, of BPRD staff with expertise in specialized areas, for potential instructors. This agreement has worked very well for all our department and we are excited to continue this relationship. Dr. Jamison recognized Paula McDevitt for her dedication and assistance with this partnership.

Mr. Joe Hoffman made a motion to approve the Consent Calendar. Ms. Kathleen Mills seconded the motion. Motion unanimously carried.

C-2. Review/Approval of Partnership Agreement with Prepared Food Vending Agreements for Market

Ms. Marcia Veldman, Program Facility Coordinator, stated the prepared food vendors are one of the three categories of vendors participating at the Farmers' Market. The selection of 2016 Food Vendors began with staff sending a Request for Proposal (RFP) to 54 individuals and organizations who expressed interest in selling prepared food at the Market in the last two years. Additionally a Legal Notice was ran in the *Herald-Times* on two consecutive Sundays, informing the public of the RFP.

The RFP established 10 criteria by which proposals would be evaluated;

- Menu
- Production
- Price
- Customer Satisfaction
- Reliability
- Local entity
- Market Product Balance
- Utilization of Local Product
- Interest in Non-Peak Season or Limited Occasion Sales
- Fulfillment of Terms of Previous Agreement

Marcia presented the proposal review committee's selection of recommended Prepared Food Vendors for the 2016 Market. The committee is made up of two Farmers' Market Advisory Council members and three Market staff.

The Board inquired why vendor proposals are denied.

Ms. Veldman stated it was sizing vendors up to criteria, product balance, ingredients used, experience from past years with product and the completion of the proposals. There are many factors used when determining the selection of vendors.

Mr. Joe Hoffman made a motion to approve the Prepared Food Vending Agreements for Market. Ms. Kathleen Mills seconded the motion. Motion unanimously carried.

C-3 Review/Approval of Softball Supply Order

John Turnball, Sports Division Director, this is an annual review of the total softballs purchased for the year. These softballs will be used throughout our 2016 programs which are ASA sanctioned, adult slow pitch leagues, youth fast pitch leagues and the hosting of six events. Indiana ASA has a purchasing agreement with Worth Sports to provide softballs at a discount to any Indiana ASA sanctioned agency. We received bids from three vendors with Worth Sports providing a substantial savings.

Mr. Joe Hoffman made a motion to approve the Softball Supply Order. Ms. Kathleen Mills seconded the motion. Motion unanimously carried.

C-5. Review/Approval of Proposed Changes to the Policy Regarding Records and Reports Management.

Kim Clapp, Office Manager, the process for managing records and reports has changed over the past few years. Changes to the policy mirror these new methods. The guidelines reflected in this policy have been thoroughly reviewed and updated to align with the 2016 CAPRA accreditation standard 3.4.2.1.

Mr. Joe Hoffman made a motion to approve the Proposed Changes to the Policy Regarding Records and Report Management. Ms. Kathleen Mills seconded the motion. Motion unanimously carried.

Board requested Ms. McDevitt review the Accreditation timeline.

Ms. Devitt stated the staff is in the process of finishing the written portion. March will consist of organizing the files electronically and sending them to the visitation team by the end of March. The visitation team will arrive the first week in June. There will be a series of meetings, tours and questions and answer sessions. There will be an exit interview at the end of that week. Staff will attend the NRPA conference to receive the final review by the National Committee.

REPORTS

D-1. Operations Division – Environmental Resources Advisory Council Annual Report

Ms. Mellissa Clark, Chair of ERAC, reviewed the topics that were focus areas for 2015.

- Deer Management- The cull was called off in early 2015, the health of the preserve is still a concern.
- Griffy Lake Plant and Water Quality Data Studies still point toward a plant versus algal dominated lake. There has been an increase in the invasive plant, Eurasian watermilfoil.
- Adopt-an-Acre Program This program began in 2015 and is modeled off the Adopt-a-Trail program. This program has been a great success.
- Wapehanni Mountain Bike Park Indiana Division of Water inspections determined the damn is a significant hazard. Funding was not obtained by BPR for a feasibility study. Utilities department may be able to fund a study for the best course of action for the site. ERAC would like to see the damn remain.
- Winslow Woods Management Plan Development Progress was made on the management plan. The focus will be on creating a resilient and healthy native plant community that supports wildlife as well as education and recreation opportunities for the public. Draft of the plan will be presented to ERAC by the end of 2016.
- Environmental Education Efforts Members continue involvement in environmental education efforts that include Griffy Lake Nature Day program, Leonard Springs Nature Day program and Adopt-a-stream.

Priorities for 2016 are very similar to that of 2015 and ERAC will continue with these topics.

The Board inquired about the increase in invasive plants at Griffy Lake. Was this an anticipated result after the draw down?

Ms. Clark stated a drawn down can be effective in freezing out roots but the seeds remain. The recovery of the invasive plant was expected.

The Bloomington Parks and Recreation Department would like to recognize Dick Stumpner for his service to the Adopt-an-Acre program. The Department started Adopt-an-Acre in 2015 to address invasive plant issues in Bloomington parks. Griffy Lake Nature Preserve has thriving populations of invasive plant species like bush honeysuckle, garlic mustard, winter creeper, privet, and multiflora rose, all of which are out-competing native plants. A new cycle of the one-year Adopt-an-Acre commitment starts in April, with applications due Friday, March 11.

According to biologist E.O Wilson, invasive species are the second largest threat to biodiversity (after development). In his application last year, Dick explained his desire to join the program:

"I have done ongoing invasive species removal on my property and have become more aware of how pervasive they are on the Griffy site. I am aware of the physical nature of removing invasives, but also know that it is an important job worth doing, and satisfying when completed."

According to Natural Resources Manager Steve Cotter, Dick brought valuable experience to the program. He even brought his own tools to work on his plot at Griffy.

"Dick has submitted his Adopt-an-Acre reports in a timely fashion. He cleared the invasives out of his plot and expanded to the east, removing invasives from an additional area as big as his original plot. He has also helped other adopters clear their plots. He has gone above and beyond," Steve said.

When he's not working on removing invasives from his plot, Dick can be seen circumnavigating Griffy Lake in his canoe.

We are pleased to present Dick with the BRAVO award for his exceptional service to the Adopt-an-Acre program, and for helping preserve the biodiversity of Griffy Lake Nature Preserve.

BEER & FILM TOUR

Recommendation

Staff recommends approval of the alcohol permit approval for the Clips Beer and Film TOUR to be held in Bryan Park on May 20, 2016. This will be the sixth year for this event in Bloomington.

Staff also recommends approval to use ten percent of the total revenue of beer sales from 2015 as the alcohol permit fee for 2016.

Background

A statement from Clips of Faith (Belgium Brewing Company):

"In its seventh fabulous year, Clips Beer and Film Tour is a 21-city nationally touring event featuring New Belgium beers alongside amateur films created by filmmakers from across the country. As in year's past, the Bloomington tour stop will utilize volunteers from a non-profit organization with 100 percent of the proceeds from the beer sales benefiting this local organization. As such, we seek permission to sell beer. Since its inception, Clips has raised over \$500,000 for nonprofit organizations across the country. In addition to beer and film, this event focuses on sustainability by diverting waste from landfills and encouraging alternative transportation, namely by bicycle. This event also promotes responsible and safe festival, with monitoring coming from TIPs trained staff members and hired security officers."

For the past six years, this event has been instrumental in setting the standards for incorporating the safe sale and consumption of alcohol in a park during an event. They hire local security and work closely with Parks to ensure the safe set-up, implementation and tear-down of this event.

Staff would also like to use ten percent of the revenues generated from beer sales in 2015 to set the alcohol permit fee for 2016. Please see chart for past history of the event.

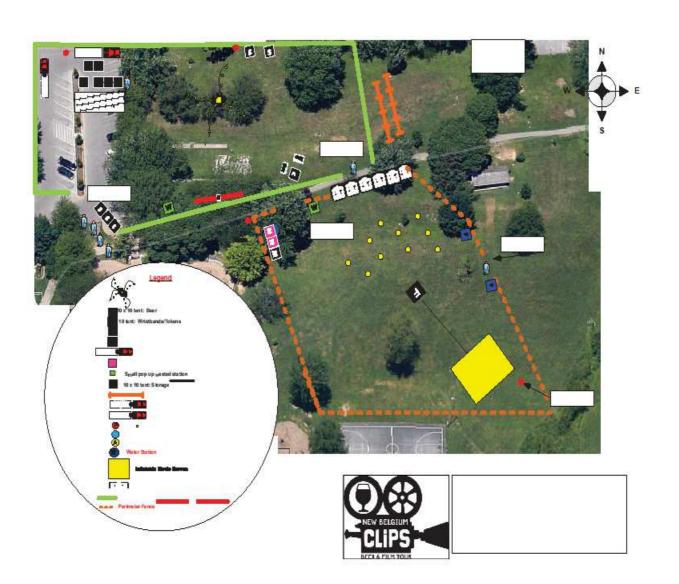

WHEREAS, the MCCT is qualified to perform such services with BPRD; and,

WHEREAS, BPRD is authorized to plan and develop partnerships and contractual arrangements with non-city organizations to ensure delivery of services;

NOW THEREFORE, the partners do mutually agree as follows:

1.0 Purpose of Agreement:

The purpose of this Agreement is to outline a program partnership which will provide for greater services in theater programming and productions by combining available resources from each partner to this Agreement.

2.0 **Duration of Agreement:**

This Agreement shall be in full force and effect from March 1, 2016, to February 28, 2017, unless early termination occurs as described in Article 8.0 of this Agreement.

3.0 Bloomington Parks and Recreation:

The goal of BPRD is to build a positive relationship with the MCCT in order to provide free performances of "Shakespeare in the Park" for the Bloomington community.

BPRD agrees to:

a. Provide use of the stage in the Third Street Park for four (4) nights per week (Monday-Thursday) during the six (6) weeks leading up to public performances. Performances are to be held during the month of June.

b. Publicize performances in the Performing Art Series through concert cards, in the program guide, and in weekly press release.

4.0 Monroe County Civic Theater:

The goals of MCCT are to provide opportunities for actors to gain experience in theatrical productions and provide free, quality performances of "Shakespeare in the Park" for the Bloomington Community.

MCCT agrees to:

- a. Name BPRD in all forms of publicity as a co-sponsor of performances held in Third Street Park.
- b. Be responsible for the production in its entirety including: auditions, rehearsals, staging, props, costumes, and other production needs.
- c. Ensure that the productions are appropriate for the general public.
- d. Inform actors, directors, and producers of policies and building procedures and adhere to same.
- e. Schedule and pay any costs associated with securing a Parks supervisor in order to open the Allison Jukebox Building (category B of the price schedule) for restroom access during times when the building is not open to the public.

5.0 Terms Mutually Agreed to by all Partners to This Agreement:

- a. The intent of this Agreement is to document a mutually beneficial partnership between BPRD and MCCT.
- b. The staff and personnel involved in this Agreement will at all times represent both partners to this Agreement in a professional manner, and reflect the commitment of both partners to quality services and customer satisfaction.
- c. The commitment of personnel, promotions, equipment, and funding sources will be honored according to the timetable agreed upon by both partners.
- d. MCCT is recognized as having the expertise and experience to run the production safely and effectively. BPRD shall have the right to review risk management, agreement terms, and service quality issues.

- e. The Agreement and the services provided will be evaluated in January, 2017.
- f. The possession of alcoholic beverages, drugs and other illegal controlled substances, fireworks, air rifles, paintball guns, bow and arrows, cross bows, swords, and pellet guns is strictly prohibited in any park or park facility. In addition, pursuant to Bloomington Municipal Code 14.20.020, the discharge of a firearm is strictly prohibited within the City's jurisdiction. Amplified music, or the promotion or sale of any article is expressly prohibited without a Special Use Permit.
- g. Municipal Code sections 6.12.020 prohibit smoking inside City of Bloomington facilities on City of Bloomington property.

The breaching party shall then have ten (10) days from the date of mailing in which to cure the breach. If the breaching party fails to cure the breach within ten (10) days, the non-breaching party may, at its option and in writing, unilaterally terminate the Agreement.

8.0 Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in anyway affect the other party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

9.0 Release and Hold Harmless Agreement:

The MCCT, including its representatives, agents, and assigns, does hereby agree to release, hold harmless, and indemnify the City of Bloomington, its Parks and Recreation Department, and any and all employees, agents, and assigns from any and all claims, causes of action, suits, proceedings, or demands, including but not limited to claims involving personal injury or death, which may arise from this Agreement, even if caused by the negligence of releases.

10.0 Verification of New Employees' Immigration Status

Pursuant to Ind. Code 22-5-1.7-11(a), which was adopted on July 1, 2011, MCCT as a business entity has to enroll in and verify the work eligibility status of all newly hired employees through the E-Verify program. MCCT is not required to continue this verification if the E-Verify program no longer exists. However, MCCT is a not-for-profit organization that does not have any employees and therefore, is not able to register with the E-Verify program. As a consequence, in order to be in compliance with Ind. Code 22-5-1.7-11(a), MCCT shall sign an affidavit affirming that MCCT currently does not employ any employees, but only works with volunteers, and if MCCT should hire any employee or contract employee, it commits itself to participate in the E-Verify program and will immediately sign an amended Affidavit as required by state law, that it is registered with the E-Verify program and if it hires employees, it will not be employing any unauthorized alien. The Affidavit to this effect is attached to and incorporated into this Agreement as Exhibit A.

If an amended affidavit becomes necessary during the term of this Agreement, MCCT –by signing this Agreement—commits itself to (1) notify BPRD prior to hiring such an employee or contracting with a contract employee, (2) register with e-verify prior to the hiring, (3) check the employee through E-Verify, and (4) sign the amended Affidavit within three (3) business days prior to hiring an employee.

- **3.3.** Promote the *Movies in the Park* in a quarterly Program Guide and through public service announcements and news releases, listing The Ryder as a co-sponsor in all publicity.
- **3.4.** Work with The Ryder on selecting appropriate films for *Movies in the Park*.

3.5. Pay The Ryder Twenty-Five Dollars (\$25.00) over the cost of the movie rights to cover the shipping fees. BPRD will pay The Ryder in two (2) installments, following the third and fifth movies. BPRD will e-mail The Ryder after the third and fifth (last) movies to secure an invoice for the amount due, and will pay the invoice within thirty (30) days after receipt. Ryder shall sign an affidavit, attached as Exhibit A, affirming that Ryder does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Ryder and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Ryder or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Ryder or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Ryder or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Ryder or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Ryder or subcontractor did not knowingly employ an unauthorized alien. If the Ryder or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City board or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Ryder. If the City terminates the contract, the Ryder or subcontractor is liable to the City for actual damages.

Ryder shall require any subcontractors performing work under this contract to certify to the Ryder that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Ryder shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

MOTHER NATURE LANDSCAPING

Recommendation

Staff recommends approval of the Adopt a Roundabout agreement with Mother Nature Landscaping. The proposed roundabout is located at Sare and Rogers Streets.

Background

Staff has been seeking opportunities to lower the cost of maintaining while increasing the aesthetics of some of the 80 public medians and roundabouts for which we are responsible. An interested local landscaping company, Mother Nature Landscaping, expressed interest in partnering with the City in this a pilot venture at the Winslow, High and Rogers Streets roundabout. This Partnership was successfully implemented in 2013. As a result of the success of the first Partnership, Mother Nature Landscaping/Bloomington Valley Nursery is interested in adopting the Sare and Rogers roundabout. Mother Nature Landscaping and Bloomington Valley Nursery are owned by Shawn Eurton.

A draft of the agreement is attached. Public Works owns the roundabout. Parks currently maintains it. Parks is proposing that this agreement be approved by the Board of Public Works and the Parks Board at the March 8 meetings of the Board of Parks Commissioners and Board of Public Works. Mother Nature would like implement the planting and signage plan in the spring of 2016.

Per this proposed agreement, Mother Nature Landscaping will plant approximately \$10,000 of landscape material in the roundabout at their cost; perform monthly maintenance to the site for 5 years; periodically change landscape material in the roundabout to enhance/change the aesthetics all at no cost to the City.

Per the agreement "public signs", as said term is defined by Title 20 of the Bloomington Municipal Code will be installed in the roundabout. The installed "public signs" are subject to the following requirements:

- Number: No more than four (4) public signs shall be installed.
- Design: The design, including the material and size, shall be determined by the City.
- Placement: The placement of each public sign shall be determined by the City.

• Costs: The Adopter shall be responsible for any and all costs associated with these public signs.

Signs will indicate that Mother Nature Landscaping has adopted the roundabout. The engineering department has provided Mother Nature with restrictions for the site and Parks/Public Works Boards will review/approve the planting materials and signage for city ordinance and other compliance issues.

Adopt-A-Roundabout Partnership Agreement

This agreement between the City of Bloomington, Department of Parks and Recreation (hereafter "City") and **Mother Nature Landscaping**, (hereinafter "Adopter") is to provide a means of improving, beautifying, and maintaining the roundabout located on **Sare and Rogers Street.** The roundabout described is approximately 100 feet in diameter.

All materials and labor necessary for the improvement and maintenance of the roundabout are the sole responsibility of the Adopter. The Adopter agrees to check the adopted location(s) on an as needed basis (minimum monthly basis), or upon request from the City, for landscape maintenance needs, and for removal of weeds, trash and litter, and other debris from the roundabout.

The Adopter agrees to provide to the City a schematic landscape plan noting species, sizes and planting locations, and Adopter shall obtain written approval from the City of Bloomington Department of Public Works, Planning and Parks and Recreation prior to the planting of any trees, shrubs, plants, flowers, or other vegetation. The City shall review all proposed planting locations for such factors as the presence of publicly and privately owned buried utilities, and potential vehicular traffic conflicts or obstructions, and compliance with local planning and zoning ordinance requirements, prior to permitting and work to proceed on the roundabout. In addition, Adopter shall be subject to the provisions of state law regarding locating underground utilities prior to excavating the site.

City roundabouts which are the subject of an Adopt-A Roundabout Partnership Agreement shall be required to install "public signs", as said term is defined by Title 20 of the Bloomington Municipal Code. The installed "public signs" are subject to the following requirements:

- Number: No more than four (4) public signs shall be installed.
- Design: The design, including the material and size, shall be determined by the City.
- Placement: The placement of each public sign shall be determined by the City.
- Costs: The Adopter shall be responsible for any and all costs associated with these public signs.

The roundabout described above shall remain the property of the City of Bloomington, and if, in the sole judgment of the City it is found that the Adopter is not meeting the terms and conditions of the agreement, the City may terminate this agreement and remove all signs. This agreement shall be in effect when signed by both parties and shall continue for a period of **five** (5) years from the date of signature; however either party may terminate the agreement earlier

upon seven days written notice to the other party. At the end of the five (5) year term, Adopter shall have the right to renew this Agreement for another **five** (5) **year** period, provided the City, in its sole discretion, determines that the roundabout will be adopted for another five (5) year period. All materials provided by Adopter under this Agreement will remain property of the Adopter and Adopter may remove the materials, or negotiate to sell them to the City, when the Agreement concludes or is terminated by either party.

The Adopter agrees that its volunteers, employees, or subcontractors are not acting as agents or employees of the City of Bloomington, and also shall agree to release the City of Bloomington from any liability arising hereunder, including from the negligence of releasee, and shall indemnify the City of Bloomington against any claims which may arise due, in whole or in part, to the negligence of the Adopter in its acts or omissions pursuant to this agreement. This agreement may be renewed by the written agreement of both parties upon original date of expiration.

TIF BOND FUNDED PROJECTS

Recommendation

Staff recommends approval of two TIF Bond funded contracts for outdoor lighting upgrades on the B-Line Trail (1) and Waldron, Hill and Buskirk Park (1)

Background

The four projects were approved and funded in the 2015 TIF Bond. These projects were also approved by the Redevelopment Commission (RDC) at the "Project Review" stage and will be submitted for funding approval at the RDC's March 7th meeting. Contract agreements with the four contractors are submitted for Board review and approval so we may initiate purchase orders and proceed with completion of these projects. Although funding is provided by the TIF Bond, as holders of the deeds on these park/trail/facility locations an approved contract through the Board of Park Commissioners is required. Details of the contract agreements are as follows:

Huston Electric-\$12,645 Replace existing metal halide pole lighting on the B-Line Trail

between 2nd and Rogers Street with high efficiency LED

lighting.

ECO Lighting Solutions-\$14,386 Replace existing sodium vapor parking lot pole lighting at the

southeast parking lot of Waldron, Hill, and Buskirk Park with

high efficiency LED lighting.

Cassady Electric, Inc - \$4,950 Installation of electrical breaker panel and LED flood lights

at the Buskirk-Chumley Theater.

AGREEMENT

BETWEEN

CITY OF BLOOMINGTON

PARKS AND RECREATION DEPARTMENT

AND

CASSADY ELECTRICAL CONTRACTORS, INC.

FOR

BUSKIRK-CHUMLEY LED LIGHTING UPGRADES

THIS AGREEMENT, executed by and between the City of Bloomington, Parks and Recreation Department through its Board of Park Commissioners (hereinafter CITY), and Cassady Electrical Contractors, Inc., (hereinafter CONTRACTOR);

WITNESSETH THAT:

WHEREAS, CITY desires to retain CONTRACTOR'S services for **SCOPE OF WORK** (more particularly described in Attachment A, "Scope of Work"; and

WHEREAS, CONTRACTOR is capable of performing work as per his/her proposal; and

WHEREAS, in accordance with Indiana Code 5-16-13 *et seq.*, incorporated herein by reference, Contractor is a Tier 1 or General Contractor for this project; and

WHEREAS, CONTRACTOR, based upon his/ her proposal, was determined to be the most advantageous to the City for the said project.

NOW, THEREFORE, in consideration of the mutual promises hereinafter enumerated, the parties agree as follows:

ARTICLE 1. TERM

<u>1.01</u> This Agreement shall be in effect upon execution of this Agreement by all parties. In accordance with Indiana Code 5-16-13 *et seq.*, incorporated herein by reference, Contractor is a Tier 1 contractor or general contractor for this project.

ARTICLE 2. SERVICES

- **2.01** CONTRACTOR shall complete all work required under this Agreement on or before May 13th, 2016, unless the parties mutually agree to a later completion date. Substantial Completion shall mean completion of all work.
- **2.02** CONTRACTOR agrees that no charges or claims for damages shall be made by him for any delays or hindrances, from any cause whatsoever during the progress of any portion of the services specified in the Agreement. Such delays or hindrances, if any, may be compensated for by an extension of time for a reasonable period as may be mutually agreed upon between the parties, it being understood, however, that permitting CONTRACTOR to proceed to complete any service, or any part of the services / project, after the date to which the time of completion may have been extended, shall in no way operate as a waiver on the part of CITY of any of its rights herein.

ARTICLE 3.COMPENSATION

- <u>3.01</u> CONTRACTOR shall provide services as specified in Attachment A, "Scope of Work", attached hereto and incorporated into this Agreement.
- <u>3.02</u> Upon the submittal of approved claims, CITY shall compensate CONTRACTOR in a lump sum not to exceed Four Thousand Nine Hundred Fifty Dollars (\$4,950). CITY may withhold payment, in whole or in part, to the extent necessary to protect itself from a loss on account of any of the following:
 - Defective work.
 - Evidence indicating the probable filing of claims by other parties against CONTRACTOR which may adversely affect CITY.
 - Failure of CONTRACTOR to make payments due to subcontractors, material suppliers or employees.
 - Damage to CITY or a third party.
- <u>3.03</u> The submission of any request for payment shall be deemed a waiver and release by CONTRACTOR of all liens and claims with respect to the work and period to which such payment request pertains except as specifically reserved and noted on such request.
- <u>3.04</u> CONTRACTOR shall maintain proper account records for the scope of all services of this Agreement and provide an accounting for all charges and expenditures as may be necessary for audit purposes. All such records shall be subject to inspection and examination by CITY's representatives at reasonable business hours.
- <u>3.05</u> For projects utilizing federal funding the CONTRACTOR shall submit time sheets (WH-347) for his own and all subcontracted employees, to City Superintendent of Operations or his representative for

approval and review, including review for compliance with Davis Bacon requirements, if federal funds are used.

<u>3.06</u> <u>Superintendent of Operations.</u> The Superintendent of Operations or his representative shall act as the CITY's representative and assume all duties and responsibilities and have all the rights and authority assigned to the Superintendent of Operations in the Contract Documents in connection with completion of the Work in accordance with the Contract Documents.

ARTICLE 4. RETAINAGE

For contracts in excess of \$100,000, the Owner requires that retainage be held set out below.

- **<u>4.01</u>** Escrow Agent The retainage amount withheld shall be placed in an escrow account. First Financial Bank, Bloomington, Indiana, shall serve as the escrow agent.
- **<u>4.02</u> Retainage Amount** The escrow agent, Owner and Contractor shall enter into a written escrow agreement. Under that agreement, the Owner shall withhold ten percent (10%) of the dollar value of all work satisfactorily completed until the Contract work is fifty percent (50%) completed. No additional retainage shall be withheld on the remaining fifty percent (50%) of the Contract work. The escrow agent shall invest all escrowed principal in obligations selected by the escrow agent. The escrow agent shall be compensated for the agent's services by a reasonable fee, agreed upon by the parties, that is comparable with fees charged for the handling of escrow accounts of similar size and duration. The fee shall be paid from the escrow income. The escrow agent's fee may be determined by specifying an amount of interest the escrow agent will pay on the escrowed amount, with any additional earned interest serving as the escrow agent's fee. The escrow agreement may include other terms and conditions as deemed necessary by the parties.
- <u>4.03</u> <u>Payment of Escrow Amount</u> The escrow agent shall hold the escrowed principal and income until receipt of the notice from the Owner and Contractor that the Contract work has been substantially completed to the reasonable satisfaction of the Owner, at which time the Owner shall pay to the Contractor the balance to be paid under this Contract and execute such documents as are necessary to authorize the escrow agent to pay to the Contractor the funds in the escrow account, including both specifying the part of the escrowed principal to be released from the escrow and the person to whom that portion is to be released. After receipt of the notice, the escrow agent shall remit the designated part of the escrowed principal and the escrowed income, minus the escrow agent's fees, to the person specified in the notice. However, nothing in this section shall prohibit Owner from requiring the escrow agent to withhold amounts necessary to complete minor items of the Contract, following substantial completion of the Contract in accordance with the provisions of paragraph 4.04.
- <u>4.04</u> <u>Withholding Funds for Completion of Contract</u> If, upon substantial completion of the Contract, there still remains minor Contract work that needs to be completed, or minor Contract work that needs to be performed to the satisfaction of the Owner, Owner may direct the escrow agent to retain in the escrow account, and withhold from payment to the Contractor, an amount equal to two hundred

percent (200%) of the value of said work. The value of said work shall be determined by the architect/Superintendent of Operations or his representative. The escrow agent shall release the funds withheld under this section after receipt of notice from the Owner that all work on the Contract has been satisfactorily completed. In the event that said work is not completed by the Contractor, but by Owner or another party under contract with the Owner, said funds shall be released to the Owner.

ARTICLE 5. GENERAL PROVISIONS

<u>5.01</u> CONTRACTOR agrees to indemnify and hold harmless CITY and its officers, agents, officials and employees for any and all claims, actions, causes of action, judgments and liens arising out of any negligent act or omission by CONTRACTOR or any of its officers, agents, officials, employees, or subcontractors or any defect in materials or workmanship of any supply, materials, mechanism or other product or service which it or any of its officers, agents, officials, employees, or subcontractors has supplied to CITY or has used in connection with this Agreement and regardless of whether or not it is caused in part by a party indemnified herein under. Such indemnity shall include attorney's fees and all costs and other expenses arising there from or incurred in connection therewith and shall not be limited by reason of the enumeration of any insurance coverage required herein.

5.02 Abandonment, Default and Termination

5.02.01 CITY shall have the right to abandon the work contracted for in this Agreement without penalty. If CITY abandons the work described herein, CONTRACTOR shall deliver to CITY all surveys, notes, drawings, specifications and estimates completed or partially completed and these shall become the property of CITY. The earned value of the work performed shall be based upon an estimate of the proportion between the work performed by CONTRACTOR under this Agreement and the work which CONTRACTOR was obligated to perform under this Agreement. This proportion shall be mutually agreed upon by CITY and CONTRACTOR. The payment made to CONTRACTOR shall be paid as a final payment in full settlement of his services hereunder.

5.02.02 If CONTRACTOR defaults or fails to fulfill in a timely and proper manner the obligations pursuant to this Agreement, CITY may, after seven (7) days' written notice has been delivered to CONTRACTOR, and without prejudice to any other remedy it may have, make good such deficiencies and may deduct the cost thereof from the payment then or thereafter due to CONTRACTOR. In the alternative, CITY, at its option, may terminate this Agreement and take possession of the site and of all materials, equipment, tools and construction equipment and machinery thereon owned by CONTRACTOR, and may finish the project by whatever method it may deem expedient, and if the such action exceeds the unpaid balance of the sum amount, CONTRACTOR or his surety, shall pay the difference to CITY.

5.02.03 Default: If CONTRACTOR breaches this Agreement or fails to perform the work in an acceptable manner, he shall be considered in default. Any one or more of the following will be considered a default:

- Failure to begin the work under this Agreement within the time specified.
- Failure to perform the work with sufficient supervision, workmen, equipment and materials to insure prompt completion of said work within the time limits allowed.
- Unsuitable performance of the work as determined by City Superintendent of Operations or his representative.
- Neglecting or refusing to remove defective materials or failure to perform anew such work as shall have been rejected.
- Discontinuing the prosecution of the work or any part of it.
- Inability to finance the work adequately.
- If, for any other reason, CONTRACTOR breaches this Agreement or fails to carry on the work in an acceptable manner.

5.02.04 CITY shall send CONTRACTOR a written notice of default. If CONTRACTOR, or his Surety, within a period of ten (10) days after such notice, fails to remedy the default, then CITY shall have full power and authority, without violation of the Contract, to take the prosecution of the work out of the hands of said CONTRACTOR, to appropriate or use any or all materials and equipment on the ground as may be suitable and acceptable, and may, at its option, turn the work over to the Surety, or enter into an agreement with another Contractor for the completion of the Agreement according to the terms and provisions thereof, or CITY may use such other methods as, in its opinion, shall be required for the completion of said Contract in an acceptable manner.

5.02.05 All cost of completing the work under the Contract shall be deducted from the monies due or which may become due to said CONTRACTOR. In case the expenses so incurred by CITY shall be less than the sum which would have been payable under the Contract if it had been completed by said CONTRACTOR, CONTRACTOR shall be entitled to receive the difference. However, in case such expense shall exceed the sum which would have been payable under the Contract, CONTRACTOR and his Surety will be liable and shall pay to CITY the amount of said excess. By taking over the prosecution of the work, CITY does not forfeit the right to recover damages from CONTRACTOR or his Surety for his failure to complete the work in the time specified.

5.02.06 Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of the Agreement by CITY are at any time not forthcoming or are insufficient, through failure of any entity to appropriate the funds or otherwise, then CITY shall have the right to terminate this Agreement without penalty by giving prior written notice documenting the lack of funding in which instance, unless otherwise agreed to by the parties, this Agreement shall terminate and become null and void.

5.02.07 CITY agrees that it will make its best effort to obtain sufficient funds, including but not limited to, including in its budget for each fiscal period during the term hereof a request for sufficient funds to meet its obligations hereunder in full.

5.03 Successors and Assigns

5.03.01 Both parties agree that for the purpose of this Agreement, CONTRACTOR shall be an Independent Contractor and not an employee of CITY.

5.03.02 No portion of this Agreement shall be sublet, assigned, transferred or otherwise disposed of by CONTRACTOR except with the written consent of CITY being first obtained. Consent to sublet, assign, transfer, or otherwise dispose of any portion of this Agreement shall not be construed to relieve CONTRACTOR of any responsibility of the fulfillment of this Agreement.

5.04 Extent of Agreement: Integration

5.04.01 This Agreement consists of the following parts, each of which is as fully a part of this Agreement as if set out herein:

- 1. This Agreement and its Attachments.
- 2. All Written Amendments and other documents amending, modifying, or supplementing the Contract Documents which may be delivered or issued after the Effective Date of the Agreement and are not attached hereto.
- 3. All Addenda to the Request For Proposal
- 4. The Request for Proposal
- 5. All plans as provided for the work that is to be completed.
- 6. The Specifications.
- 7. CONTRACTOR'S proposal.
- 8. Request for Taxpayer Identification number and certification: Substitute W-9.

5.04.02 In resolving conflicts, errors, discrepancies and disputes concerning the Scope of Work to be performed by CONTRACTOR, and other rights and obligations of CITY and CONTRACTOR, the document expressing the greater quantity, quality or other scope of work in question, or imposing the greater obligation upon CONTRACTOR and affording the greater right or remedy to CITY shall govern; otherwise the documents shall be given precedence in the order as enumerated above.

5.05 Insurance

<u>5.05.01</u> CONTRACTOR shall, as a prerequisite to this Agreement, purchase and thereafter maintain such insurance as will protect him from the claims set forth below which may arise out of or result from CONTRACTOR'S operations under this Agreement, whether such operations be by CONTRACTOR or by any SUBCONTRACTORS or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable:

5.05.02 CONTRACTOR'S comprehensive general liability insurance shall also provide coverage for the following:

• Premises and operations;

Coverage

- Contractual liability insurance as applicable to any hold-harmless agreements;
- Completed operations and products; which also must be maintained for a minimum period of two (2) years after final payment and CONTRACTOR shall continue to provide evidence of such coverage to CITY on an annual basis during the aforementioned period;
- Broad form property damage including completed operations;
- Fellow employee claims under Personal Injury; and
- Independent Contractors.

5.05.03 With the prior written approval of CITY, CONTRACTOR may substitute different types or amounts of coverage for those specified as long as the total amount of required protection is not reduced.

5.05.04 Certificates of Insurance showing such coverage then in force (but not less than the amount shown above) shall be on file with CITY prior to commencement of work. These Certificates shall contain a provision that coverage afforded under the policies will not be canceled or non-renewed until at least sixty (60) days' prior written notice has been received by CITY. The CITY shall be named as an additional insured on the Commercial General Liability, Automobile Liability, and Umbrella Excess Liability policies. The CONTRACTOR shall agree to a waiver of subrogation on its Worker's Compensation policy.

<u>5.06</u> <u>Necessary Documentation</u> CONTRACTOR certifies that it will furnish CITY any and all documentation, certification, authorization, license, permit or registration required by the laws or rules and regulations of the City of Bloomington, the State of Indiana and the United States. CONTRACTOR further certifies that it is now and will maintain in good standing with such governmental agencies and that it will keep its license, permit registration, authorization or certification in force during the term of this Agreement.

<u>5.07</u> Applicable Laws CONTRACTOR agrees to comply with all federal, state, and local laws, rules and regulations applicable to CONTRACTOR in performing work pursuant to this Agreement, including, but not limited to, discrimination in employment, prevailing wage laws, conflicts of interest, public notice, accounting records and requirements. This Agreement shall be governed by the laws of the United States, and the State of Indiana, and by all Municipal Ordinances and Codes of the City of Bloomington. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

5.08 Non-Discrimination

5.08.01 CONTRACTOR and subcontractors shall not discriminate against any employee or applicant for employment, to be employed in the performance of this Agreement, with respect to hire, tenure, terms, training, conditions or privileges of employment, because of race, sex, color, religion, national origin, ancestry, disability, sexual orientation, gender identity, veteran status, or housing status. Breach of this covenant may be regarded as a material breach of the Agreement.

5.08.02 CONTRACTOR certifies for itself and all its subcontractors compliance with existing laws of the City of Bloomington, the State of Indiana and the United States regarding:

Prohibition of discrimination in employment practices on the basis of race, sex, color, religion, national origin, ancestry, disability, sexual orientation, gender identity, veteran status, housing status or any other legally protected classification;

The utilization of Minority and Women Business Enterprises. CONTRACTOR further certifies that it:

- a. Has formulated its own Affirmation Action plan for the recruitment, training and employment of minorities and women, including goals and timetable; which has been approved by the City's Contract Compliance Officer.
- b. Encourages the use of small business, minority-owned business and women-owned business in its operations.

5.08.03 FURTHER, PURSUANT TO INDIANA CODE 5-16-6-1, CONTRACTOR AGREES:

- A) That in the hiring of employees for the performance of work under this Agreement or any sub agreement hereunder, no contractor, or subcontractor, nor any person acting on behalf of such CONTRACTOR or subcontractor, shall by reason of race, sex, color, religion, national origin, ancestry, or any other legally protected classification, discriminate against any citizen of the State of Indiana who is qualified and available to perform the work to which the employment relates.
- B) That no contractor, subcontractor, or any person on their behalf, shall, in any manner, discriminate against or intimidate any employee hired for performance of work under this Agreement on account of race, religion, color, sex, national origin, ancestry or any other legally protected classification.
- C) That there may be deducted from the amount payable to CONTRACTOR, by CITY, under this Agreement, penalty of Five Dollars (\$5.00) for each person for each calendar day during which such person was discriminated against or intimidated in violation of the provisions of this Agreement. Any such person discriminated against retains the right to file a discrimination complaint with the appropriate civil rights agency or court.
- D) That this Agreement may be canceled or terminated by CITY and all money due or to become hereunder may be forfeited, for a second or any subsequent violations of the terms or conditions under this section of the Agreement.

5.09 Workmanship and Quality of Materials

5.09.01 CONTRACTOR shall guarantee the work for a period of one (1) year from the date of substantial completion. Failure of any portion of the work within one (1) year due to improper construction, materials of construction, or design may result in a refund to CITY of the purchase price of that portion which failed or may result in the forfeiture of CONTRACTOR's Performance Bond.

- equipment is defined by describing a proprietary product, or by using the name of a manufacturer or vender, the term "Or Equal" or the term "The Equivalent" if not inserted, shall be implied, and it is done for the express purpose of establishing a basis of durability and efficiency and not for the purpose of limiting completion. Whenever material or equipment is submitted for approval as being equal to that specified, the submittal shall include sufficient information and data to demonstrate that the material or equipment conforms to the Contract requirements. The decision as to whether or not such material or equipment is equal to that specified shall be made by the City Superintendent of Operations or his representative. The approval by the City Superintendent of Operations or his representative of alternate material or equipment as being equivalent to that specified, shall not in any way relieve CONTRACTOR of responsibility for failure of the material or equipment due to faulty design, material, or workmanship, to perform the function required by the Contract Documents. Specifications as determined by other entities within the City of Bloomington such as City Utilities shall only be substituted or changed by their approval which shall be submitted in writing to the City Superintendent of Operations or his representative.
- **5.09.03** CITY shall be the sole judge of the sufficiency of workmanship and quality of materials. Disputes shall be resolved by the Director of Parks and Recreation and are not subject to arbitration.
- <u>5.10</u> <u>Safety</u>. CONTRACTOR shall be responsible for the safety of employees at all times and shall provide all equipment necessary to insure their safety. CONTRACTOR shall ensure the enforcement of all applicable safety rules, regulations, ordinances and laws, whether federal, state or local. Contractor's Superintendent of Safety shall make daily inspections upon the arrival and leaving of the site at the close of each workday.

5.11 Amendments/Changes

- **5.11.01** Except as provided in Paragraph 5.11.02, this Agreement may be amended only by written instrument signed by both CITY and CONTRACTOR.
- **5.11.02** Without invalidating the Agreement and without notice to any surety, CITY may, at any time or from time to time, order, in writing, additions, deletions, or revisions in the work. Upon receipt of any such document, CONTRACTOR shall promptly proceed with the work involved, which will be performed under the applicable conditions of the Agreement Documents.
- 5.11.03 If CONTRACTOR believes that any direction of CITY under paragraph 5.11.02, or any other event or condition, will result in an increase in the Contract time or price, he shall file written notice with CITY no later than twenty (20) calendar days after the occurrence of the event giving rise to the claim and stating the general nature of the claim with supporting data. No claim for any adjustment of the Contract time or price will be valid if not submitted in accordance with this Paragraph.

5.11.04 CONTRACTOR shall carry on the work and adhere to the progress schedule during all disputes or disagreements with CITY. No work shall be delayed or postponed pending resolution of any dispute or disagreement except as CONTRACTOR and CITY may otherwise agree in writing.

5.12 Performance Bond and Payment Bond

- **5.12.01** For contracts in excess of \$100,000, CONTRACTOR shall provide CITY with a Performance Bond and a Payment Bond in the amount of one hundred percent (100%) of the contract amount.
- **5.12.02** Failure by CONTRACTOR to perform the work in a timely or satisfactory fashion may result in forfeiture of CONTRACTOR'S Performance Bond.
- **5.12.03** If the surety on any bond furnished by CONTRACTOR becomes a party to supervision, liquidation, or rehabilitation action pursuant Indiana Code 27-9 et seq . or its right to do business in the State of Indiana is terminated, CONTRACTOR shall, within thirty (30) calendar days thereafter, substitute another bond and surety, both of which must be acceptable to CITY.
- <u>5.13</u> <u>Payment of Subcontractors</u> CONTRACTOR shall pay all subcontractors, laborers, material suppliers and those performing services to CONTRACTOR on the project under this Agreement. CITY may, as a condition precedent to any payment hereunder, require CONTRACTOR to submit satisfactory evidence of payments of any and all claims of subcontractors, laborers, material suppliers, and those furnishing services to CONTRACTOR. Upon receipt of a lawful claim, CITY shall withhold money due to CONTRACTOR in a sufficient amount to pay the subcontractors, laborers, material suppliers, and those furnishing services to CONTRACTOR.
- <u>5.14</u> <u>Written Notice</u> Written notice shall be considered as served when delivered in person or sent by mail to the individual, firm, or corporation, or to the last business address of such known to CONTRACTOR who serves the Notice. Notice shall be sent as follows:

<u>5.15</u> <u>Severability and Waiver</u> In the event that any clause or provision of this Agreement is held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not affect any other provision of this Agreement. Failure of either party to insist on strict compliance with any provision of this Agreement shall not constitute waiver of that party's right to demand later compliance with the same or other provisions of this Agreement.

5.16 Notice to Proceed CONTRACTOR shall not begin the work pursuant to the "Scope of Work" of this Agreement until it receives an official written Notice to Proceed from the City. Contractor shall start active and continuous work on the Agreement within five (5) calendar days after the date of the Notice to Proceed. In no case shall work begin prior to the date of the Notice to Proceed. If a delayed starting date is indicated in the proposal, the five (5) calendar day limitation will be waived. Work day charges will then begin on a date mutually agreed upon, but not later than the delayed starting date specified. In the event that any Agreement is canceled after an award has been made but prior to the issuing of the Notice to Proceed, no reimbursement will be made for any expenses accrued relative to this contract during that period.

5.17 Steel or Foundry Products

5.17.01 To comply with Indiana Code 5-16-8, affecting all contracts for the construction, reconstruction, alteration, repair, improvement or maintenance of public works, the following provision shall be added: If steel or foundry products are to be utilized or supplied in the performance of any contract or subcontract, only domestic steel or foundry products shall be used. Should CITY feel that the cost of domestic steel or foundry products is unreasonable; CITY will notify CONTRACTOR in writing of this fact.

5.17.02 Domestic Steel products are defined as follows:

"Products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two (2) or more of such operations, from steel made in the United States by open hearth, basic oxygen, electric furnace, Bessemer or other steel making process."

5.17.03 Domestic Foundry products are defined as follows:

"Products cast from ferrous and nonferrous metals by foundries in the United States."

5.17.04 The United States is defined to include all territory subject to the jurisdiction of the United States.

5.17.05 CITY may not authorize or make any payment to CONTRACTOR unless CITY is satisfied that CONTRACTOR has fully complied with this provision.

<u>5.18</u> Verification of Employees' Immigration Status

CONTRACTOR is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). CONTRACTOR shall sign an affidavit, attached as Attachment B, affirming that CONTRACTOR does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code Chapter 12 or by the U.S. Attorney General.

CONTRACTOR and any of its subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the CONTRACTOR or any of its subcontractors learns is an unauthorized alien. If the City obtains information that the CONTRACTOR or any of its subcontractors employs or retains an employee who is an unauthorized alien, the City shall notify the CONTRACTOR or its subcontractors of the Agreement violation and require that the violation be remedied within thirty (30) calendar days of the date of notice. If the CONTRACTOR or any of its subcontractors verify the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the CONTRACTOR or its subcontractor did not knowingly employ an unauthorized alien. If the CONTRACTOR or its subcontractor fails to remedy the violation within the thirty (30) calendar day period, the City shall terminate the Agreement, unless the City determines that terminating the Agreement would be detrimental to the public interest or public property, in which case the City may allow the Agreement to remain in effect until the City procures a new contractor. If the City terminates the Agreement, the CONTRACTOR or its subcontractor is liable to the City for actual damages.

CONTRACTOR shall require any subcontractors performing work under this Agreement to certify to the CONTRACTOR that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. CONTRACTOR shall maintain on file all subcontractors' certifications throughout the term of this Agreement with the City.

Recommendation

Staff recommends awarding Coca-Cola our beverage provider for a three year term, 2016-2018.

Background

Quotes were received from both Pepsico and Coca-Cola. Analysis was done using historical volume numbers per an annual time period and then the life of the agreement.

The overall bids were surprisingly similar. Pepsico's quote was slightly cheaper in price in both the non-vending (we serve the beverages from behind a counter) and vending category. Vending can be either self service (we empty the money and fill the product) or full service (beverage provider deals with the money and filling the product and sends a percentage rebate). We typically choose the full service as it eliminates labor, storage, and shrinkage.

Coca Cola offered \$10,500 per year in sponsorship cash at the beginning of each contract year and that was the tipping point. Pepsico offered \$10,000 in year one, \$5,000 in years two and three.

Below is a summary of the number analysis our staff reviewed:

<u>Coca-Cola</u> <u>Pepsico</u>

\$93,591 estimated cost of product over 3 years
\$31,500 payments over 3 years of contract
\$62,091 estimated net cost of product over 3 years
\$88,779 estimate cost of product over 3 years
\$20,000 payments over 3 years of contract
\$68,779 est. net cost of product over 3 years

The difference is close and estimated to be about \$6,000 or about 10% of the contract.

Brand Preference/Gross Sales

Some retailers think they may sell one brand more than another but we do not have strong feelings along those lines. Our basic premise is if there are choices, if it is hot outside, if the beverage is cold, and if the beverage is wet it will sell. One small exception is Gatorade. Pepsico provides Gatorade and it outsells Coke's Powerage by quite a margin. Pepsico brand leaders are strong with Mountain Dew, Gatorade, and Dr. Pepper. Coca-Cola's brand leaders are Coke, Diet Coke, Sprite and their sports drink is Powerade.

Service

Pepsico has been our provider the last two contract terms. We have experienced adequate service but never seen a representative. Coca-Cola does have a history of more contact and at least attentive service.

All facility managers that sell beverages have been consulted and gave input on the recommendation.

Background

This report is for information purposes only. The following is a description of 2016 events. Included in Community Events are concerts, movies, events, Farmers' Market, parades, community gardens, and A Fair of the Arts, Programming for the dog park and the 50+ Expo.

Events for 2016 include:

Seusspicious Behavior – This event was held on March 5th and is a collaboration with the library. Bloomington High School North provided a live performance throughout the event and there were 500+ participants.

Children's Expo will be held on April 10th at the Monroe County Convention Center. 31st year for this event.

The **Bloomington Community Farmers' Market** begins on April 2nd and runs from 8am – 1pm. The Tuesday Market runs 4-7pm from June through September on Madison just outside of Bloomingfoods.

The **Community Gardens** will open on April 15th. Willie Streeter Community Gardens and the Rev. Butler Park Community Gardens offer 210 garden plots for rent. Plant a Row for the Hungry generated 30,000 lbs of food in 2015 and has generated 351,042 lbs of food since 2002.

Nature Sounds –A unique listening experience that pair's acoustic music with song of the wild. Each program includes an introduction to the park's current music makers, an hour-long concert, and a guided nature walk. Four dates in 2016. Various locations such as Griffy Lake and Lower Cascades.

The Fourth of July Parade is a partnership with Downtown Bloomington Inc. Any groups who would like to receive an application to march in the parade can contact the Parks office. There is a \$25 fee and space is limited.

Messy Mania -This ever-popular event will be held on July 12th from 9am – noon any Bryan Park. Kids can get crazy when they experiment with all kinds of messy mediums. Hands-on activities will delight every youngster who loves to squish, splatter, and fling!

The **Movies in the Parks** series is back with a line up of movies that are sure to please. Partnering with Ryder Film Series, we will be showing movies on Friday nights at dusk in Bryan Park, Butler Park, and at the Ferguson Dog Park beginning in August. \$1,700 in sponsorships makes this movie series a reality.

Dogs rule at Mills Pool. **Drool in the Pool** celebrates its 12th anniversary and will be held on August 10th & 11th from 5-8pm. Dogs will doggie dip in this annual event after the pool is closed for the season to humans. Admission both days is \$5/dog.

Junk in the Truck is our version of a community rummage sale and will be held on August 20th at the Frank Southern Center parking lot from 8am – 1pm. This event is free an open to the public. Anyone interested in participating as a seller can reserve a space for \$20. The location makes parking for shoppers a breeze.

Fall programs in 2015 will include the **Trick or Treat Trail** in RCA Park on October 22nd and the **Festival of Ghost Stories** on October 28^h in Bryan Park.

The Great Bloomington Pumpkin Launch continues to provide great entertainment for children and adults alike. This event will be held October 29th this year. We will once again partner up with WonderLab and Monroe County Fairgrounds.

We will finish out the year with the annual **Holiday Market** on November 26th from 10am – 3pm. This Bloomington tradition will feature some of your favorite, locally-grown farm products, arts and crafts, entertainment and much, much more.
