  - Add this disclaimer to that first page:
  - This information is not a true representation for domestic violence in Monroe County. It just represents that data collected by agencies under specific circumstances reporting to Monroe County Domestic Violence Coalition.

- Ron (Batterers Intervention Program): Is there an issue on the difference between domestic and family violence? For offenders, it is a 12 versus 26 weeks need to go through (DV going through the 26). They also have Earned Dismissal (sort of diversion program) successfully completes probation with no violation and no criminal charge, then they can have case dismissed. There is a significant percentage of people have mental health issues and sometimes they need to be dismissed until they address that issue.
