### II. Strangulation Presentation by Barbara Bachmeier

### A. Definitions

- 1. Legal and Medical > see presentation slides for text
- 2. Strangulation: External force is applied to the neck that results in a depressed or complete loss of consciousness
- 3. Asphyxia: Function cells in the body, particularly the brain, are deprived of oxygen
- 4. External force: hands (manual), ligature (cord-like) or gravity (hanging)
  - a) Manual force is most common
  - b) Estimation of force is generally not possible to calculate

#### B. Injuries

- 1. Fractured hyoid bone
  - a) Not very common in strangulation, but more common in
- 2. Thyroid cartilage
  - a) Possible to fracture
- 3. Tracheal rings
  - a) Commonly fractured
- 4. Obstruction of vessels

- a) Interruption of oxygenation causing cell death
- 5. Timeline
  - a) 20-30 seconds causes petechiae above the point of construction
  - b) 2 minutes to full consciousness
  - c) 2 minutes or more causes cell death
    - (1) Suffocation will accelerate the process of cell death
    - (2) If there is intermittent strangulation, they damage will be slowed

#### C. Signs and Symptoms

- 1. Signs are physically seen and symptoms are reported by the victim
- 2. Breathing changes
- 3. Voice changes
- 4. Swallowing changes
- 5. Symptoms
  - a) Any of these symptoms require an evaluation (near death)
    - (1) Loss of bowel or bladder
    - (2) Unconsciousness
    - (3) Petechiae
  - b) What victim advocates should check for and document
    - (1) Rips, tears or bite marks in victim's mouth
    - (2) Patches of hair loss
    - (3) Blood red eyes (hemorrhage)
      - (a) May not be evident in the first few hours
    - (4) Neck swelling
    - (5) Bruising around the neck
    - (6) Rope burns
    - (7) Red spots or scratches on the neck
    - (8) Questions about their environment
      - (a) What did you hear, see, think of
        - (i) You will get better answers
  - c) Mental health and behavioral changes
    - (1) Memory loss
    - (2) Confusion
  - d) Complications
    - (1) Pneumonitis: vomiting and taking in vomit to lungs
    - (2) Coronary artery dissection
    - (3) Mini strokes
      - (a) Vision blurriness
      - (b) Face drooping

### D. Lethality

- 1. Can lead to death in minutes
- 2. 50% of DV homicides involve a strangulation incident within the year prior
- 3. Lifelong effects even with no visible injury
- 4. Symptoms can appear rapidly

- 5. (Glass, et al, 2008)
  - a) Prior non-fatal strangulation was associated with greater than 6x odds of becoming an attempted homicide
  - b) Victims of prior attempted strangulation are 7 times more likely of becoming a homicide victim
