B. MCCSC policy on reduced lunches (Sue Wanzer and Cathy Fuentes-Rowher.)

Background Information: Children in the MCCSC school system are experiencing "lunch-shaming" where they are turned away from hot lunches because there is not enough credit in their account. Students who are receiving reduced lunch and their parents have a bill, are notified after they have gone through the lunch line that their account is overdrawn. The students' hot lunches are discarded in the trash and they are directed to get a cold lunch that consists of a peanut butter and jelly sandwich and cold milk.

The lunch system might not be set up in a way that is productive for students as they can continue to spend money and credit their accounts. Accounts can be charged up to the value of three lunches in debt before a student is prohibited from taking a hot meal. The students getting hit the hardest with lunch-shaming are those from working-poor families who are just above the line to qualify for free and reduced lunch programs which are under the purview of the Department of Agriculture. The lunch debt is currently at \$6,000.

Request for the Commission to write to the School Board to advocate for children, as well as for Commissioners to provide testimony at the School Board meeting on Tuesday at 6pm at the Administration Center near South high school. The policy will show on the meeting notes for Tuesday.

Motion by Seth Debro to compose a letter to the MCCSC School Board. Motion passed at 6:10pm.

C. Post-event evaluation (discussion): Black Barbershop Talk Moving forward, need to account for privacy and extending or changing the hours to draw more people. The event was well advertised and healthcare providers were impressed with the turnout. 18 were tested between 9am-12pm and another 30 people came throughout the day for conversations including mental health and spinal checks. Talks about mental health would be worth revisiting again.

There will be a recap conference call on the 22nd where representatives from 15 cities will share what worked.
