- a. Black male summit
 - i. Invite Patrick Smith, Director of the FASE Mentoring Program, to attend July meeting to discuss collaborating with summit.
 - ii. Stressed importance of summit being held annually, collaborating with programs already in existence (e.g. Black Males Matter movement) and relevant across wide demographic.

- a. Review and Approval of CSBM bylaws
 - i. Discussion of automatically adding award winners for Black Leaders of Tomorrow as affiliate positions.
 - 1. Each commission allowed up to 4 affiliates but requests must be justified. Commissioners should identify specific individuals and write letters to Council for approval.
 - 2. Commissioners encouraged to seek out diversity for affiliate positions in order to represent broader inclusiveness, bringing dynamic perspectives to the table (eg. youth, seniors, women, and the LGBTQ+ community).

 - i. Last year served 150. Evictions highest around back to school and Christmas.
 - ii. Sherwood Oaks providing some shoes. MCUM providing some toiletries.

- 3. Might want to get names from schools to recognize students a little earlier next year. Utilize grass roots strategies to source names.

ii. Health and Wellness

- 1. ICSSBM update on Black Barbership Initiative-recap phone conference
 - a. This year, there were 896 participants from all counties; average over past 4 years was 811.
 - i. In Bloomington: 2005, 1 person screened; 2017, 25 people screened.
 - ii. Liked: Thursday rather than Saturday. Synergy around Little 5.
 - b. Ages 30-39 had highest BMI and blood pressure; 80% showed signs of hypertension. Ages 18-29 had some warning factors. Oldest demographic was healthiest of all sampled.
 - c. Moving forward, different initiatives will be used to target the 30-39 age group.

- 1. Financial Literacy (Dollars and Sense Program)
 - a. Initial training with United Way was rescheduled for 12th, no commissioners were able to attend as the training session was full.
