## Chair's Report, Sally Gaskill -

(1) Sally shared that our own Peter Jacobi will receive the Ivy Tech Bloomington's Community Arts Award for Lifetime Achievement in the Arts on November 10th! Peter must attend the opera that night but Commissioners will make sure he will also be present at the Waldron for the awards ceremony. After all, the BAC submitted his nomination.

(2) Bicentennial Project: A group of Commissioners (Alain, Lynn, Abby, Sally) have met with Sean and would like to move forward with the Bicentennial Community Song. We expect it to be a \$5,000 or \$6,000 project and hope to receive creative proposals from local composers. We will release an RFQ in the very near future. The RFQ will lay out specific criteria as outlined by the committee. We would like a song that is accessible and singable, ideally in multiple formats (SATB, single melody, etc). We want proposals that will envision many roll-outs of the song throughout the community in our bicentennial year, 2017.

• Martina Celerin proposed that the BAC officially adopt the Bloomington Bicentennial Community Song as its Bicentennial Project and spend up to \$6,000 to implement it. All in favor.

**Grant Evaluation Update**: Sean said that Joanna Woronkowicz, IU arts administration faculty member, will complete the evaluation this fall so that we can incorporate any changes into the 2018 grants program.
