## 1. Introductions

- 2. Request for Additional Agenda Items City Staff liaison request Geoffrey Bradley to provide a brief summary of State of the Black Community.
- **3. Guest remarks** John Clower discussed the failure of law enforcement communities (outside of Bloomington Police Department, named: Owens, Spencer and Nashville counties). Clower requested support from the CSBM to join local coalition of groups which includes, NAACP, Universalist Unitarian Church to 1) pressure news reporting outlets to conduct a formidable indepth journalistic investigation about the lack of reporting by law enforcement communities; 2) partner with WFIU to host a training on how to recognize white privilege; 3) to engage with Indiana legislators to advocate for sanctions against departments that fail to comply with federal reporting law. *CSBM voted and approved to join the coalition*.

- B. Barbershop Talk 2018
  - 1. Commissioner Richardson indicated that the event will take place on the Thursday during the week of the IU "Little 500!" Commissioner Richardson will coordinate equipment needs for the event with Rafi Hasan. Commissioner Richardson indicated that HIV testing will not take place this year for reasons of privacy. Commissioner Richardson indicated that he will reach out to JW Barbershop on 2<sup>nd</sup> street.
  - 2. Staff liaison commented that Blue-Cross Blue Shield would like to partner with CSBM for Health initiatives.
- C. Request to recognize 2018 MCCSC graduates
