5. NEW BUSINESS

- A. The "Books in Barbershops" project has obtained interest from the Bridge Leadership Foundation (Indianapolis) and the Monroe County Public Library. Staff liaison has reported making contact with the owners of Razor's Image and Hoosier Barbershop.
- B. The 2018 Health and Wellness Initiative will involve the CSBM recruiting 100 Black males to participate in a study to increase the understanding of how Black males perceive and experience their health in Bloomington. The CSBM is attempting to conduct preliminary research which may assist the IU School of Public Health in future research studies and present information at the State of the Black Community in February of 2019.
- C. *The CSBM voted and unanimously approved measure* to create the Outstanding Black Woman of Tomorrow.

6. LIAISON REPORT

- A. The Bloomington Human Rights Commission (BHRC) has not made an appointment to the CSBM. One candidate was interviewed during their March meeting. Kourtney Byrd indicated her interview is scheduled for April 23rd.
- B. Commissioners should make efforts to contact staff liaison monthly, in addition to the monthly meeting. Meeting reminder, CSBM has a ten month schedule. The CSBM will not meeting in June or July. Reminder that commissioners should not campaign for candidates during commission programs which includes wearing merchandise that endorses a candidate.

The Monroe County Public Library (MCPL) will participate host Story Walk on Friday, April 20th, the MCPL will also host a Spoken Word event for READ FOR 200 Volunteers from 12pm to 4pm and MCPL will kick off Summer Reading Program with libraries rock on May 25. The Banneker is hosting an Open House on June 1. We have 53 Volunteers and 20 volunteers who have completed the orientation, background check and availability form. 4. Shirts are available.
