Call to order

Sally Gaskill called the meeting to order at 5:04pm.

Approval of March Minutes

Lynn Schwartzberg moved to approve. Nick Blandford seconded. Motion passed unanimously.

Financial Report

No changes in our finances. BAC has no operating money – what's in our operating fund is leftover from postcard sales. We have a new fund of \$50 created for public art by a donor in memory of a deceased artist. We can consider adding to it in order to maintain public art projects.

Richard Ross Residency in Bloomington - Recap

Rachel Glago reported that 347 people attended the events, and more than 1,200 engaged with everything including in-person and online. There were nine events in total. It was awesome. Richard Ross connected Sean Starowitz and Rachel to Julian Robinson in Louisville for more projects. Attendees from other counties at the stakeholder lunch are looking into connecting with the Juvenile Detention Alternatives Initiative for their facilities.

Bloomington Bicentennial Community Song

- The committee selected three finalists
- Meeting with them next week; we'll make a decision next week
- Diverse finalists yay

Arts Project Grants

- Six commissioners on the grants panel; three are returning, three new
 - o Sally, Lynn, Abby, Nick, Rachel, Emily
- 22 applicants
- Meeting April 25 at 4pm in a closed meeting to review grants
- May 9 meeting with full commission is when we will make final decisions

- In addition to the public meetings, Abby and Sally met with some applicants to give advice
- Michael pointed out that there is often great diversity of opinions between commissioners on each application, and some people might have been misled during the workshop if the commissioner they met with liked their application, but the committee doesn't. Others responded that each applicant generally gets more than one point of view from various commissioners.
- All commissioners are welcome to come to the panel meeting, but only the six on the panel will be scoring.
 - All commissioners should skim the applications so they are prepared to vote on May 9
- Conflicts of Interest must be reported before commissioners receive and score applications
 - Sean will send new form as soon as he gets it
- Nick suggested that first reader & second reader on each app be a combo of new and experienced commissioners
