Thank you for your response.

What I would like to do is obtain permission to be Sewer Area A from our current classification, Area B. The properties for proposed reclassification are:

Emogene Webb is my, and Leigh's, mother. Emogene Webb passed away September 11, 2018, and Leigh and I inherited the properties in her trust.
