A. Cyber stalking

1. Only increased in the past ten years as more and more has been put online
2. Formal definition for cyber stalking is included in the slides
 - a) Can include harassment, embarrassment, humiliation, economic controls and isolation

B. Revenge porn

1. Indiana does not currently have a law in place against revenge porn
2. It is typically easy to investigate but hard to charge any crime
3. California's law against revenge porn is a good example of legislation

C. Investigative process

1. Identify the ip address of the account
 - a) Identify username
 - b) Get a court order for the IP address of the postings
2. Identify the physical address of the ip address
 - a) Get a court order for the internet service provider
 - b) Receive the name and address of their customer

D. Protective order violations

1. Violations can go through the legal process or a victim can provide all of the necessary data

a) Victim would go to [download all data on Facebook](#)'

E. How easy is it?

1. [Stalkface.com](#): Pulls all information on someone's Facebook in one place
2. [Facebook.com](#): Increasingly easy to use as people post more
3. [Monroe County GIS](#): Can look up addresses of property owners
4. [TOR](#): IP bouncing/masking
5. [Textem.net](#): anonymous and free text messaging
