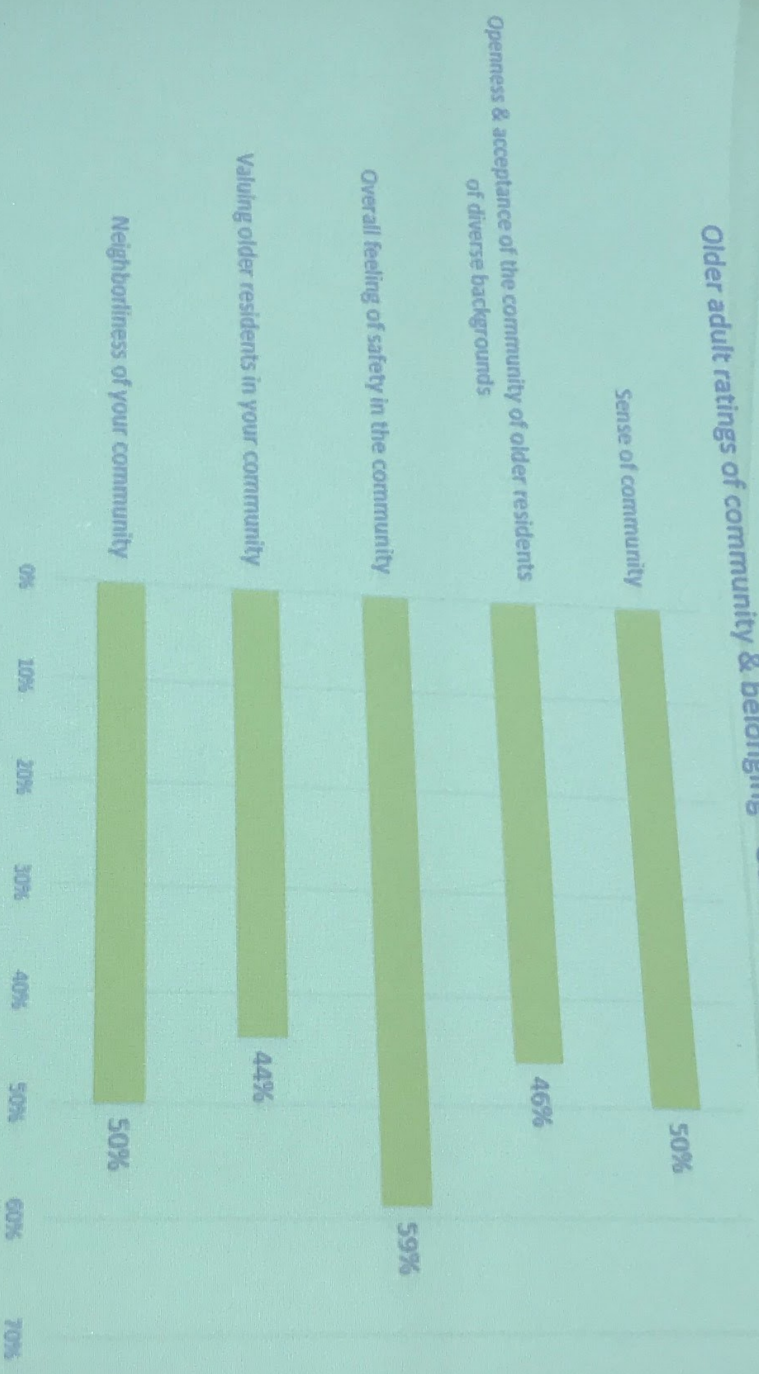
Alzheimer's Resource Service Donation
