- a. Health and Public Safety Report
  - i. Ruben is working with Morgan Co. sheriff's dept. and Wayne James (IUPD) to further conversations. Ruben met with Latino students and Lilian Casillas at Teter
  - ii. Shelley reports that the clinic will begin seeing people beginning Dec. 30. They are still looking for medical doctors, dental assistants, dentists, front office staff, nurses, etc. The clinics new name will be the "Bloomington Family Health and Dental Center"
- b. Cultural Competency
  - i. Ricardo is continuing to pursue updating the list of Hispanic and Latino business owners, etc. and is working with Carmen Henne-Ochoa and Lillian Casillas to merge multiple lists for a final comprehensive list.

  - ii. Israel is also working with Rafi Hasan's (MCCSC) team to promote diversity and equity additional efforts will start in November.
  - iii. Israel is working with a committee that will be working to revise materials that provide Spanish education in the classroom for teachers and the Spanish Immersion program.
