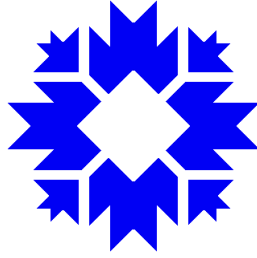

Synopsis

This amendment has been proposed by the Controller’s Office and is need of a sponsor. The change arose after the legislation was introduced and results in the transfer of \$33,000 in General Fund from the Planning and Transportation (P&T) department to the Police department. In essence, the deferral of a document scanning program until next year frees up an additional \$33,000 in Category 3 (Other Services and Charges) of P&T department for use to cover overtime charges in the Police department. There is no net change in the General Fund balance as the result of this amendment.
