## II. NAME of SPEAKER: Becky Rose, Director of Student Services

Topic: Choosing Silence and Being Silenced: impact of domestic violence on families

- Barriers in making disclosure (child or survivors)
  - Family secrecy (e.g. "they were the perfect family")

- Ramifications (e.g. physical discipline/abuse, parent going to jail, embarrassment)
- Lack of trust due to negative experiences
- Parentified role (to protect parent/sibling)
- Barriers after disclosure and DCS intervention
  - Documentation- only know what's been reported and documented (with details!)
    - LEA/DCS reports (including Unsubstantiated reports)
    - Extent of DV history
    - 310 Details from report source and accuracy from hotline worker.
  - Protocols/release of information
  - Recant (child/parent)
    - All play a role in determining the decision to substantiate a report and/or take further action to offer services.
  - Children who are exposed to domestic violence are more likely to experience:
    - Childhood behavioral, emotional and social problems;
    - Cognitive and attitude problems; and
    - Long-term problems such as higher levels of adult depression and trauma.
    - → Every CA/N report is screened for the presence of domestic violence. <u>https://www.in.gov/dcs/2971.htm</u>.
  - An assessment involving domestic violence does not always warrant an automatic removal to ensure the safety of the child. Domestic violence does not always constitute exigent circumstances to interview child first without first seeking parental consent. (Chapter 4.5)
  - o Domestic Violence Assessment
    - Child abuse and neglect (CA/N) may increase the risk to the child and other family members when domestic violence is present. It is important to consider how the assessment process will affect the safety of all involved and take action as outlined in chapter 4.3.
    - The primary focus of DCS is to protect the child and family members.
