In the Council Chambers of the Showers Municipal City Hall at a meeting held on Wednesday, June 4, 1997 at 7:30 PM with Council President Pizzo presiding over a Regular Session of the Common Council.

Roll Call: Banach, Mayer, Young, Cole, Pizzo, Service, Sabbagh, Pierce. Absent: Sherman.

Council President Pizzo gave the Agenda Summation.

There were no minutes for approval.

Sabbagh gave a "Fifth District" report, congratulating Carol Lowengrub on her Gold Medal success with the Senior Olympic Swimming Program. He also addressed a recent letter from Linda Woods supporting the need for Bike & Ped paid coordinator, and expressed his changing opinion about that paid position.

Service gave the "Shakespeare Theater In the Park" Report with the latest upcoming offering "The Winter's Tale" and the various dates of the performances.

Banach announced the upcoming Blue Ridge Neighborhood Association Garage Sale this coming Saturday.

Sabbagh read and presented Encomiums to representatives and coaches of the following Bloomington High School South Award winning groups: The Science Olympiad Team, The Academic Decathlon Team and the Sounds of South.

Pizzo announced that the Common Council Social Service Funds Committee hearings will be on Tuesday, June 10 at 6:00 PM in the Council Chambers. The public is invited.

It was moved and seconded that Ordinance 97-17 be introduced and read by title only. Clerk Williams read the legislation by title only. It was moved and seconded that Ordinance 97-17 be adopted. The synopsis was given. There was no committee recommendation.

Jane Fleig, Traffic Engineer, presented an overview of the entire ordinance, noting that the sections dealing with STOP sign locations are due, in part, to recent annexations and are actually more housekeeping details, street names and designations corrections. Maps were presented and a brief discussion of each section ensued. The Waldron Art Center has had an ongoing problem with a current Loading Zone and Fire Lane designation on 4th Street. It has been requested that a Fire Lane line be painted, the actual loading zone area be smaller and the parallel parking remain the same. The angle parking that has been somewhat confusing will be deleted. The four lane street is not wide enough to accommodate angle parking. And a code correction for bicycles deals with the confusion of current provisions for two wheel bikes on sidewalks with radius exceeding 14" (diameter 28"). The original intent was to allow children to ride their bikes on sidewalks. Current code would allow practically any bike to be on the sidewalk. That has been corrected.

Pizzo hoped that we would not make it so prohibitive for people to ride on the sidewalk if safety dictates it.

Cole also agreed and said that sometimes we don't really want kids on certain streets, that the sidewalk is definitely safer. She also suggested that the city look at signal light timing on some streets, particularly east bound Third Street. Fleig said that Don Porter would look into it.
