MINUTES FOR APPROVAL

Sherman commented on the recent permitting for our landfill expansion and said it is an important piece of the entire solid waste disposal puzzle. He thanked Kiesling for all her years of effort for these programs.

MESSAGES FROM COUNCILMEMBERS

Service thanked everyone involved in last weeks visit by our Sister City, LuChou, and the wonderful middle school jumpropers who came to perform for the International Meeting in Indianapolis and stayed in Bloomington for a few days. She also thanked the BCAT crews who cover the council meetings for providing the television coverage that allows us to have a well informed citizenry.

Kiesling talked about an IU Victim/Offender program offered tomorrow as well as upcoming League of Women Voters activities surrounding the 75th Anniversary of the 19th amendment, granting the right to vote to women.

Clerk Williams presented the councilmembers with gifts from our Sister Cities visitors.

announced that Congregations for Peace Physicians for Social Responsibility are having a tree planting ceremony in Bryan Park on Sunday commemorating the 50th anniversary of the bombing of Hiroshima.

and COMMITTEE MESSAGES

Sherman announced the start of a Pilot Program on four recycling routes to include corrugated cardboard and magazines. If all goes well, the program will be citywide on January 1.

Evelyn Powers talked about the upcoming Lotus Dickey Festival and fundraising efforts for a songbook/project commemorating this legendary local musician. She also talked about the soon to be facility for women dealing with substance abuses and she thanked everyone who has worked on the committee to make this facility a reality.

PUBLIC INPUT

Joe Lee and Chris Luckinbill presented a proposal and petition to the council urging the council to encourage the concept of street art for on the construction board walls around Bloomington at this current time. This would be a good all inclusive project that could really involve the youth of the community.

Cole was very enthusiastic about the project and had several suggestions about rotating the art panels and various ways of hanging them.

White expressed support for the project and suggested that the Commission for Bloomington Downtown be involved in the project. He thought this was a real positive idea.

It was moved, seconded and approved by a voice vote that Patrick J. Murphy to appointed to fill the unexpired term of Rex Hume on the Public Transportation Corporation.

APPOINTMENT TO BOARDS PTC

It was moved and seconded that Resolution 95-27 be introduced and read by title only. Clerk Williams read the resolution by title only.

LEGISLATION FOR SECOND READING RESOLUTION 95-27 It was moved and seconded that Resolution 95-27 be adopted. The synopsis was given.

Michael Flory presented the legal details of the interlocal agreement and Chief Sharp said that this request is the result of a 3 year research project between the city and the county and he highlighted the various things this video imaging system can do: identify finger prints, criminal history. Everything is provided by the vendor, set-up, training, maintenance and expanding the basic system to attach other modular systems. It is a 24 hour/day and 7 days week system. A video image is stored and can be accessed by ethnic group, criminal activity, juvenile or adult files, photo images on jail inmates wristbands as well as warrants.

White asked what other cities are currently using this system and Sharp said that Richmond, IN has had this system in place for 3-4 years.

The resolution received a roll call vote of Ayes:7, Nays:0

It was moved and seconded that Resolution 95-19 be RESOLUTION 95-19 introduced and read by title only. Clerk Williams read the resolution by title only. It was moved and seconded that Resolution 95-19 be adopted. The synopsis was given.

Chris Spiek said that this is the legally required confirming resolution as the companion legislation for Resolution 95-18 passed by the council two weeks ago.

Larry Davis, CPA representing Jerdan Industries was present and available for questions.

The resolution received a roll call vote of Ayes:7, Nays:0.

There was no legislation for first reading. There was no public comment. The meeting was adjourned at 8:20 P.M.
