Pat Bookwalter, Code Enforcement Manager, discussed the building inspection

program and the computerization of Code Enforcement documents. Glenda Murray, Director of the Chamber of Commerce, introduced Jim Willis of PSI.

Jim Willis, PSI, thanked the Council for letting him speak. He presented a study finished a year ago that was done at the request of several communities in the PSI service area. The study focused on economic development in 12 cities, 4 of which are in Indiana. Willis discussed a wide array of economic issues such as capital investment and taxes. He covered the issue of building consensus between cities and businesses regarding methods of economic development. He talked of the requirement of leadership. He projected some hard specific objectives of every community. Willis summarized the top ten requirements for successful economic development. He listed the important questions for a ruling body to answer regarding economic growth. Willis thanked the Council for the chance to speak. Willis then fielded questions from the Council.

John Burnham discussed the Elm Heights neighborhood meeting and comments made by Councilmember Service regarding him. Burnham discussed the interactions of neighborhood associations and the city. Burnham asked that neighborhood associations be recognized for what they are, namely, resident property owner groups. He speculated that student residents were next to be excluded. Burnham described some planning issues.

Service addressed issues raised by John Burnham.

White said he shared some of the concerns of both Burnham and Service. White felt that as neighborhood associations have been revitalized over the last few years that communities had a unique opportunity for various groups to discuss problems that exist. He addressed the problem of absentee landlords. He hoped that the opposing groups could get neighborhood associations back on track.
