He also thanked Senator Vi Simpson for SB 112 dealing with lottery proceeds going back into the communities, he congratulated CAP for the start of a major building fund program for a new facility that would also house Headstart, congratulating former councilmembers Olcott and Register who agreed to chair the drive. 
