In the Council Chambers of the Municipal Building held on Wednesday September 2, 1992 at 7:30 p.m. at a Regular Session of the Common Council.

Roll Call: Sherman, Swain, Miller, Fernandez, Service, Kiesling, Cole, Hopkins, White.

Council President Service gave the Agenda Summation.

The minutes for June 17 and August 5, 1992 were approved by a voice vote.

Sherman welcomed the IU students back to Bloomington. He announced the upcoming Henry IV production and thanked the Director, Alex Service. Miller welcomed the IU students back.

Fernandez thanked the County Council and Commissioners for taking the lead in obtaining local funding for local social services and commended them for expanding the local Public Health Nursing Services. Secondly, he thanked Bloomington Transit for the new City buses. Thirdly, he thanked the Parking Enforcement Division for effectively dealing with the Elm Heights Parking plan. Finally, he spoke of the recent assault at Lake Griffy and the racial vandalism on the campus and encouraged people to speak against these crimes. Kiesling also congratulated the County for extending the services of the Public Health Nursing program. She spoke in favor of the Elm Heights Parking Plan and mentioned the possibility of expanding the area in the future. White informed the public that he was happy to return to Bloomington after being through twenty weeks of military training for the National Guard. He offered comments regarding some of the topics which received a great deal of discussion while he was gone. He also announced that the City now has a 100 Aerial Platform Firetruck in operation, ready for service.

Hopkins reminded the public of the Camiros presentation on the proposed rewriting of the zoning code Thursday, September 3, 1992, at 6:00 p.m. in the Council Chamber.

Service recognized former Councilmember Hogan for attending the meeting with Alan McClain, who is working toward his Eagle Scout qualifications. Service congratulated the County for considering a No Smoking Ordinance. She urged the County Council to adopt a comprehensive No Smoking ordinance. She spoke of the upcoming opening of Henry IV.

The Mayor presented the 4th Street Arts Festival a proclamation for the 16th year anniversary of the festival and Mary Jane Gormley and Ruth Conley accepted it on behalf of the festival.
