Hogan commented on the recent barrage of letters and articles about Bobby Knight saying that it has become a media event to criticize Knight, that he is an extremely talented basketball coach and a tremendous assest to our community and that he is pleased that helps staying in Bloomington. Gardner thanked the City of Bloomington for its donation to the Rape Crisis Center and said that \$60,000 in additional funds will be needed for operating funds.

There were no messages from the Mayor's office except for Mike Davis also wishing the mayor a quick recovery and return to work.

Dean Behnke reported to the Council that there are no plans, at this time for the closing of North Dunn St. There has been much discussion of such a proposal and despite the fact that the rural design of this road has placed it almost in the middle of the City. An '85 study resulted in some signage changes to alert motorists to the particular terrain, but the cost to close or redirect would be astromomical and the usage of that road just does not warrant that type of expense. Traffic counts indicate 1,000 cars a day on No. Dunn and 4,000 cars/day on Old 37. White suggested Deer Warning signs for the area

Julie Koegel, Tox Away Day Coordinator presented a COMMITTEE REPORTS final report to the Council. she noted that the original goals of the committee were met, namely the reduction of hazardous household waste, the education of our population and proper disposal of household waste. 280 people participated, 43 drums of waste were collected, three areas of collection were considered, latex materials, flamable liquids, and pesticides like DDT, Chlordane. Materials were incinerated where possible rather than landfilled and 8% of the materials collected The entire project came in were neutralized. under \$25,000 and people were very pleased with the opportunity to dispose of long time stored items that they had no idea of how to safely take care of. GSX did a good job and the only problem was the inability to take aerosol cans. said that drums for used motor oil are Koegel said the now available. Service thanked Koegel for a job well done.

It was moved and seconded that Ordinance 88-16 be introduced and read by title only. Clerk Williams read the ordinance.

It was moved and seconded that Ordinance 88-16 be adopted.

It was moved and seconded that the ordinance be amended to change in each instance that Lake Griffey is mentioned that the name be officially considered to be Griffy Lake. Roll Call Vote: Ayes:7, Vicky Mayes said that this was proposed last Nays:0 week by Frank Ragan as a hope to finally have one designated name. Research has been done and there is significant evidence that Griffy Lake is the proper title. Hogan commended the Parks Department and Mayes reinforced the statement that this ordinance puts into effect policies, rules and regulations that the Parks Board has implemented.

Paul Schneider quoting Bill Jones of the Environmental Commission, said the major concern of the Commission was the area the City owned, not the entire watershed (under discussion at this time). Schneider said there is concern about the entire area and especially concern about the horses from the Devonshire area coming into the Griffy He also said that there are no signs about not using minnows for bait or taking bass under 14" from the lake. He said he has asked the Mayor repeatedly to do something about this. Vicky Mayes said that each time there is a sign change request it is carefully considered. She said she would take the request back to the Environmental Resources committee for their consideration. This process takes place to avoid covering the area with dozens and dozens of signs to cover each and every possible situation. Olcott asked about patrols and Mayes said a staff of 4-5 are employed and there are always three people on site during regular hours. Schneider said that there are no personnal at the damm site. He said again, that signs would help, that he would like to see the lake restocked, because "the little guys are all fished out"

Gardner asked how often the lake is restocked and Mayes said it was 4-5 years ago when the lake was drained and then restocked. Dick Martin said that the build up of cars around the rental area is beginning to occur again. Cars are not supposed to park along the road. Martin also said the DNR is checking fishinglicenses and the problem really has to do with how we enforce the rules and regs at the lake. City boundaries are not marked and there is no way of knowing if land is City, private or owned by I.U.

Mayes said the question of ice skating and ice fishing has come up and there are no recommendations at this time for ice/water based activities. She said boundary markings will have to be taken under advisement. There are 1200 acres under consideration and most of the concern has been the area closest to the lake and used by the greater number of people. Regarding the parking problem, notices are placed on cars that are parked on the road.

Tom Zellar said he supported these regulations being elevated to ordinance level. He said the problem is compounded by the fact that upstream there are trails that cover private and public lands both. He expressed concern about motorcycles & bikes along the shoreline. He suggested that the major access on Russell Road be gated and signed. Mayes said that would be taken care of as amended

The ordinance received a roll call vote of Ayes:7, Nays:0
