Tim Mueller gave a brief descripteion of the tract, noting that the steep slopes over 15% of the graded area would not be developed.

John Goss suggested that the west side annexation fund might be used to finance the cost of water line displacement necessary for this development. If we do the water line work in house it is likely to cost at least \$45,000. If it is contracted out it would be considerably more. If the fund were to be used then the Council would have to pass the necessary resolution.

He said I.U. has been contacted regarding the plan and that while they shared our concern they were not going to take a position on the issue.

Lynne Coyne, attorney for the petitioner, said 4d/z that Mueller had described the issue adequately there are some points of different opinion. First of all the Plan Commission is an appointed body, You, as council members are an elected body and so it is appropriate that we bring this request to you. The need is there, the need for permanent office space, delis perhaps, a small grocery store, a laundry and storage is always a problem in efficiency apartments. The original 20 acres were high density zoned and the request was made for a The original 20 acres were BA change since mini warehouses were in the BA zone. Afterward the petitioner agreed to request the BL zoning with the understanding that the request would go before the BZA for variance for the mini-warehouses. Coyne then submitted statements of support from 697 residents of the area and 145 unit owners. He argued that the concern for precedent was not relevant since each case is considered separtely. Coyne said there is a trend to neighborhhood shopping areas rather than strip shopping and this area is certainly a neighborhood area

Regester asked if there was any remonstrance on the part of property owners or tenants. Mueller said nd.

Olcott said he felt that it was a good plan for the area and the best use of that type of land, He said he talked with plan commission members and felt that the area was across from a major I.U. facility and that has a direct impact (the development) on the university. He said he would vote no. "it's just in the wrong place at the wrong time" ...

The City of Bloomington has always maintained, both in public and private, that the^{\$900,000} rental figure, which was arrived at by negotiation among the parties to the consent decree, is reimbursement for legal fees. This can be confirmed by consulting accounts of public meetings. It should also be noted that although it might be emotionally satisfying to "rub Westinghouse's nose in it", that the absence of an admission of liability is common is civil suitsettlements. And regardless of how that sum is charactorized, its receipt, particularly as rental for a and tax payers property of little market value, is very important to the people of Bloomington as it relieves them of a considerable empense in legal fees.
